## A BILL TO BE ENTITLED

1 AN ACT 2 relating to the reporting and handling of unclaimed property. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 3 Δ SECTION 1. Subsection (c), Section 74.101, Property Code, is amended to read as follows: 5 The property report must include, if known by the 6 (c) holder: 7 the name, [and] social security number, driver's 8 (1)license or state identification number, e-mail address [if known], 9 and the last known address[, if any,] of: 10 (A) each person who, from the records of the 11 12 holder of the property, appears to be the owner of the property;  $[\tau]$ 13 οr 14 (B) [the name and address, if known, of] any person who is entitled to the property; 15 (2) a description of the property, the identification 16 17 number, if any, and, if appropriate, a balance of each account, except as provided by Subsection (d); 18 19 (3) the date that the property became payable, demandable, or returnable; 20 (4) the date of the last transaction with the owner 21 22 concerning the property; and 23 (5) other information that the comptroller by rule 24 requires to be disclosed as necessary for the administration of
