Section 74.101, Property Code, is amended by 4 5 amending Subsection (c) and adding Subsection (e) to read as follows: 6 7 (c) The property report must include: (1) the name, [and] social security number, driver's 8 9 license or state identification number, and e-mail address, if known, and the last known address, if any, of: 10 11 (A) each person who, from the records of the 12 holder of the property, appears to be the owner of the property: $[\tau]$ 13 or 14 (B) [the name and address, if known, of] any person who is entitled to the property; 15 a description of the property, the identification 16 (2) number, if any, and, if appropriate, a balance of each account, 17 except as provided by Subsection (d); 18 (3) the date that the property became payable, 19 demandable, or returnable; 20 21 (4) the date of the last transaction with the owner 22 concerning the property; and 23 (5) other information that the comptroller by rule 24 requires to be disclosed as necessary for the administration of

2 (e) A penalty equal to five percent of the value of the 3 property shall be imposed on a person who knowingly fails to report 4 a social security number as required by Subsection (c).

5 SECTION 2. Subchapter B, Chapter 74, Property Code, is 6 amended by adding Section 74.1011 to read as follows:

7 Sec. 74.1011. NOTICE BY PROPERTY HOLDER REQUIRED. (a) Except as provided by Subsection (b), a holder who on June 30 holds 8 property valued at more than \$250 that is presumed abandoned under 9 Chapter 72, 73, or 75 of this code or Chapter 154, Finance Code, 10 shall, on or before the following August 1, mail to any person who, 11 12 from the records of the holder of the property, appears to be the owner of the property or a person entitled to the property written 13 14 notice stating that:

(1) the holder is holding the property; and

16 (2) the holder may be required to deliver the property 17 to the comptroller on or before November 1 if the property is not 18 claimed.

(b) A holder shall send the notice required by this section to the last known address of the person who appears to be the property owner or a person entitled to the property. A holder who does not have a record of an address for the property owner or any other person entitled to the property is not required to provide notice under this section.

25 (c) A holder that provides notice under this section may 26 charge the cost of the postage against the property held as a 27 service charge.

(a) Not later than June 1 of each year, the retirement system shall provide to the comptroller, for the purpose of 9 10 assisting the comptroller in the identification of persons entitled to unclaimed property reported to the comptroller, the name, 11 12 address, social security number, and date of birth of each member, retiree, and beneficiary from the retirement system's records. 13 14 (b) Information provided to the comptroller under this 15 section is confidential and may not be disclosed to the public. (c) The retirement system shall provide the information in 16 17 the format prescribed by rule by the comptroller. SECTION 7.
