4	SECTION 1. Section 501.021, Transportation Code, is amended
5	by adding Subsection (c) to read as follows:
6	(c) A certificate of title for a motor vehicle that has been
7	the subject of an ordered repurchase or replacement under Chapter
8	2301, Occupations Code, must contain on its face a notice
9	sufficient to inform a purchaser that the motor vehicle has been the
10	subject of an ordered repurchase or replacement.
11	SECTION 2. Section 520.023, Transportation Code, is amended
12	by adding Subsection (g) to read as follows:
13	(g) A transferor who files the appropriate form with the
14	department as provided by, and in accordance with, this section,
15	whether that form is a part of a certificate of title or a form
16	otherwise promulgated by the department to comply with the terms of
17	this section, has no vicarious civil or criminal liability arising
18	out of the use, operation, or abandonment of the vehicle by another
19	person. Proof by the transferor that the transferor filed a form
20	under this section is a complete defense to an action brought
21	against the transferor for an act or omission, civil or criminal,
22	arising out of the use, operation, or abandonment of the vehicle by
23	another person after the transferor filed the form. A copy of the
24	form filed under this section is proof of the filing of the form.

SECTION 3. Section 702.003, Transportation Code, is amended
by adding Subsection (f) to read as follows:

3 (f) This section does not apply to the registration of a 4 motor vehicle under Section 501.0234.

5 SECTION 4. Section 707.017, Transportation Code, is amended 6 to read as follows:

Sec. 707.017. ENFORCEMENT. If the owner of a motor vehicle is delinquent in the payment of a civil penalty imposed under this chapter, the county assessor-collector or the Texas Department of Transportation may refuse to register a motor vehicle alleged to have been involved in the violation. <u>This section does not apply to</u> the registration of a motor vehicle under Section 501.0234.

13 SECTION 5. (a) The change in law made to Section 501.021, 14 Transportation Code, as amended by this Act, applies only to a title 15 issued on or after the effective date of this Act. A title issued 16 before the effective date of this Act is governed by the law in 17 effect immediately before the effective date of this Act, and the 18 former law is continued in effect for that purpose.

(b) The change in law made to Section 520.023, 19 Transportation Code, as amended by this Act, applies only to a 20 transfer of a vehicle that occurred on or after the effective date 21 of this Act. A transfer that occurred before the effective date of 22 this Act is governed by the law in effect immediately before the 23 effective date of this Act, and the former law is continued in 24 25 effect for that purpose.

(c) The change in law made to Sections 702.003 and 707.017,
27 Transportation Code, as amended by this Act, applies only to a
