- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 420.002, Property Code, is amended to
- 6 read as follows:
- 7 Sec. 420.002. REQUIRED CONTRACT PROVISIONS. (a) In a
- 8 contract for the construction of a new home or an improvement to an
- 9 existing home required to be registered under Section 426.003, the
- 10 contract is not enforceable against a homeowner unless the
- 11 contract:
- 12 (1) contains the builder's name and certificate of
- 13 registration number; and
- 14 (2) contains the notice required by Section 420.001.
- 15 (b) A builder may amend a contract that does not comply with
- 16 this section to add the required provisions to avoid additional
- 17 civil penalties.
- (c) When a builder amends a contract under Subsection (b),
- 19 the builder and the homeowner may not alter any other term or
- 20 <u>condition of the contract.</u>
- 21 SECTION 2. Chapter 420, Property Code, is amended by adding
- 22 Sections 420.0025 and 420.0026 to read as follows:
- Sec. 420.0025. CIVIL PENALTY: FAILURE TO COMPLY WITH
- 24 REQUIRED CONTRACT PROVISIONS. (a) A person who violates Section

- 1 420.002 is liable for a civil penalty in an amount of not less than
- 2 \$100 and not more than \$500 for each violation, not to exceed an
- 3 aggregate amount of \$5,000.
- 4 (b) Each day a violation of Section 420.002 continues
- 5 constitutes a separate violation for the purposes of this section.
- 6 (c) The attorney general may bring suit to recover a civil
- 7 penalty under this section.
- 8 (d) The amount of the civil penalty under this section must
- 9 be based on:
- 10 (1) the seriousness of the violation, including the
- 11 nature, circumstances, extent, and gravity of the violation;
- 12 (2) the history of previous violations;
- 13 (3) the amount necessary to deter a future violation;
- 14 (4) whether the violator demonstrated good faith,
- 15 including when applicable whether the violator made good faith
- 16 efforts to correct the violation; and
- 17 (5) any other matter that justice may require.
- 18 Sec. 420.0026. CERTAIN LIENS VALID. Notwithstanding
- 19 Section 420.002(a), a builder's failure to comply with Section
- 20 420.002 does not invalidate a lien of an entity that:
- 21 (1) provided third-party financing to a homeowner for
- 22 the construction of a new home or an improvement to an existing home
- 23 <u>under a residential construction contract; or</u>
- 24 (2) renewed and extended financing for a purpose
- 25 described by Subdivision (1).
- SECTION 3. This Act takes effect September 1, 2009.
