(a) In this section: (1) "Pharmacy care management services" means 10 services provided by a pharmacy to support recipients of medical 11 assistance receiving treatment or therapy through a specialty 12 pharmacy product, including: 13 14 (A) significant caregiver and provider contact and education regarding the relevant disease, disease prevention 15 16 and treatment, and drug indications and pharmacy counseling with regard to benefits, risks, complications, and appropriate use of 17 the specialty pharmacy product; 18 19 (B) an explanation of existing guidelines to 20 providers; 21 (C) recipient compliance services, including coordination of provider visits with delivery of the specialty 22 23 pharmacy product to the provider, compliance with the dosing regimen, patient reminders, compilation of compliance data, and 24

1	assisting providers in development of a compliance program; and
2	(D) tracking services, including developing
3	ordering processes with a provider, screening referrals, and
4	tracking a patient's weight for dosing requirements.
5	(2) "Specialty pharmacy product" means a prescription
6	drug or therapy typically used to treat a chronic condition or
7	manage complex care issues, including:
8	(A) injection and infusion therapies;
9	(B) biotechnology drugs;
10	(C) high-cost therapies; and
11	(D) therapies requiring complex care.
12	(b) The department shall establish reimbursement rates
13	under the vendor drug program for pharmacies that provide pharmacy
14	care management services for recipients of medical assistance. The
15	reimbursement rates required by this subsection must be separate
16	from the reimbursement rates provided for the relevant specialty
17	pharmacy products.
18	(c) A pharmacy that seeks reimbursement under this section
19	shall provide verification that pharmacy care management services
20	were provided in connection with a specialty pharmacy product
21	provided by the pharmacy.
22	(d) The department shall consult with pharmacies that
23	provide pharmacy care management services to determine
24	reimbursement rates based on accurate costs of products, services,
25	and administrative costs described by this section.
26	SECTION 2. If before implementing any provision of this Act
27	a state agency determines that a waiver or authorization from a

1 federal agency is necessary for implementation of that provision, 2 the agency affected by the provision shall request the waiver or 3 authorization and may delay implementing that provision until the 4 waiver or authorization is granted.

5 SECTION 3. This Act takes effect September 1, 2009.
