- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 61.071, Education Code, is amended by
- 6 amending Subsections (b), (c), and (d) and adding Subsection (b-1)
- 7 to read as follows:
- 8 (b) Not later than August 1 of each odd-numbered year, the
- 9 board shall provide the following to each institution of higher
- 10 education:
- 11 (1) a list of available positions for student
- 12 representatives on board advisory committees, the effective term of
- 13 <u>each</u> [terms] of those positions, and the duties and requirements
- 14 for each position;
- 15 (2) a maximum number of nominees determined by the
- 16 board allowed to be submitted by each institution for each
- 17 position; and
- 18 (3) an application form for appointment to an advisory
- 19 committee.
- 20 (b-1) The term of a student representative on a board
- 21 advisory committee may not be less than two years.
- (c) Not later than September 1 of each odd-numbered year,
- 23 the president of each institution of higher education shall
- 24 establish a nomination process for the available positions for

- 1 student representatives on board advisory committees and shall
- 2 solicit student applications from which the president may select a
- 3 number of applicants for those positions, not to exceed the maximum
- 4 number designated by the board for each position.
- 5 (d) Not later than the following December 1, the president
- 6 shall forward the applications of the nominees selected by the
- 7 president to the board for consideration. Not later than the
- 8 following February 1, the board shall appoint a total of not fewer
- 9 [less] than four student representatives to designated advisory
- 10 committees of the board, including the Common Application Advisory
- 11 Committee, the Distance Education Advisory Committee, the
- 12 Financial Aid Advisory Committee, the Undergraduate Education
- 13 Advisory Committee, the Transfer Issues Advisory Committee, or any
- 14 other advisory committee created to address the needs of higher
- 15 education, including committees addressing financial aid, student
- 16 services, and undergraduate education needs.
- 17 SECTION 2. The changes in law made by this Act to Section
- 18 61.071, Education Code, apply only to the term of a student member
- 19 of a Texas Higher Education Coordinating Board advisory committee
- 20 appointed under that section on or after the effective date of this
- 21 Act. This Act does not affect the term of a student member of a
- 22 Texas Higher Education Coordinating Board advisory committee
- 23 serving on the effective date of this Act.
- 24 SECTION 3. This Act takes effect immediately if it receives
- 25 a vote of two-thirds of all the members elected to each house, as
- 26 provided by Section 39, Article III, Texas Constitution. If this
- 27 Act does not receive the vote necessary for immediate effect, this
