A BILL TO BE ENTITLED

2	relating to the dissemination of information regarding the cost of

4	regarding the availability of financial aid to assist in paying

6	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
7	SECTION 1. Subchapter C, Chapter 61, Education Code, is
8	amended by adding Section 61.0777 to read as follows:
9	Sec. 61.0777. UNIFORM STANDARDS FOR PUBLICATION OF COST OF
10	ATTENDANCE INFORMATION. (a) The board shall prescribe uniform
11	standards intended to ensure that information regarding the cost of
12	attendance at institutions of higher education and at private or
13	independent institutions of higher education approved under
14	Subchapter F to receive tuition equalization grant funds is
15	available to the public in a manner that is consumer-friendly and
16	readily understandable to prospective students and their families.
17	In developing the standards, the board shall examine common and
18	recommended practices regarding the publication of such
19	information and shall solicit recommendations and comments from
20	institutions of higher education and affected private or

23 (1) address all of the elements that constitute the 24 total cost of attendance, including tuition and fees, room and

- 1 board costs, book and supply costs, transportation costs, and other
- 2 personal expenses; and
- 3 (2) prescribe model language to be used to describe
- 4 <u>each element of the cost of attendance.</u>
- 5 (c) Each institution of higher education and each private or
- 6 independent institution of higher education approved under
- 7 Subchapter F to receive tuition equalization grant funds that
- 8 offers an undergraduate degree or certificate program shall:
- 9 (1) prominently display on the institution's Internet
- 10 website in accordance with the uniform standards prescribed under
- 11 this section information regarding the cost of attendance at the
- 12 institution by a full-time entering first-year student; and
- 13 (2) conform to the uniform standards in any electronic
- 14 or printed materials intended to provide to prospective
- 15 undergraduate students information regarding the cost of
- 16 <u>attendance at the institution.</u>
- 17 (d) Institutions described by Subsection (c) shall consider
- 18 the uniform standards prescribed under this section when providing
- 19 information to the public or to prospective students regarding the
- 20 cost of attendance at the institution by nonresident students,
- 21 graduate students, or students enrolled in professional programs.
- (e) The board shall prescribe requirements for an
- 23 <u>institution</u> described by Subsection (c) to provide on the
- 24 institution's Internet website consumer-friendly and readily
- 25 understandable information regarding student financial aid
- 26 opportunities. The required information must be provided in
- 27 connection with the information displayed under Subsection (c)(1)

- 1 and must include a link to the primary federal student financial aid
- 2 Internet website intended to assist persons applying for student
- 3 financial aid.
- 4 (f) The board shall provide on the board's Internet website
- 5 a program or similar tool that will compute for a person accessing
- 6 the website the estimated net cost of attendance for a full-time
- 7 entering first-year student attending an institution described by
- 8 <u>Subsection (c). The board shall require each of those institutions</u>
- 9 to provide the board with the information the board requires to
- 10 administer this subsection.
- 11 (g) The board shall prescribe the initial standards and
- 12 requirements under this section not later than January 1, 2010.
- 13 Institutions of higher education shall comply with the standards
- 14 and requirements not later than April 1, 2010. This subsection
- 15 expires January 1, 2011.
- SECTION 2. This Act takes effect immediately if it receives
- 17 a vote of two-thirds of all the members elected to each house, as
- 18 provided by Section 39, Article III, Texas Constitution. If this
- 19 Act does not receive the vote necessary for immediate effect, this
- 20 Act takes effect September 1, 2009.
