A written request that does not 14 specify the name and location to which the information is to be sent 15 is not effective. The property owners' association may deliver the 16 17 information required by Subsection (a) and any update to the resale certificate required by Subsection (f) by mail, hand delivery, or 18 alternative delivery means specified in the written request. 19 20 (f) Not later than the seventh day after the date a written request for an update to a resale certificate delivered under 21 Subsection (a) is received from an owner, owner's agent, or title 22

insurance company or its agent acting on behalf of the owner, the

agent, or title insurance company or its agent an updated resale 1 2 certificate that contains the following information: (1) if a right of first refusal or other restraint on 3 sale is contained in the restrictions, a statement of whether the 4 property owners' association waives the restraint on sale; 5 6 (2) the status of any unpaid special assessments, 7 dues, or other payments attributable to the owner's property; and (3) any changes to the information provided in the 8 9 resale certificate issued under Subsection (a). 10 (g) Requests for an updated resale certificate pursuant to Subsection (f) must be made within 180 days of the date a resale 11 certificate is issued under Subsection (a). The update request may 12 13 be made only by the party requesting the original resale 14 certificate.

15 SECTION 2. The change in law made by this Act applies only 16 to a request for an updated resale certificate received by a 17 property owners' association on or after the effective date of this 18 Act. A request received before the effective date of this Act is 19 governed by the law in effect immediately before the effective date 20 of this Act, and that law is continued in effect for that purpose. 21 SECTION 3. This Act takes effect September 1, 2009.
