## A BILL TO BE ENTITLED

AN ACT

2	relating	to	the	safe	operation	of	motorcycles	and	other	vehicles	in

- 3 this state; providing penalties.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Subchapter H, Chapter 201, Transportation Code,
- 6 is amended by adding Section 201.621 to read as follows:
- 7 Sec. 201.621. MOTORCYCLIST SAFETY AND SHARE THE ROAD
- 8 CAMPAIGN. From funds appropriated for that purpose, the department
- 9 shall conduct a continuing public awareness campaign to promote
- 10 motorcyclist safety and the concept of sharing the road with
- 11 motorcyclists.

- 12 SECTION 2. Subchapter G, Chapter 521, Transportation Code,
- 13 is amended by adding Section 521.148 to read as follows:
- 14 Sec. 521.148. APPLICATION FOR CLASS M LICENSE OR
- 15 AUTHORIZATION TO OPERATE MOTORCYCLE. (a) An applicant for an
- 16 original Class M license or Class A, B, or C driver's license that
- 17 <u>includes an authorization to operate a motorcycle must furnish to</u>
- 18 the department evidence satisfactory to the department that the
- 19 applicant has successfully completed a basic motorcycle operator
- 20 training course approved by the department under Chapter 662.
- 21 (b) The department may not issue an original Class M license
- 22 or Class A, B, or C driver's license that includes an authorization
- 23 to operate a motorcycle to an applicant who fails to comply with
- 24 Subsection (a).

- 1 (c) When the department issues a license to which this
- 2 section applies, the department shall provide the person to whom
- 3 the license is issued with written information about the Glenda
- 4 Dawson Donate Life-Texas Registry program established under
- 5 Chapter 49, Health and Safety Code.
- 6 SECTION 3. Subchapter C, Chapter 522, Transportation Code,
- 7 is amended by adding Section 522.034 to read as follows:
- 8 <u>Sec. 522.034. APPLICATION FOR AUTHORIZATION TO OPERATE</u>
- 9 MOTORCYCLE. (a) An applicant for an original commercial driver's
- 10 license or commercial driver learner's permit that includes an
- 11 <u>authorization</u> to operate a motorcycle must furnish to the
- 12 department evidence satisfactory to the department that the
- 13 applicant has successfully completed a basic motorcycle operator
- 14 training course approved by the department under Chapter 662.
- 15 (b) The department may not issue an original commercial
- 16 driver's license or commercial driver learner's permit that
- 17 <u>includes an authorization to operate a motorcycle to an applicant</u>
- 18 who fails to comply with Subsection (a).
- 19 (c) When the department issues a license or permit to which
- 20 this section applies, the department shall provide the person to
- 21 whom the license is issued with written information about the
- 22 Glenda Dawson Donate Life-Texas Registry program established under
- 23 Chapter 49, Health and Safety Code.
- SECTION 4. Subchapter D, Chapter 542, Transportation Code,
- 25 is amended by adding Section 542.4045 to read as follows:
- Sec. 542.4045. PENALTIES FOR FAILURE TO YIELD RIGHT-OF-WAY
- 27 OFFENSE RESULTING IN ACCIDENT. If it is shown on the trial of an

- 1 offense under this subtitle in which an element is the failure by
- 2 the operator of a vehicle to yield the right-of-way to another
- 3 vehicle that an accident resulted from the operator's failure to
- 4 yield the right-of-way:
- 5 (1) the offense is a Class B misdemeanor with a minimum
- 6 fine of \$500, if a person other than the operator of the vehicle
- 7 suffered bodily injury in the accident; and
- 8 (2) the offense is a Class A misdemeanor with a minimum
- 9 fine of \$1,000, if a person other than the operator of the vehicle
- 10 suffered serious bodily injury in the accident.
- SECTION 5. Section 661.003, Transportation Code, is amended
- 12 by amending Subsection (c) and adding Subsections (c-1) and (c-2)
- 13 to read as follows:
- 14 (c) It is an exception to the application of Subsection (a)
- 15 or (b) that at the time the offense was committed, the person
- 16 required to wear protective headgear was at least 21 years old and
- 17 had successfully completed a motorcycle operator training and
- 18 safety course under Chapter 662 or was covered by a health insurance
- 19 plan providing the person with [at least \$10,000 in] medical
- 20 benefits for injuries incurred as a result of an accident while
- 21 operating or riding on a motorcycle. A peace officer may not arrest
- 22 a person or issue a citation to a person for a violation of
- 23 Subsection (a) or (b) if the person required to wear protective
- 24 headgear is at least 21 years of age and presents evidence
- 25 sufficient to show that the person required to wear protective
- 26 headgear has successfully completed a motorcycle operator training
- 27 and safety course or is covered by a health insurance plan as

- 1 described by this subsection.
- 2 (c-1) A peace officer may not stop or detain a person who is
- 3 the operator of or a passenger on a motorcycle for the sole purpose
- 4 of determining whether the person has successfully completed the
- 5 motorcycle operator training and safety course or is covered by a
- 6 health insurance plan.
- 7 (c-2) The Texas Department of Insurance shall prescribe a
- 8 standard proof of health insurance for issuance to persons who are
- 9 at least 21 years of age and covered by a health insurance plan
- 10 described by Subsection (c).
- SECTION 6. Subsection (a), Section 662.011, Transportation
- 12 Code, is amended to read as follows:
- 13 (a) Of each fee collected under Sections 521.421(b) and (f)
- 14 and  $[\tau]$  Sections 522.029(f) and (g), [and Section 661.003(d), [a
- 15 Department of Public Safety shall send \$5 to the comptroller for
- 16 deposit to the credit of the motorcycle education fund account.
- 17 SECTION 7. Subchapter C, Chapter 1001, Education Code, is
- 18 amended by adding Section 1001.1025 to read as follows:
- 19 Sec. 1001.1025. MOTORCYCLE AWARENESS INFORMATION.
- 20 (a) The agency by rule shall require that information relating to
- 21 motorcycle awareness, the dangers of failing to yield the
- 22 right-of-way to a motorcyclist, and the need to share the road with
- 23 motorcyclists be included in the curriculum of any driver education
- 24 <u>course or driving safety course.</u>
- 25 (b) In developing rules under this section, the agency shall
- 26 consult with the department.
- SECTION 8. Subsections (d), (e), (f), and (g), Section

- 1 661.003, Transportation Code, are repealed.
- 2 SECTION 9. The change in law made by this Act to Chapters
- 3 521 and 522, Transportation Code, apply only in connection with an
- 4 application for a driver's license, personal identification
- 5 certificate, commercial driver's license, or commercial driver
- 6 learner's permit filed on or after the effective date of this Act.
- 7 An application for a driver's license, personal identification
- 8 certificate, commercial driver's license, or commercial driver
- 9 learner's permit filed before the effective date of this Act is
- 10 covered by the law in effect when the application was filed, and the
- 11 former law is continued in effect for that purpose.
- 12 SECTION 10. This Act takes effect September 1, 2009.
