- 14 (a) The 414th Judicial District is composed of McLennan County.
- 15 (b) The 414th District Court has concurrent jurisdiction
- 16 with the county court and the statutory county courts of McLennan
- 17 County in misdemeanor cases as well as the jurisdiction prescribed

- 19 (c) The terms of the 414th District Court begin on the first
