6	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
7	SECTION 1. Chapter 571, Government Code, is amended by
8	adding Subchapter G to read as follows:
9	SUBCHAPTER G. REPORTING OF POLITICAL CONTRIBUTIONS AND
10	EXPENDITURES RELATED TO LOCAL GOVERNMENTAL ENTITIES AND OFFICERS
11	Sec. 571.201. PURPOSE. The purpose of this subchapter is to
12	further the objective of fully disclosing information related to
13	political contributions and expenditures made in connection with
14	offices of and measures proposed by local governmental entities by
15	allowing a local governmental entity or a candidate for or holder of
16	an office of a local governmental entity or a related
17	specific-purpose committee to use the commission's software and
18	other commission resources to file reports of political
19	contributions and expenditures required by Title 15, Election Code.
20	Sec. 571.202. DEFINITIONS. In this subchapter:
21	(1) "Local governmental entity" and "local government
22	officer" have the meanings assigned by Section 176.001, Local
23	Government Code.
24	(2) "Measure," "political contribution," "political

- 2 <u>assigned by Section 251.001, Election Code.</u>
- 3 Sec. 571.203. USE OF COMMISSION SOFTWARE AND RESOURCES.
- 4 (a) To fulfill the purpose of this subchapter and to facilitate
- 5 filing of reports of political contributions and expenditures
- 6 required by Title 15, Election Code, the commission may allow the
- 7 use of commission software and resources by:
- 8 <u>(1) a local governmental entity;</u>
- 9 (2) a local government officer;
- 10 (3) a candidate for an office of a local governmental
- 11 entity; or
- 12 (4) a specific-purpose committee for supporting or
- 13 opposing a candidate for an office of a local governmental entity,
- 14 assisting a local government officer, or supporting or opposing a
- 15 measure proposed by a local governmental entity.
- 16 (b) The commission may provide assistance to a local
- 17 governmental entity, a local government officer, a candidate for an
- 18 office of a local governmental entity, or a specific-purpose
- 19 committee by:
- 20 (1) developing software to facilitate electronic
- 21 filing of reports of political contributions and expenditures;
- 22 (2) maintaining reports of political contributions
- 23 and expenditures for electronic publishing and filing; and
- 24 (3) providing public access through the commission's
- 25 Internet website to electronic reports of political contributions
- 26 and expenditures filed by:
- 27 (A) a local governmental entity;

- 1 (B) a local government officer;
- 2 (C) a candidate for an office of a local
- 3 governmental entity; or
- 4 (D) a specific-purpose committee for supporting
- 5 or opposing a candidate for an office of a local governmental
- 6 entity, assisting a local government officer, or supporting or
- 7 opposing a measure proposed by a local governmental entity.
- 8 <u>(c)</u> The commission may enter into an intergovernmental
- 9 contract with a local governmental entity to provide the assistance
- 10 described by Subsection (b).
- 11 SECTION 2. This Act does not make an appropriation. A
- 12 provision in this Act that creates a new governmental program,
- 13 creates a new entitlement, or imposes a new duty on a governmental
- 14 entity is not mandatory during a fiscal period for which the
- 15 legislature has not made a specific appropriation to implement the
- 16 provision.
- 17 SECTION 3. This Act takes effect September 1, 2009.
