- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Subchapter E, Chapter 2306, Government Code, is
- 7 amended by adding Section 2306.096 to read as follows:
- 8 Sec. 2306.096. COMMUNITY DEVELOPMENT CORPORATION PILOT
- 9 PROGRAM. (a) In this section, "community development corporation"
- 10 means a private, nonprofit corporation organized to foster economic
- 11 growth and revitalization, create small businesses, or develop
- 12 <u>affordable housing in a defined neighborhood or for a targeted</u>
- 13 population.
- 14 (b) Using existing resources, the department shall
- 15 establish a pilot program to create and provide support for a
- 16 regional community development corporation in a single rural area
- 17 of this state.
- (c) Not later than January 1, 2011, the department shall
- 19 report to the governor, the lieutenant governor, the speaker of the
- 20 house of representatives, and the members of the legislature
- 21 regarding:
- 22 (1) the impact of the pilot program in the rural area
- 23 in which it was implemented; and
- 24 (2) the feasibility and advisability of creating and

- 1 supporting additional regional community development corporations
- 2 to serve other areas of the state.
- 3 (d) This section expires October 1, 2011.
- 4 SECTION 2. Subchapter LL, Chapter 2306, Government Code, is
- 5 amended by adding Section 2306.934 to read as follows:
- 6 Sec. 2306.934. COMMUNITY DEVELOPMENT CORPORATION FOR
- 7 MIGRANT LABOR HOUSING FACILITIES. (a) In this section, "community
- 8 <u>development corporation</u>" means a private, nonprofit corporation
- 9 organized to foster economic growth and revitalization, create
- 10 small businesses, or develop affordable housing in a defined
- 11 <u>neighborhood or for a targeted population.</u>
- 12 <u>(b) Using existing resources, the department shall create a</u>
- 13 statewide community development corporation charged with
- 14 developing, acquiring, and rehabilitating migrant labor housing
- 15 <u>facilities in appropriate areas in the state.</u>
- 16 (c) The department shall work with the community
- 17 development corporation to implement the findings and
- 18 recommendations of the department in the report submitted under
- 19 Section 2(f), Chapter 60 (H.B. 1099), Acts of the 79th Legislature,
- 20 Regular Session, 2005.
- 21 SECTION 3. The Texas Department of Housing and Community
- 22 Affairs shall create the community development corporations
- 23 required by this Act as soon as practicable after the effective date
- 24 of this Act, but not later than October 1, 2009.
- 25 SECTION 4. This Act takes effect immediately if it receives
- 26 a vote of two-thirds of all the members elected to each house, as
- 27 provided by Section 39, Article III, Texas Constitution. If this

- 1 Act does not receive the vote necessary for immediate effect, this
- 2 Act takes effect September 1, 2009.
