| 8 | CHAPTER 8353. CLEARWATER RANCH MUNICIPAL UTILITY DISTRICT NO. 1 |
| 9 | SUBCHAPTER A. GENERAL PROVISIONS |
| 10 | Sec. 8353.001. DEFINITIONS. In this chapter: |
| 11 | (1) "Board" means the district's board of directors. |
| 12 | (2) "Director" means a board member. |
| 13 | (3) "District" means the Clearwater Ranch Municipal |
| 14 | Utility District No. 1. |
| 15 | Sec. 8353.002. NATURE OF DISTRICT. The district is a |
| 16 | municipal utility district created under Section 59, Article XVI, |
| 17 | Texas Constitution. |
| 18 | Sec. 8353.003. CONFIRMATION AND DIRECTORS' ELECTION |
| 19 | REQUIRED. The temporary directors shall hold an election to |
| 20 | confirm the creation of the district and to elect five permanent |
| 21 | directors as provided by Section 49.102, Water Code. |
| 22 | Sec. 8353.004. CONSENT OF MUNICIPALITY REQUIRED. The |
| 23 | temporary directors may not hold an election under Section 8353.003 |
| 24 | until each municipality in whose corporate limits or |

extraterritorial jurisdiction the district is located has 1 2 consented by ordinance or resolution to the creation of the 3 district and to the inclusion of land in the district. 4 Sec. 8353.005. FINDINGS OF PUBLIC PURPOSE AND BENEFIT. (a) 5 The district is created to serve a public purpose and benefit. 6 (b) The district is created to accomplish the purposes of: 7 (1) a municipal utility district as provided by general law and Section 59, Article XVI, Texas Constitution; and 8 (2) Section 52, Article III, Texas Constitution, that 9 relate to the construction, acquisition, improvement, operation, 10 or maintenance of macadamized, graveled, or paved roads, or 11 12 improvements, including storm drainage, in aid of those roads. Sec. 8353.006. INITIAL DISTRICT TERRITORY. (a) The 13 14 district is initially composed of the territory described by Section 2 of the Act creating this chapter. 15 16 (b) The boundaries and field notes contained in Section 2 of 17 the Act creating this chapter form a closure. A mistake made in the field notes or in copying the field notes in the legislative process 18 19 does not affect the district's: 20 (1) organization, existence, or validity; 21 (2) right to issue any type of bond for the purposes 22 for which the district is created or to pay the principal of and 23 interest on a bond; 24 (3) right to impose a tax; or 25 (4) legality or operation. 26 [Sections 8353.007-8353.050 reserved for expansion]

1 SUBCHAPTER B. BOARD OF DIRECTORS 2 Sec. 8353.051. GOVERNING BODY; TERMS. (a) The district is governed by a board of five elected directors. 3 4 (b) Except as provided by Section 8353.052, directors serve 5 staggered four-year terms. 6 Sec. 8353.052. TEMPORARY DIRECTORS. (a) On or after the 7 effective date of the Act creating this chapter, the owner or owners 8 of a majority of the assessed value of the real property in the district may submit a petition to the Texas Commission on 9 Environmental Quality requesting that the commission appoint as 10 temporary directors the five persons named in the petition. The 11 12 commission shall appoint as temporary directors the five persons named in the petition. 13 14 (b) Temporary directors serve until the earlier of: 15 (1) the date permanent directors are elected under Section 8353.003; or 16 17 (2) the fourth anniversary of the effective date of the Act creating this chapter. 18 19 (c) If permanent directors have not been elected under Section 8353.003 and the terms of the temporary directors have 20 expired, successor temporary directors shall be appointed or 21 reappointed as provided by Subsection (d) to serve terms that 22 23 expire on the earlier of: 24 (1) the date permanent directors are elected under <u>Section</u> 8353.003; or 25 26 (2) the fourth anniversary of the date of the 27 appointment or reappointment.

(d) If Subsection (c) applies, the owner or owners of a 1 2 majority of the assessed value of the real property in the district may submit a petition to the Texas Commission on Environmental 3 Quality requesting that the commission appoint as successor 4 5 temporary directors the five persons named in the petition. The commission shall appoint as successor temporary directors the five 6 7 persons named in the petition. 8 [Sections 8353.053-8353.100 reserved for expansion] SUBCHAPTER C. POWERS AND DUTIES 9 10 Sec. 8353.101. GENERAL POWERS AND DUTIES. The district has the powers and duties necessary to accomplish the purposes for 11 12 which the district is created. Sec. 8353.102. MUNICIPAL UTILITY DISTRICT POWERS AND 13 14 DUTIES. The district has the powers and duties provided by the 15 general law of this state, including Chapters 49 and 54, Water Code, applicable to municipal utility districts created under Section 59, 16 17 Article XVI, Texas Constitution. Sec. 8353.103. AUTHORITY FOR ROAD PROJECTS. Under Section 18 52, Article III, Texas Constitution, the district may design, 19 acquire, construct, finance, issue bonds for, improve, operate, 20 maintain, and convey to this state, a county, or a municipality for 21 operation and maintenance macadamized, graveled, or paved roads, or 22 improvements, including storm drainage, in aid of those roads. 23 24 Sec. 8353.104. ROAD STANDARDS AND REQUIREMENTS. (a) A road project must meet all applicable construction standards, zoning and 25 26 subdivision requirements, and regulations of each municipality in whose corporate limits or extraterritorial jurisdiction the road 27

1 project is located. 2 (b) If a road project is not located in the corporate limits or extraterritorial jurisdiction of a municipality, the road 3 project must meet all applicable construction standards, 4 5 subdivision requirements, and regulations of each county in which the road project is located. 6 7 (c) If the state will maintain and operate the road, the Texas Transportation Commission must approve the plans and 8 specifications of the road project. 9 10 Sec. 8353.105. COMPLIANCE WITH MUNICIPAL CONSENT ORDINANCE OR RESOLUTION. The district shall comply with all applicable 11 12 requirements of any ordinance or resolution that is adopted under Section 54.016 or 54.0165, Water Code, and that consents to the 13 creation of the district or to the inclusion of land in the 14 15 district. Sec. 8353.106. LIMITATION ON USE OF EMINENT DOMAIN. The 16 17 district may not exercise the power of eminent domain outside the district to acquire a site or easement for: 18 19 (1) a road project authorized by Section 8353.103; or (2) a recreational facility as defined by Section 20 49.462, Water Code. 21 Sec. 8353.107. DIVISION OF DISTRICT. (a) The district may 22 be divided into two or more new districts only if the district: 23 24 (1) has no outstanding bonded debt; and 25 (2) is not imposing ad valorem taxes. 26 (b) This chapter applies to any new district created by the division of the district, and a new district has all the powers and 27

| 27 | Sec. 8353.202. TAXES FOR BONDS. At the time the district |

2 board shall provide for the annual imposition of a continuing 3 direct ad valorem tax, without limit as to rate or amount, while all 4 or part of the bonds are outstanding as required and in the manner 5 provided by Sections 54.601 and 54.602, Water Code. 6 Sec. 8353.203. BONDS FOR ROAD PROJECTS. At the time of 7 issuance, the total principal amount of bonds or other obligations 8 issued or incurred to finance road projects and payable from ad 9 valorem taxes may not exceed one-fourth of the assessed value of the

9 valorem taxes may not exceed one-fourth of the assessed value of the 10 real property in the district.

27 SECTION 3. (a) The legal notice of the intention to

1 introduce this Act, setting forth the general substance of this 2 Act, has been published as provided by law, and the notice and a 3 copy of this Act have been furnished to all persons, agencies, 4 officials, or entities to which they are required to be furnished 5 under Section 59, Article XVI, Texas Constitution, and Chapter 313, 6 Government Code.

7 (b) The governor, one of the required recipients, has 8 submitted the notice and Act to the Texas Commission on 9 Environmental Quality.

10 (c) The Texas Commission on Environmental Quality has filed its recommendations relating to this Act with the governor, the 11 12 lieutenant governor, and the speaker of the house of 13 representatives within the required time.

(d) All requirements of the constitution and laws of this state and the rules and procedures of the legislature with respect to the notice, introduction, and passage of this Act are fulfilled and accomplished.

SECTION 4. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2009.
