1-6 A BILL TO BE ENTITLED  
1-7 AN ACT

1-8 relating to the creation of the Comal County Water Improvement  
1-9 District No. 1; providing authority to impose a tax and issue bonds;  
1-10 granting a limited power of eminent domain.

1-11 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-12 SECTION 1. Subtitle I, Title 6, Special District Local Laws  
1-13 Code, is amended by adding Chapter 9038 to read as follows:

1-14 CHAPTER 9038. COMAL COUNTY WATER IMPROVEMENT DISTRICT NO. 1

1-15 SUBCHAPTER A. GENERAL PROVISIONS

1-16 Sec. 9038.001. DEFINITIONS. In this chapter:

1-17 (1) "Board" means the district's board of directors.

1-18 (2) "Director" means a board member.

1-19 (3) "District" means the Comal County Water  
1-20 Improvement District No. 1.

1-21 Sec. 9038.002. NATURE OF DISTRICT. The district is a water  
1-22 control and improvement district created under Section 59, Article  
1-23 XVI, Texas Constitution.

1-24 Sec. 9038.003. CONFIRMATION AND DIRECTORS' ELECTION  
1-25 REQUIRED. The temporary directors shall hold an election to  
1-26 confirm the creation of the district and to elect five permanent  
1-27 directors as provided by Section 49.102, Water Code.

1-28 Sec. 9038.004. CONSENT OF MUNICIPALITY AND DEVELOPMENT  
1-29 AGREEMENT REQUIRED. (a) The temporary directors may not hold an  
1-30 election under Section 9038.003 until each municipality in whose  
1-31 corporate limits or extraterritorial jurisdiction the district is  
1-32 located has:

1-33 (1) consented by ordinance or resolution to the  
1-34 creation of the district and to the inclusion of land in the  
1-35 district; and

1-36 (2) entered into a development agreement under Section  
1-37 212.172, Local Government Code, with the retail public utility  
1-38 owned by the municipality that addresses water and wastewater  
1-39 issues and with the owners of land in the district that addresses  
1-40 relevant issues, including:

1-41 (A) the provision of services other than water or  
1-42 wastewater services to land in the district, including emergency  
1-43 services and solid waste collection;

1-44 (B) traffic and roadway impacts caused by the  
1-45 creation of the district;

1-46 (C) the amount of debt to be issued by the  
1-47 district or any new district created by the division of the  
1-48 district;

1-49 (D) a plan for dividing the district, including  
1-50 the number, location, and size of any new districts created by the  
1-51 division of the district;

1-52 (E) fire flow; and

1-53 (F) a prohibition against a retail public  
1-54 utility, as defined by Section 13.002, Water Code, other than the  
1-55 retail public utility owned by the municipality, from providing  
1-56 retail water or wastewater service to the property in the district  
1-57 or a new district created by the division of the district.

1-58 (b) The development agreement may not contain a provision  
1-59 prohibited by Section 212.174, Local Government Code, in relation  
1-60 to the provision of utility service.

1-61 (c) A confirmation election held in violation of this  
1-62 section is void.

1-63 Sec. 9038.005. FINDINGS OF PUBLIC PURPOSE AND BENEFIT.

1-64 (a) The district is created to serve a public purpose and benefit.

2-1 (b) The district is created to accomplish the purposes of:  
2-2 (1) a water control and improvement district as  
2-3 provided by general law and Section 59, Article XVI, Texas  
2-4 Constitution; and

2-5 (2) Section 52, Article III, Texas Constitution, that  
2-6 relate to the construction, acquisition, improvement, operation,  
2-7 or maintenance of macadamized, graveled, or paved roads, or  
2-8 improvements, including storm drainage, in aid of those roads.

2-9 Sec. 9038.006. INITIAL DISTRICT TERRITORY. (a) The  
2-10 district is initially composed of the territory described by  
2-11 Section 2 of the Act creating this chapter.

2-12 (b) The boundaries and field notes contained in Section 2 of  
2-13 the Act creating this chapter form a closure. A mistake made in the  
2-14 field notes or in copying the field notes in the legislative process  
2-15 does not affect the district's:

2-16 (1) organization, existence, or validity;

2-17 (2) right to issue any type of bond for the purposes  
2-18 for which the district is created or to pay the principal of and  
2-19 interest on a bond;

2-20 (3) right to impose a tax; or

2-21 (4) legality or operation.

2-22 [Sections 9038.007-9038.050 reserved for expansion]

2-23 SUBCHAPTER B. BOARD OF DIRECTORS

2-24 Sec. 9038.051. GOVERNING BODY; TERMS. (a) The district is  
2-25 governed by a board of five elected directors.

2-26 (b) Except as provided by Section 9038.052, directors serve  
2-27 staggered four-year terms.

2-28 Sec. 9038.052. TEMPORARY DIRECTORS. (a) The temporary  
2-29 board consists of:

2-30 (1) Donnie Shaw;

2-31 (2) Bob Shemwell;

2-32 (3) Joe Dawson;

2-33 (4) Dick Nevitt; and

2-34 (5) Robert Whitley.

2-35 (b) Temporary directors serve until the earlier of:

2-36 (1) the date permanent directors are elected under  
2-37 Section 9038.003; or

2-38 (2) the fourth anniversary of the effective date of  
2-39 the Act creating this chapter.

2-40 (c) If permanent directors have not been elected under  
2-41 Section 9038.003 and the terms of the temporary directors have  
2-42 expired, successor temporary directors shall be appointed or  
2-43 reappointed as provided by Subsection (d) to serve terms that  
2-44 expire on the earlier of:

2-45 (1) the date permanent directors are elected under  
2-46 Section 9038.003; or

2-47 (2) the fourth anniversary of the date of the  
2-48 appointment or reappointment.

2-49 (d) If Subsection (c) applies, the owner or owners of a  
2-50 majority of the assessed value of the real property in the district  
2-51 may submit a petition to the Texas Commission on Environmental  
2-52 Quality requesting that the commission appoint as successor  
2-53 temporary directors the five persons named in the petition. The  
2-54 commission shall appoint as successor temporary directors the five  
2-55 persons named in the petition.

2-56 [Sections 9038.053-9038.100 reserved for expansion]

2-57 SUBCHAPTER C. POWERS AND DUTIES

2-58 Sec. 9038.101. GENERAL POWERS AND DUTIES. The district has  
2-59 the powers and duties necessary to accomplish the purposes for  
2-60 which the district is created.

2-61 Sec. 9038.102. WATER CONTROL AND IMPROVEMENT DISTRICT  
2-62 POWERS AND DUTIES. The district has the powers and duties provided  
2-63 by the general law of this state, including Chapters 49 and 51,  
2-64 Water Code, applicable to water control and improvement districts  
2-65 created under Section 59, Article XVI, Texas Constitution, and  
2-66 including powers relating to sanitary sewer.

2-67 Sec. 9038.103. AUTHORITY FOR ROAD PROJECTS. Under Section  
2-68 52, Article III, Texas Constitution, the district may design,  
2-69 acquire, construct, finance, issue bonds for, improve, operate,

3-1 maintain, and convey to this state, a county, or a municipality for  
 3-2 operation and maintenance macadamized, graveled, or paved roads, or  
 3-3 improvements, including storm drainage, in aid of those roads.

3-4 Sec. 9038.104. ROAD STANDARDS AND REQUIREMENTS. (a) A  
 3-5 road project must meet all applicable construction standards,  
 3-6 zoning and subdivision requirements, and regulations of each  
 3-7 municipality in whose corporate limits or extraterritorial  
 3-8 jurisdiction the road project is located.

3-9 (b) If a road project is not located in the corporate limits  
 3-10 or extraterritorial jurisdiction of a municipality, the road  
 3-11 project must meet all applicable construction standards,  
 3-12 subdivision requirements, and regulations of each county in which  
 3-13 the road project is located.

3-14 (c) If the state will maintain and operate the road, the  
 3-15 Texas Transportation Commission must approve the plans and  
 3-16 specifications of the road project.

3-17 Sec. 9038.105. WATER AND WASTEWATER INFRASTRUCTURE.

3-18 (a) The district may not construct a water or wastewater facility  
 3-19 unless any municipality in whose corporate limits or  
 3-20 extraterritorial jurisdiction the facility is located at the time  
 3-21 of construction has approved the plans and specifications of the  
 3-22 facility.

3-23 (b) On completion of a water or wastewater facility  
 3-24 described in a development agreement between the district and a  
 3-25 municipality, the district shall convey the facility to the  
 3-26 municipality or to the retail public utility owned by the  
 3-27 municipality, free of all liens, claims, or encumbrances, in the  
 3-28 form and manner acceptable to the municipality or retail public  
 3-29 utility.

3-30 Sec. 9038.106. COMPLIANCE WITH MUNICIPAL CONSENT ORDINANCE  
 3-31 OR RESOLUTION AND DEVELOPMENT AGREEMENT. (a) The district shall

3-32 comply with all applicable requirements of any ordinance or  
 3-33 resolution that is adopted under Section 42.042, Local Government  
 3-34 Code, and that consents to the creation of the district or to the  
 3-35 inclusion of land in the district.

3-36 (b) Notwithstanding other law, a municipality may place a  
 3-37 condition or restriction on the creation of the district or  
 3-38 inclusion of land in the district that is:

3-39 (1) expressly permitted by Sections 54.016(e) and (i),  
 3-40 Water Code; or

3-41 (2) contained in the development agreement entered  
 3-42 into under Section 212.172, Local Government Code, and this  
 3-43 chapter.

3-44 Sec. 9038.107. LIMITATION ON USE OF EMINENT DOMAIN. The  
 3-45 district may not exercise the power of eminent domain outside the  
 3-46 district to acquire a site or easement for:

3-47 (1) a road project authorized by Section 9038.103; or  
 3-48 (2) a recreational facility as defined by Section  
 3-49 49.462, Water Code.

3-50 Sec. 9038.108. DIVISION OF DISTRICT. (a) The district may  
 3-51 be divided into two or more new districts only if the district:

3-52 (1) has no outstanding bonded debt; and  
 3-53 (2) is not imposing ad valorem taxes.

3-54 (b) This chapter applies to any new district created by the  
 3-55 division of the district, and a new district has all the powers and  
 3-56 duties of the district.

3-57 (c) Any new district created by the division of the district  
 3-58 may not, at the time the new district is created, contain any land  
 3-59 outside the area described by Section 2 of the Act creating this  
 3-60 chapter.

3-61 (d) The board, on its own motion or on receipt of a petition  
 3-62 signed by the owner or owners of a majority of the assessed value of  
 3-63 the real property in the district, may adopt an order dividing the  
 3-64 district.

3-65 (e) The board may adopt an order dividing the district  
 3-66 before or after the date the board holds an election under Section  
 3-67 9038.003 to confirm the district's creation.

3-68 (f) An order dividing the district shall:

3-69 (1) name each new district;

4-1 (2) include the metes and bounds description of the  
4-2 territory of each new district;

4-3 (3) appoint temporary directors for each new district;  
4-4 and

4-5 (4) provide for the division of assets and liabilities  
4-6 between or among the new districts.

4-7 (g) On or before the 30th day after the date of adoption of  
4-8 an order dividing the district, the district shall file the order  
4-9 with the Texas Commission on Environmental Quality and record the  
4-10 order in the real property records of each county in which the  
4-11 district is located.

4-12 (h) Any new district created by the division of the district  
4-13 shall hold a confirmation and directors' election as required by  
4-14 Section 9038.003.

4-15 (i) Municipal consent to the creation of the district and to  
4-16 the inclusion of land in the district granted under Section  
4-17 9038.004 acts as municipal consent to the creation of any new  
4-18 district created by the division of the district and to the  
4-19 inclusion of land in the new district.

4-20 (j) Any new district created by the division of the district  
4-21 must hold an election as required by this chapter to obtain voter  
4-22 approval before the district may impose a maintenance tax or issue  
4-23 bonds payable wholly or partly from ad valorem taxes.

4-24 Sec. 9038.109. LIMITATION ON ANNEXATION OF LAND BY  
4-25 DISTRICT. The district or any new district created by the division  
4-26 of the district may not annex land outside the area described by  
4-27 Section 2 of the Act creating this chapter without the consent of  
4-28 each municipality in whose corporate limits or extraterritorial  
4-29 jurisdiction any of the land in the area described by Section 2 of  
4-30 the Act creating this chapter is located.

4-31 Sec. 9038.110. MUNICIPAL ANNEXATION ADJACENT TO DISTRICT.  
4-32 For the purposes of Section 43.021(2), Local Government Code, or  
4-33 other law, including a municipal charter or ordinance relating to  
4-34 annexation, an area adjacent to the district or any new district  
4-35 created by the division of the district is considered adjacent to a  
4-36 municipality in whose corporate limits or extraterritorial  
4-37 jurisdiction any of the land in the area described by Section 2 of  
4-38 the Act creating this chapter is located.

4-39 [Sections 9038.111-9038.150 reserved for expansion]

4-40 SUBCHAPTER D. GENERAL FINANCIAL PROVISIONS

4-41 Sec. 9038.151. ELECTIONS REGARDING TAXES OR BONDS.

4-42 (a) The district may issue, without an election, bonds and other  
4-43 obligations secured by:

4-44 (1) revenue other than ad valorem taxes; or

4-45 (2) contract payments described by Section 9038.153.

4-46 (b) The district must hold an election in the manner  
4-47 provided by Chapters 49 and 51, Water Code, to obtain voter approval  
4-48 before the district may impose an ad valorem tax or issue bonds  
4-49 payable from ad valorem taxes.

4-50 (c) The district may not issue bonds payable from ad valorem  
4-51 taxes to finance a road project unless the issuance is approved by a  
4-52 vote of a two-thirds majority of the district voters voting at an  
4-53 election held for that purpose.

4-54 Sec. 9038.152. OPERATION AND MAINTENANCE TAX. (a) If  
4-55 authorized at an election held under Section 9038.151, the district  
4-56 may impose an operation and maintenance tax on taxable property in  
4-57 the district in accordance with Section 49.107, Water Code.

4-58 (b) The board shall determine the tax rate. The rate may not  
4-59 exceed the rate approved at the election.

4-60 Sec. 9038.153. CONTRACT TAXES. (a) In accordance with  
4-61 Section 49.108, Water Code, the district may impose a tax other than  
4-62 an operation and maintenance tax and use the revenue derived from  
4-63 the tax to make payments under a contract after the provisions of  
4-64 the contract have been approved by a majority of the district voters  
4-65 voting at an election held for that purpose.

4-66 (b) A contract approved by the district voters may contain a  
4-67 provision stating that the contract may be modified or amended by  
4-68 the board without further voter approval.

4-69 [Sections 9038.154-9038.200 reserved for expansion]

SUBCHAPTER E. BONDS AND OTHER OBLIGATIONS

Sec. 9038.201. AUTHORITY TO ISSUE BONDS AND OTHER OBLIGATIONS. The district may issue bonds or other obligations payable wholly or partly from ad valorem taxes, impact fees, revenue, contract payments, grants, or other district money, or any combination of those sources, to pay for any authorized district purpose.

Sec. 9038.202. TAXES FOR BONDS. At the time the district issues bonds payable wholly or partly from ad valorem taxes, the board shall provide for the annual imposition of a continuing direct ad valorem tax, without limit as to rate or amount, while all or part of the bonds are outstanding as required and in the manner provided by Section 51.433, Water Code.

Sec. 9038.203. BONDS FOR ROAD PROJECTS. At the time of issuance, the total principal amount of bonds or other obligations issued or incurred to finance road projects and payable from ad valorem taxes may not exceed one-fourth of the assessed value of the real property in the district.

SECTION 2. The Comal County Water Improvement District No. 1 initially includes all the territory contained in the following area:

8-1 SECTION 3. (a) The legal notice of the intention to  
8-2 introduce this Act, setting forth the general substance of this  
8-3 Act, has been published as provided by law, and the notice and a  
8-4 copy of this Act have been furnished to all persons, agencies,  
8-5 officials, or entities to which they are required to be furnished  
8-6 under Section 59, Article XVI, Texas Constitution, and Chapter 313,  
8-7 Government Code.

8-8 (b) The governor, one of the required recipients, has  
8-9 submitted the notice and Act to the Texas Commission on  
8-10 Environmental Quality.

8-11 (c) The Texas Commission on Environmental Quality has filed  
8-12 its recommendations relating to this Act with the governor, the  
8-13 lieutenant governor, and the speaker of the house of  
8-14 representatives within the required time.

8-15 (d) All requirements of the constitution and laws of this  
8-16 state and the rules and procedures of the legislature with respect  
8-17 to the notice, introduction, and passage of this Act are fulfilled  
8-18 and accomplished.

8-19 SECTION 4. This Act takes effect immediately if it receives  
8-20 a vote of two-thirds of all the members elected to each house, as  
8-21 provided by Section 39, Article III, Texas Constitution. If this  
8-22 Act does not receive the vote necessary for immediate effect, this  
8-23 Act takes effect September 1, 2009.
