## A BILL TO BE ENTITLED

1	AN ACT
2	relating to the creation of the Montgomery County Water Control and
3	Improvement District No. 3; providing authority to impose a tax and
4	issue bonds; granting a limited power of eminent domain.
5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Subtitle I, Title 6, Special District Local Laws
7	Code, is amended by adding Chapter 9040 to read as follows:
8	CHAPTER 9040. MONTGOMERY COUNTY WATER CONTROL AND IMPROVEMENT
9	DISTRICT NO. 3
10	SUBCHAPTER A. GENERAL PROVISIONS
11	Sec. 9040.001. DEFINITIONS. In this chapter:
12	(1) "Board" means the district's board of directors.
13	(2) "Director" means a board member.
14	(3) "District" means the Montgomery County Water
15	Control and Improvement District No. 3.
16	Sec. 9040.002. NATURE OF DISTRICT. The district is a water
17	control and improvement district created under Section 59, Article
18	XVI, Texas Constitution.
19	Sec. 9040.003. CONFIRMATION AND DIRECTORS' ELECTION
20	REQUIRED. The temporary directors shall hold an election to
21	confirm the creation of the district and to elect five permanent
22	directors as provided by Section 49.102, Water Code.
23	Sec. 9040.004. CONSENT OF MUNICIPALITY REQUIRED. The
24	temporary directors may not hold an election under Section 9040.003

- 1 until each municipality in whose corporate limits or
- 2 extraterritorial jurisdiction the district is located has
- 3 consented by ordinance or resolution to the creation of the
- 4 district and to the inclusion of land in the district.
- 5 Sec. 9040.005. FINDINGS OF PUBLIC PURPOSE AND BENEFIT. (a)
- 6 The district is created to serve a public purpose and benefit.
- 7 (b) The district is created to accomplish the purposes of a
- 8 water control and improvement district as provided by general law
- 9 and Section 59, Article XVI, Texas Constitution.
- 10 Sec. 9040.006. INITIAL DISTRICT TERRITORY. (a) The
- 11 district is initially composed of the territory described by
- 12 Section 2 of the Act creating this chapter.
- 13 (b) The boundaries and field notes contained in Section 2 of
- 14 the Act creating this chapter form a closure. A mistake made in the
- 15 <u>field notes or in copying the field notes in the legislative process</u>
- 16 does not affect the district's:
- 17 (1) organization, existence, or validity;
- 18 (2) right to issue any type of bond for the purposes
- 19 for which the district is created or to pay the principal of and
- 20 interest on a bond;
- 21 (3) right to impose a tax; or
- 22 <u>(4) legality or operation.</u>
- [Sections 9040.007-9040.050 reserved for expansion]
- SUBCHAPTER B. BOARD OF DIRECTORS
- Sec. 9040.051. GOVERNING BODY; TERMS. (a) The district is
- 26 governed by a board of five elected directors.
- 27 (b) Except as provided by Section 9040.052, directors serve

- 1 staggered four-year terms.
- 2 Sec. 9040.052. TEMPORARY DIRECTORS. (a) On or after the
- 3 effective date of the Act creating this chapter, the owner or owners
- 4 of a majority of the assessed value of the real property in the
- 5 district may submit a petition to the Texas Commission on
- 6 Environmental Quality requesting that the commission appoint as
- 7 temporary directors the five persons named in the petition. The
- 8 commission shall appoint as temporary directors the five persons
- 9 named in the petition.
- 10 (b) Temporary directors serve until the earlier of:
- 11 (1) the date permanent directors are elected under
- 12 Section 9040.003; or
- 13 (2) the fourth anniversary of the effective date of
- 14 the Act creating this chapter.
- 15 <u>(c)</u> If permanent directors have not been elected under
- 16 Section 9040.003 and the terms of the temporary directors have
- 17 expired, successor temporary directors shall be appointed or
- 18 reappointed as provided by Subsection (d) to serve terms that
- 19 expire on the earlier of:
- 20 (1) the date permanent directors are elected under
- 21 <u>Section 9040.003; or</u>
- 22 (2) the fourth anniversary of the date of the
- 23 appointment or reappointment.
- 24 (d) If Subsection (c) applies, the owner or owners of a
- 25 majority of the assessed value of the real property in the district
- 26 may submit a petition to the Texas Commission on Environmental
- 27 Quality requesting that the commission appoint as successor

- 2 commission shall appoint as successor temporary directors the five
- 3 persons named in the petition.
- 4 [Sections 9040.053-9040.100 reserved for expansion]
- 5 SUBCHAPTER C. POWERS AND DUTIES
- 6 Sec. 9040.101. GENERAL POWERS AND DUTIES. The district has
- 7 the powers and duties necessary to accomplish the purposes for
- 8 which the district is created.
- 9 Sec. 9040.102. WATER CONTROL AND IMPROVEMENT DISTRICT
- 10 POWERS AND DUTIES. (a) The district has the powers and duties
- 11 provided by the general law of this state, including Chapters 49 and
- 12 51, Water Code, applicable to water control and improvement
- 13 districts created under Section 59, Article XVI, Texas
- 14 Constitution.
- (b) The powers and duties authorized under Subsection (a)
- 16 shall specifically include the powers authorized under Subchapter
- 17 H, Chapter 51, Water Code.
- 18 Sec. 9040.103. COMPLIANCE WITH MUNICIPAL CONSENT ORDINANCE
- 19 OR RESOLUTION. The district shall comply with all applicable
- 20 requirements of any ordinance or resolution that is adopted under
- 21 Section 42.042 or 42.0425, Local Government Code, and that consents
- 22 to the creation of the district or to the inclusion of land in the
- 23 <u>district.</u>
- Sec. 9040.104. LIMITATION ON USE OF EMINENT DOMAIN. The
- 25 district may not exercise the power of eminent domain outside the
- 26 district to acquire a site or easement for a recreational facility
- 27 as defined by Section 49.462, Water Code.

2	SUBCHAPTER D. GENERAL FINANCIAL PROVISIONS
3	Sec. 9040.151. ELECTIONS REGARDING TAXES OR BONDS. (a) The
4	district may issue, without an election, bonds and other
5	obligations secured by:
6	(1) revenue other than ad valorem taxes; or
7	(2) contract payments described by Section 9040.153.
8	(b) The district must hold an election in the manner
9	provided by Chapters 49 and 51, Water Code, to obtain voter approval
10	before the district may impose an ad valorem tax or issue bonds
11	payable from ad valorem taxes.
12	Sec. 9040.152. OPERATION AND MAINTENANCE TAX. (a) If
13	authorized at an election held under Section 9040.151, the district
14	may impose an operation and maintenance tax on taxable property in
15	the district in accordance with Section 49.107, Water Code.
16	(b) The board shall determine the tax rate. The rate may not
17	exceed the rate approved at the election.
18	Sec. 9040.153. CONTRACT TAXES. (a) In accordance with
19	Section 49.108, Water Code, the district may impose a tax other than
20	an operation and maintenance tax and use the revenue derived from
21	the tax to make payments under a contract after the provisions of
22	the contract have been approved by a majority of the district voters
23	voting at an election held for that purpose.
24	(b) A contract approved by the district voters may contain a
25	provision stating that the contract may be modified or amended by
26	the board without further voter approval.

## 1 SUBCHAPTER E. BONDS AND OTHER OBLIGATIONS

- 2 Sec. 9040.201. AUTHORITY TO ISSUE BONDS AND OTHER
- 3 OBLIGATIONS. The district may issue bonds or other obligations
- 4 payable wholly or partly from ad valorem taxes, impact fees,
- 5 revenue, contract payments, grants, or other district money, or any
- 6 combination of those sources, to pay for any authorized district
- 7 purpose.
- 8 Sec. 9040.202. TAXES FOR BONDS. At the time the district
- 9 issues bonds payable wholly or partly from ad valorem taxes, the
- 10 board shall provide for the annual imposition of a continuing
- 11 direct ad valorem tax, without limit as to rate or amount, while all
- 12 or part of the bonds are outstanding as required and in the manner
- 13 provided by Chapter 51, Water Code.
- 14 Sec. 9040.203. BONDS FOR RECREATIONAL FACILITIES. (a) The
- 15 district may develop recreational facilities and issue bonds for
- 16 the facilities under Chapter 49, Water Code, notwithstanding any
- 17 overlap of the district's territory with the territory of one or
- 18 more political subdivisions authorized to develop recreational
- 19 facilities and issue bonds under Chapter 49, Water Code.
- 20 (b) The authority of the district to develop recreational
- 21 <u>facilities</u> and issue bonds under this section does not limit the
- 22 <u>authority of any other political subdivision whose territory the</u>
- 23 territory of the district may overlap, wholly or partly, to develop
- 24 recreational facilities and issue bonds under Chapter 49, Water
- 25 Code.
- 26 SECTION 2. The Montgomery County Water Control and
- 27 Improvement District No. 3 initially includes all the territory
