S.B. No. 2531

A BILL TO BE ENTITLED

AN ACT

relating to the creation of the Harris County Improvement District No. 15; providing authority to impose an assessment, impose a tax, and issue bonds.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Subtitle C, Title 4, Special District Local Laws Code, is amended by adding Chapter 3883 to read as follows:

CHAPTER 3883. HARRIS COUNTY IMPROVEMENT DISTRICT NO. 15

SUBCHAPTER A. GENERAL PROVISIONS

Sec. 3883.001. DEFINITIONS. In this chapter:

(1) "Board" means the district's board of directors.

(2) "Director" means a board member.

(3) "District" means the Harris County Improvement District No. 15.

Sec. 3883.002. NATURE OF DISTRICT. The Harris County Improvement District No. 15 is a special district created under Section 59, Article XVI, Texas Constitution.

Sec. 3883.003. PURPOSE; DECLARATION OF INTENT. (a) The creation of the district is essential to accomplish the purposes of Sections 52 and 52-a, Article III, and Section 59, Article XVI, Texas Constitution, and other public purposes stated in this chapter. By creating the district and in authorizing the City of Houston, Harris County, and other political subdivisions to contract with the district, the legislature has established a

1 program to accomplish the public purposes set out in Section 52-a,
2 Article III, Texas Constitution.

3 (b) The creation of the district is necessary to promote,
4 develop, encourage, and maintain employment, commerce,
5 transportation, housing, tourism, recreation, the arts,
6 entertainment, economic development, safety, and the public
7 welfare in the district.

8 (c) This chapter and the creation of the district may not be
9 interpreted to relieve Harris County from providing the level of
10 services provided, as of the effective date of the Act enacting this
11 chapter, to the area in the district. The district is created to
12 supplement and not to supplant the county services provided in the
13 area in the district.

14 Sec. 3883.004. FINDINGS OF BENEFIT AND PUBLIC PURPOSE.

15 (a) The district is created to serve a public use and benefit.

16 (b) All land and other property included in the district
17 will benefit from the improvements and services to be provided by
18 the district under powers conferred by Sections 52 and 52-a,
19 Article III, and Section 59, Article XVI, Texas Constitution, and
20 other powers granted under this chapter.

21 (c) The creation of the district is in the public interest
22 and is essential to:

23 (1) further the public purposes of developing and
24 diversifying the economy of the state;

25 (2) eliminate unemployment and underemployment; and

26 (3) develop or expand transportation and commerce.

27 (d) The district will:

1 (1) promote the health, safety, and general welfare of
2 residents, employers, potential employees, employees, visitors,
3 and consumers in the district, and of the public;

4 (2) provide needed funding for the district to
5 preserve, maintain, and enhance the economic health and vitality of
6 the district territory as a community and business center;

7 (3) promote the health, safety, welfare, and enjoyment
8 of the public by providing pedestrian ways and by landscaping and
9 developing certain areas in the district, which are necessary for
10 the restoration, preservation, and enhancement of scenic beauty;

11 (4) provide for water, wastewater, drainage, road, and
12 recreational facilities for the district; and

13 (5) provide for canals, waterways, bulkheads, docks,
14 and other similar improvements or facilities for the district.

15 (e) Pedestrian ways along or across a street, whether at
16 grade or above or below the surface, and street lighting, street
17 landscaping, parking, and street art objects are parts of and
18 necessary components of a street and are considered to be a street
19 or road improvement.

20 (f) The district will not act as the agent or
21 instrumentality of any private interest even though the district
22 will benefit many private interests as well as the public.

23 Sec. 3883.005. INITIAL DISTRICT TERRITORY. (a) The
24 district is initially composed of the territory described by
25 Section 2 of the Act enacting this chapter.

26 (b) The boundaries and field notes contained in Section 2 of
27 the Act enacting this chapter form a closure. A mistake in the

1 field notes or in copying the field notes in the legislative process
2 does not affect the district's:

3 (1) organization, existence, or validity;

4 (2) right to issue any type of bond for the purposes
5 for which the district is created or to pay the principal of and
6 interest on the bond;

7 (3) right to impose or collect an assessment or tax; or

8 (4) legality or operation.

9 Sec. 3883.006. ELIGIBILITY FOR INCLUSION IN SPECIAL ZONES.

10 All or any part of the area of the district is eligible to be
11 included in:

12 (1) a tax increment reinvestment zone created under
13 Chapter 311, Tax Code;

14 (2) a tax abatement reinvestment zone created under
15 Chapter 312, Tax Code; or

16 (3) an enterprise zone created under Chapter 2303,
17 Government Code.

18 Sec. 3883.007. APPLICABILITY OF MUNICIPAL MANAGEMENT
19 DISTRICTS LAW. Except as otherwise provided by this chapter,
20 Chapter 375, Local Government Code, applies to the district.

21 Sec. 3883.008. LIBERAL CONSTRUCTION OF CHAPTER. This
22 chapter shall be liberally construed in conformity with the
23 findings and purposes stated in this chapter.

24 [Sections 3883.009-3883.050 reserved for expansion]

25 SUBCHAPTER B. BOARD OF DIRECTORS

26 Sec. 3883.051. GOVERNING BODY; TERMS. (a) The district is
27 governed by a board of seven voting directors who serve staggered

1 terms of four years, with three or four directors' terms expiring
2 June 1 of each odd-numbered year.

3 (b) The board by resolution may change the number of voting
4 directors on the board, but only if the board determines that the
5 change is in the best interest of the district. The board may not
6 consist of fewer than five or more than 15 voting directors.

7 Sec. 3883.052. APPOINTMENT OF DIRECTORS. The Texas
8 Commission on Environmental Quality shall appoint voting directors
9 from persons recommended by the board.

10 Sec. 3883.053. INITIAL VOTING DIRECTORS. (a) The initial
11 board consists of the following voting directors:

20 (b) Of the initial directors, the terms of directors
21 appointed for positions 1 through 4 expire June 1, 2011, and the
22 terms of directors appointed for positions 5 through 7 expire June
23 1, 2013.

24 (c) Section 3883.052 does not apply to this section.

25 Sec. 3883.054. NONVOTING DIRECTORS. The board may appoint
26 nonvoting directors to serve at the pleasure of the voting
27 directors.

1 Sec. 3883.055. QUORUM. For purposes of determining the
2 requirements for a quorum of the board, the following are not
3 counted:

4 (1) a board position vacant for any reason, including
5 death, resignation, or disqualification;

6 (2) a director who is abstaining from participation in
7 a vote because of a conflict of interest; or

8 (3) a nonvoting director.

9 Sec. 3883.056. COMPENSATION. A director is entitled to
10 receive fees of office and reimbursement for actual expenses as
11 provided by Section 49.060, Water Code. Sections 375.069 and
12 375.070, Local Government Code, do not apply to the board.

13 [Sections 3883.057-3883.100 reserved for expansion]

14 SUBCHAPTER C. POWERS AND DUTIES

15 Sec. 3883.101. MARITIME IMPROVEMENT AND OPERATIONS POWERS.

16 (a) In this section, "port authority" means the Port of Houston
17 Authority of Harris County, Texas.

18 (b) Except as provided by this section, the district may
19 purchase, construct, acquire, own, operate, maintain, improve, or
20 extend, inside and outside the district, canals, waterways,
21 bulkheads, docks, and any other improvements or facilities
22 necessary or convenient to accomplish the navigation purposes of
23 the district authorized by Section 59, Article XVI, Texas
24 Constitution.

25 (c) The district may not exercise its powers in, over,
26 under, or across any lands or submerged lands of the port authority,
27 as conveyed by the State of Texas to the Harris County Houston Ship

1 Channel Navigation District by Chapter 292, Acts of the 40th
2 Legislature, Regular Session, 1927.

3 (d) The design, construction, operation, and maintenance of
4 any improvements or facilities related to navigation of the area
5 commonly known as the Houston Ship Channel or its tributaries, as
6 described in Section 1, Chapter 97, Acts of the 40th Legislature,
7 1st Called Session, 1927, by the district, any owner of land in the
8 district, or any other person acting by, through, or on behalf of
9 the district or a person who owns land in the district, whether by
10 permission, agency, agreement, lease, easement, license, or
11 otherwise, must comply with the applicable rules, regulations,
12 bylaws, and similar legislative or regulatory acts or policies of
13 the port authority.

14 (e) Each rule, bylaw, or similar legislative or regulatory
15 act or policy of the district is subject to any applicable rule,
16 bylaw, or similar legislative or regulatory act or policy of the
17 port authority. In case of any conflict or inconsistency, the port
18 authority's rules, bylaws, or similar legislative or regulatory
19 acts or policies control over the rules, bylaws, or similar
20 legislative or regulatory acts or policies of the district.

21 (f) The rights, powers, privileges, and authority this
22 chapter confers on the district do not supersede or diminish the
23 rights, powers, privileges, and authority of the port authority,
24 the United States Army Corps of Engineers, or any other state or
25 federal agency.

26 Sec. 3883.102. DEVELOPMENT CORPORATION POWERS. The
27 district may exercise the powers given to a development corporation

1 under Chapter 505, Local Government Code, including the power to
2 own, operate, acquire, construct, lease, improve, or maintain a
3 project described by that chapter.

4 Sec. 3883.103. NONPROFIT CORPORATION. (a) The board by
5 resolution may authorize the creation of a nonprofit corporation to
6 assist and act for the district in implementing a project or
7 providing a service authorized by this chapter.

8 (b) The nonprofit corporation:

9 (1) has each power of and is considered for purposes of
10 this chapter to be a local government corporation created under
11 Chapter 431, Transportation Code; and

12 (2) may implement any project and provide any service
13 authorized by this chapter.

14 (c) The board shall appoint the board of directors of the
15 nonprofit corporation. The board of directors of the nonprofit
16 corporation shall serve in the same manner as the board of directors
17 of a local government corporation created under Chapter 431,
18 Transportation Code, except that a board member is not required to
19 reside in the district.

20 Sec. 3883.104. AGREEMENTS; GRANTS. (a) The district may
21 make an agreement with or accept a gift, grant, or loan from any
22 person.

23 (b) The implementation of a project is a governmental
24 function or service for the purposes of Chapter 791, Government
25 Code.

26 Sec. 3883.105. AUTHORITY TO CONTRACT FOR LAW ENFORCEMENT
27 SERVICES. To protect the public interest, the district may

1 contract with a qualified person, including Harris County or the
2 City of Houston, for the provision of law enforcement services in
3 the district for a fee.

4 Sec. 3883.106. MEMBERSHIP IN CHARITABLE ORGANIZATIONS. The
5 district may join and pay dues to a charitable or nonprofit
6 organization that performs a service or provides an activity
7 consistent with the furtherance of a district purpose.

8 Sec. 3883.107. ECONOMIC DEVELOPMENT PROGRAMS. (a) The
9 district may establish and provide for the administration of one or
10 more programs to promote state or local economic development and to
11 stimulate business and commercial activity in the district,
12 including programs to:

13 (1) make loans and grants of public money; and

14 (2) provide district personnel and services.

15 (b) The district has all of the powers of a municipality
16 under Chapter 380, Local Government Code.

17 Sec. 3883.108. STRATEGIC PARTNERSHIP AGREEMENT. The
18 district may negotiate and enter into a written strategic
19 partnership with the City of Houston pursuant to Section 43.0751,
20 Local Government Code.

21 Sec. 3883.109. NO EMINENT DOMAIN. The district may not
22 exercise the power of eminent domain.

23 Sec. 3883.110. ANNEXATION OR EXCLUSION OF LAND. (a) The
24 district may annex land as provided by Subchapter J, Chapter 49,
25 Water Code.

26 (b) The district may exclude land as provided by Subchapter
27 J, Chapter 49, Water Code. Section 375.044(b), Local Government

1 Code, does not apply to the district.

2 [Sections 3883.111-3883.150 reserved for expansion]

3 SUBCHAPTER D. PUBLIC TRANSIT SYSTEM AND PARKING FACILITIES

4 Sec. 3883.151. PUBLIC TRANSIT SYSTEM. The district may
5 acquire, lease as lessor or lessee, construct, develop, own,
6 operate, and maintain a public transit system to serve the area in
7 the district.

8 Sec. 3883.152. PARKING FACILITIES AUTHORIZED; OPERATION BY
9 PRIVATE ENTITY. (a) The district may acquire, lease as lessor or
10 lessee, construct, develop, own, operate, and maintain parking
11 facilities or a system of parking facilities, including:

12 (1) lots, garages, parking terminals, or other
13 structures or accommodations for parking motor vehicles off the
14 streets; and

15 (2) equipment, entrances, exits, fencing, and other
16 accessories necessary for safety and convenience in parking
17 vehicles.

18 (b) A parking facility of the district may be leased to or
19 operated on behalf of the district by an entity other than the
20 district.

21 (c) The district's parking facilities are a program
22 authorized by the legislature under Section 52-a, Article III,
23 Texas Constitution.

24 (d) The district's parking facilities serve the public
25 purposes of the district and are owned, used, and held for a public
26 purpose even if leased or operated by a private entity for a term of
27 years.

1 Sec. 3883.153. RULES. The district may adopt rules
2 governing the district's public parking facilities.

3 Sec. 3883.154. FINANCING OF PUBLIC TRANSIT SYSTEM OR
4 PARKING FACILITIES. (a) The district may use any of its
5 resources, including revenue, assessments, taxes, or grant or
6 contract proceeds, to pay the cost of acquiring or operating a
7 public transit system or public parking facilities.

8 (b) The district may:

9 (1) set, charge, impose, and collect fees, charges, or
10 tolls for the use of the district's public transit system or parking
11 facilities; and

12 (2) issue bonds or notes to finance the cost of the
13 district's public transit system or parking facilities.

14 [Sections 3883.155-3883.200 reserved for expansion]

15 SUBCHAPTER E. GENERAL FINANCIAL PROVISIONS

16 Sec. 3883.201. DISBURSEMENTS AND TRANSFERS OF MONEY. The
17 board by resolution shall establish the number of directors'
18 signatures and the procedure required for a disbursement or
19 transfer of the district's money.

20 Sec. 3883.202. MONEY USED FOR IMPROVEMENTS OR SERVICES.
21 The district may acquire, construct, finance, operate, or maintain
22 any improvement or service authorized under this chapter or Chapter
23 375, Local Government Code, using any money available to the
24 district.

25 Sec. 3883.203. PETITION REQUIRED FOR FINANCING SERVICES AND
26 IMPROVEMENTS WITH ASSESSMENTS. (a) The board may not finance a
27 service or improvement project with assessments under this chapter

1 unless a written petition requesting that service or improvement
2 has been filed with the board.

3 (b) A petition filed under Subsection (a) must be signed by
4 the owners of a majority of the assessed value of real property in
5 the district subject to assessment according to the most recent
6 certified tax appraisal roll for Harris County.

7 Sec. 3883.204. METHOD OF NOTICE FOR HEARING. The district
8 may mail the notice required by Section 375.115(c), Local
9 Government Code, by certified or first class United States mail.
10 The board shall determine the method of mailing notice.

11 Sec. 3883.205. ASSESSMENTS; LIENS FOR ASSESSMENTS.
12 (a) The board by resolution may impose and collect an assessment
13 for any purpose authorized by this chapter in all or any part of the
14 district.

15 (b) An assessment, a reassessment, or an assessment
16 resulting from an addition to or correction of the assessment roll
17 by the district, penalties and interest on an assessment or
18 reassessment, an expense of collection, and reasonable attorney's
19 fees incurred by the district:

20 (1) are a first and prior lien against the property
21 assessed;

22 (2) are superior to any other lien or claim other than
23 a lien or claim for county, school district, or municipal ad valorem
24 taxes; and

25 (3) are the personal liability of and a charge against
26 the owners of the property even if the owners are not named in the
27 assessment proceedings.

1 (c) The lien is effective from the date of the board's
2 resolution imposing the assessment until the date the assessment is
3 paid. The board may enforce the lien in the same manner that the
4 board may enforce an ad valorem tax lien against real property.

5 (d) The board may make a correction to or deletion from the
6 assessment roll that does not increase the amount of assessment of
7 any parcel of land without providing notice and holding a hearing in
8 the manner required for additional assessments.

9 Sec. 3883.206. UTILITY PROPERTY EXEMPT FROM IMPACT FEES AND
10 ASSESSMENTS. The district may not impose an impact fee or
11 assessment on the property, including the equipment,
12 rights-of-way, facilities, or improvements, of:

13 (1) an electric utility or a power generation company
14 as defined by Section 31.002, Utilities Code;

15 (2) a gas utility as defined by Section 101.003 or
16 121.001, Utilities Code;

17 (3) a telecommunications provider as defined by
18 Section 51.002, Utilities Code; or

19 (4) a person who provides to the public cable
20 television or advanced telecommunications services.

21 Sec. 3883.207. OPERATION AND MAINTENANCE TAX. (a) If
22 authorized at an election held in accordance with Section 3883.211,
23 the district may impose an annual operation and maintenance tax on
24 taxable property in the district in accordance with Section 49.107,
25 Water Code, for any district purpose, including to:

26 (1) maintain and operate the district;

27 (2) construct or acquire improvements; or

1 (3) provide a service.

2 (b) The board shall determine the tax rate. The rate may not
3 exceed the rate approved at the election.

4 (c) Section 49.107(h), Water Code, does not apply to the
5 district.

6 Sec. 3883.208. CONTRACT TAXES. (a) In accordance with
7 Section 49.108, Water Code, the district may impose a tax other than
8 an operation and maintenance tax and use the revenue derived from
9 the tax to make payments under a contract after the provisions of
10 the contract have been approved by a majority of the district voters
11 voting at an election held for that purpose.

12 (b) A contract approved by the district voters may contain a
13 provision stating that the contract may be modified or amended by
14 the board without further voter approval.

15 Sec. 3883.209. AUTHORITY TO BORROW MONEY AND TO ISSUE
16 BONDS. (a) The district may borrow money on terms and conditions
17 as determined by the board. Section 375.205, Local Government
18 Code, does not apply to a loan, line of credit, or other borrowing
19 from a bank or financial institution secured by revenue other than
20 ad valorem taxes.

21 (b) The district may issue bonds, notes, or other
22 obligations payable wholly or partly from ad valorem taxes, sales
23 and use taxes, assessments, impact fees, revenue, contract
24 payments, grants, or other district money, or any combination of
25 those sources of money, to pay for any authorized district purpose.

26 (c) The limitation on the outstanding principal amount of
27 bonds, notes, and other obligations set forth in Section 49.4645,

1 Water Code, does not apply to the district.

2 Sec. 3883.210. TAXES FOR BONDS. At the time the district
3 issues bonds payable wholly or partly from ad valorem taxes, the
4 board shall provide for the annual imposition of a continuing
5 direct annual ad valorem tax, without limit as to rate or amount,
6 while all or part of the bonds are outstanding as required and in
7 the manner provided by Sections 54.601 and 54.602, Water Code.

8 Sec. 3883.211. ELECTIONS REGARDING TAXES AND BONDS.

9 (a) The district may issue, without an election, bonds, notes, and
10 other obligations secured by:

11 (1) revenue other than ad valorem taxes; or

12 (2) contract payments described by Section 3883.208.

13 (b) The district must hold an election in the manner
14 provided by Subchapter L, Chapter 375, Local Government Code, to
15 obtain voter approval before the district may impose an ad valorem
16 tax or sales and use tax or issue bonds payable from ad valorem
17 taxes.

18 (c) Section 375.243, Local Government Code, does not apply
19 to the district.

20 (d) All or any part of any facilities or improvements which
21 may be acquired by a district by the issuance of its bonds may be
22 included in one single proposition to be voted on at the election or
23 the bonds may be submitted in several propositions.

24 Sec. 3883.212. COMPETITIVE BIDDING. Subchapter I, Chapter
25 49, Water Code, applies to the district. Sections 375.221 and
26 375.223, Local Government Code, do not apply to the district.

27 Sec. 3883.213. TAX AND ASSESSMENT ABATEMENTS. The district

1 may grant in the manner authorized by Chapter 312, Tax Code, an
2 abatement for a tax or assessment owed to the district.

3 [Sections 3883.214-3883.250 reserved for expansion]

4 SUBCHAPTER F. TAXES FOR CERTAIN DEFINED AREAS AND DESIGNATED
5 PROPERTY

6 Sec. 3883.251. AUTHORITY TO ESTABLISH DEFINED AREAS OR
7 DESIGNATED PROPERTY. The district may define areas or designate
8 certain property of the district to pay for improvements,
9 facilities, or services that primarily benefit that area or
10 property and do not generally and directly benefit the district as a
11 whole.

12 Sec. 3883.252. PROCEDURE FOR ELECTION. (a) Before the
13 district may impose an ad valorem tax or issue bonds payable from ad
14 valorem taxes of the area defined or property designated under
15 Section 3883.251, the board must call and hold an election as
16 provided by Section 3883.211 only in the defined area or in the
17 boundaries of the designated property.

18 (b) The board may submit the proposition to the voters on
19 the same ballot to be used in another election.

20 Sec. 3883.253. DECLARING RESULT AND ISSUING ORDER. (a) If
21 a majority of the voters voting at the election approve the
22 proposition or propositions, the board shall declare the results
23 and by order shall establish the defined area and describe it by
24 metes and bounds or designate the specific property.

25 (b) A court may not review the board's order except on the
26 ground of fraud, palpable error, or arbitrary and confiscatory
27 abuse of discretion.

1 Sec. 3883.254. TAXES FOR SERVICES, IMPROVEMENTS, AND
2 FACILITIES IN DEFINED AREAS OR DESIGNATED PROPERTY. On voter
3 approval and adoption of the order described in Section 3883.253,
4 the district may apply separately, differently, equitably, and
5 specifically its taxing power and lien authority to the defined
6 area or designated property to provide money to construct,
7 administer, maintain, and operate services, improvements, and
8 facilities that primarily benefit the defined area or designated
9 property.

10 Sec. 3883.255. ISSUANCE OF BONDS AND IMPOSITION OF TAXES
11 FOR DEFINED AREA OR DESIGNATED PROPERTY. After the order under
12 Section 3883.253 is adopted, the district may issue bonds to
13 provide for any land, improvements, facilities, plants, equipment,
14 and appliances for the defined area or designated property.

15 [Sections 3883.256-3883.300 reserved for expansion]

16 SUBCHAPTER G. MUNICIPAL ANNEXATION AND DISSOLUTION

17 Sec. 3883.301. MUNICIPAL ANNEXATION; DISSOLUTION.

18 (a) The district is a "water or sewer district" under Section
19 43.071, Local Government Code.

20 (b) Section 43.075, Local Government Code, applies to the
21 district.

22 (c) Section 375.264, Local Government Code, does not apply
23 to the dissolution of the district by a municipality.

24 SECTION 2. Harris County Improvement District No. 15
25 initially includes all territory contained in the following area:

26 TRACT 1:

27 Being a tract of land containing 384.667 acres, located in

1 the Richard and Robert Vince Survey, Abstract-76 in Harris County,
2 Texas; said 384.667 acres being all of a called 384.581 acre tract
3 described in the Special Warranty Deed with Vendor's Lien, recorded
4 in the name Port At Greens Bayou, Ltd., in Harris County Clerk's
5 File Number (H.C.C.F. No.) Z264553; said 384.667 acre tract being
6 more particularly described by metes and bounds as follows (all
7 bearings are based on the Texas State Plane Coordinate System,
8 South Central Zone (NAD27), per said H.C.C.F. No. Z264553):

9 Beginning at a 5/8-inch iron rod found on the westerly
10 Right-Of-Way (R.O.W.) line of Beltway 8 East (variable width per
11 instruments recoded under H.C.C.F. Nos. F894212, L150096, G259887,
12 G259888, G259889 and G259890), being the northeast corner of said
13 384.581 acre tract, and being in the southerly line of a called
14 75.253 acre tract described in the General Warranty Deed recorded
15 in the name of Missouri Pacific Railroad Company in Volume 4245,
16 Page 527 of the Harris County Deed Records (H.C.D.R.);

17 Thence, with the westerly lines of said Beltway 8 East and the
18 easterly lines of said 384.581 acre tract, the following nine (9)
19 courses:

20 1. South 02 degrees 42 minutes 24 seconds East, a distance
21 of 1089.96 feet to a 5/8-inch iron rod with "MSG cap set;

18 SECTION 3. (a) The legal notice of the intention to
19 introduce this Act, setting forth the general substance of this
20 Act, has been published as provided by law, and the notice and a
21 copy of this Act have been furnished to all persons, agencies,
22 officials, or entities to which they are required to be furnished
23 under Section 59, Article XVI, Texas Constitution, and Chapter 313,
24 Government Code.

25 (b) The governor, one of the required recipients, has
26 submitted the notice and Act to the Texas Commission on
27 Environmental Quality.

1 (c) The Texas Commission on Environmental Quality has filed
2 its recommendations relating to this Act with the governor,
3 lieutenant governor, and speaker of the house of representatives
4 within the required time.

5 (d) The general law relating to consent by political
6 subdivisions to the creation of districts with conservation,
7 reclamation, and road powers and the inclusion of land in those
8 districts has been complied with.

9 (e) All requirements of the constitution and laws of this
10 state and the rules and procedures of the legislature with respect
11 to the notice, introduction, and passage of this Act have been
12 fulfilled and accomplished.

13 SECTION 4. This Act takes effect immediately if it receives
14 a vote of two-thirds of all the members elected to each house, as
15 provided by Section 39, Article III, Texas Constitution. If this
16 Act does not receive the vote necessary for immediate effect, this
17 Act takes effect September 1, 2009.
