## A BILL TO BE ENTITLED 1 AN ACT 2 relating to the creation of the Lake Texoma Municipal Utility District No. 1; providing authority to impose a tax or assessment 3 and issue bonds; granting a limited power of eminent domain. 4 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 6 SECTION 1. Subtitle F, Title 6, Special District Local Laws 7 Code, is amended by adding Chapter 8359 to read as follows: CHAPTER 8359. LAKE TEXOMA MUNICIPAL UTILITY DISTRICT NO. 1 8 9 SUBCHAPTER A. GENERAL PROVISIONS Sec. 8359.001. DEFINITIONS. In this chapter: 10 11 (1) "Board" means the district's board of directors. 12 (2) "Director" means a board member. 13 (3) "District" means the Lake Texoma Municipal Utility 14 District No. 1. Sec. 8359.002. NATURE OF DISTRICT. The district is a 15 16 municipal utility district created under Section 59, Article XVI, 17 Texas Constitution. 18 Sec. 8359.003. CONFIRMATION AND DIRECTORS' ELECTION REQUIRED. (a) The temporary directors shall hold an election to 19 confirm the creation of the district and to elect five permanent 20 21 directors as provided by Section 49.102, Water Code. 22 (b) The temporary directors of any new district created 23 under Section 8359.108 may not hold an election under Subsection 24 (a) until the earlier of:

1	(1) the date the land in the new district has been
2	annexed by the City of Denison; or
3	(2) not later than the 180th day after the date the
4	City of Denison receives a written petition from a landowner
5	requesting annexation that the city does not grant.
6	(c) The petition described by Subsection (b) must:
7	(1) request annexation of land that is contiguous with
8	a boundary of the City of Denison;
9	(2) include all the land in the new district;
10	(3) include land covered by the development agreement
11	<pre>executed under Section 8359.004;</pre>
12	(4) include the landowner's consent to abide by the
13	comprehensive land use plan and development regulations as defined
14	in the development agreement; and
15	(5) if the development agreement for the land included
16	in the new district expires before a new district is created under
17	Section 8359.108, include the landowner's consent to reinstate the
18	comprehensive land use plan and development regulations defined in
19	the expired development agreement.
20	Sec. 8359.004. DEVELOPMENT AGREEMENT REQUIRED. The
21	temporary directors may not hold an election under Section 8359.003
22	until the City of Denison and the owners of the land to be covered by
23	a development agreement that covers all or part of the land in the
24	district enter into the development agreement under Chapter 212,
25	Local Government Code.
26	Sec. 8359.005. FINDINGS OF PUBLIC PURPOSE AND BENEFIT. (a)
27	The district is created to serve a public purpose and benefit.

No. 2533 (b) All land and other property included in the district 1 will benefit from the improvements and services to be provided by 2 the district under powers conferred by Section 52, Article III, and 3 Section 59, Article XVI, Texas Constitution, and under this 4 5 chapter. (c) The district is created to accomplish the purposes of: 6 7 (1) a municipal utility district as provided by general law and Section 59, Article XVI, Texas Constitution; and 8 (2) Section 52, Article III, Texas Constitution, that 9 relate to the construction, acquisition, improvement, operation, 10 or maintenance of macadamized, graveled, or paved roads, or 11 12 improvements, including storm drainage, in aid of those roads. Sec. 8359.006. INITIAL DISTRICT TERRITORY. (a) The 13 14 district is initially composed of the territory described by Section 2 of the Act creating this chapter. 15 16 (b) The boundaries and field notes contained in Section 2 of 17 the Act creating this chapter form a closure. A mistake made in the field notes or in copying the field notes in the legislative process 18 19 does not affect the district's: (1) organization, existence, or validity; 20 21 (2) right to issue any type of bond for the purposes 22 for which the district is created or to pay the principal of and 23 interest on a bond; 24 (3) right to impose a tax or assessment; or 25 (4) legality or operation. 26 Sec. 8359.007. ELIGIBILITY FOR INCLUSION IN TAX INCREMENT REINVESTMENT ZONE. (a) All or any part of the district is eligible 27

No. 2533 to be included in a tax increment reinvestment zone created under 1 Chapter 311, Tax Code. 2 (b) If the City of Denison creates a tax increment 3 reinvestment zone described by Subsection (a) that includes all or 4 part of the territory of the district, the City of Denison and the 5 6 board of directors of the zone, by contract with the district, may 7 grant money to the district to be used for a permissible purpose of a corporation under Section 380.002(b), Local Government Code, 8 including the right to pledge the money as security for a bond 9 10 issued by the district. [Sections 8359.008-8359.050 reserved for expansion] 11 12 SUBCHAPTER B. BOARD OF DIRECTORS Sec. 8359.051. GOVERNING BODY; TERMS. (a) The district is 13 14 governed by a board of five elected directors. 15 (b) Except as provided by Section 8359.052, directors serve staggered four-year terms. 16 17 Sec. 8359.052. TEMPORARY DIRECTORS. (a) The temporary board consists of: 18 19 (1) Ben Munson; 20 (2) <u>Gifford Jackson;</u> 21 (3) Robert Vaughn; (4) Denice Lucas; and 2.2 23 (5) Patrick O'Toole. 24 (b) Temporary directors serve until the earlier of: (1) the date permanent directors are elected under 25 26 Section 8359.003; or 27 (2) September 1, 2013.

No. 2533 (c) If permanent directors have not been elected under 1 Section 8359.003 and the terms of the temporary directors have 2 expired, successor temporary directors shall be appointed or 3 reappointed as provided by Subsection (d) to serve terms that 4 5 expire on the earlier of: 6 (1) the date permanent directors are elected under Section 8359.003; or 7 8 (2) the fourth anniversary of the date of the appointment or reappointment. 9 10 (d) If Subsection (c) applies, the owner or owners of a majority of the assessed value of the real property in the district 11 12 may submit a petition to the Texas Commission on Environmental Quality requesting that the commission appoint as successor 13 14 temporary directors the five persons named in the petition. The 15 commission shall appoint as successor temporary directors the five persons named in the petition. 16 17 [Sections 8359.053-8359.100 reserved for expansion] SUBCHAPTER C. POWERS AND DUTIES 18 Sec. 8359.101. GENERAL POWERS AND DUTIES. The district has 19 the powers and duties necessary to accomplish the purposes for 20 which the district is created. 21 Sec. 8359.102. MUNICIPAL UTILITY DISTRICT POWERS 22 AND DUTIES. The district has the powers and duties provided by the 23 24 general law of this state, including Chapters 49 and 54, Water Code, applicable to municipal utility districts created under Section 59, 25 26 Article XVI, Texas Constitution. 27 Sec. 8359.103. AUTHORITY FOR ROAD PROJECTS. Under Section

1 52, Article III, Texas Constitution, the district may design, 2 acquire, construct, finance, issue bonds for, improve, operate, 3 maintain, and convey to this state, a county, or a municipality for operation and maintenance macadamized, graveled, or paved roads, or 4 5 improvements, including storm drainage, in aid of those roads. 6 Sec. 8359.104. ROAD STANDARDS AND REQUIREMENTS. (a) A road 7 project must meet all applicable construction standards, zoning and 8 subdivision requirements, and regulations of each municipality in whose corporate limits or extraterritorial jurisdiction the road 9 10 project is located. (b) If <u>a road project is not located in the corporate limits</u> 11 or extraterritorial jurisdiction of a municipality, the road 12 project must meet all applicable construction standards, 13 subdivision requirements, and regulations of each county in which 14 the road project is located. 15 (c) If the state will maintain and operate the road, the 16 17 Texas Transportation Commission must approve the plans and specifications of the road project. 18 19 Sec. 8359.105. COMPLIANCE WITH MUNICIPAL CONSENT ORDINANCE OR RESOLUTION. (a) The district shall comply with all applicable 20 requirements of an ordinance or resolution adopted by the City of 21 Denison in accordance with Section 54.016 or 54.0165, Water Code, 22 23 that consents to the creation of the district or to the inclusion of land in the district. The ordinance or resolution of the City of 24 Denison consenting to the creation of the district may limit the 25 26 amount of the district's bonds and tax rate. 27 (b) The ordinance or resolution of the City of Denison

1 consenting to the inclusion of additional land in the district may 2 be conditioned on the additional land being covered by the 3 development agreement executed under Section 8359.004. 4 (c) The consent ordinance or resolution of the City of 5 Denison may not impose a restriction or condition not expressly provided under Section 54.016(f), Water Code, on a new district 6 7 created under Section 8359.108 or on the inclusion of land in the 8 new district. A restriction or condition on the creation of a new district under Section 8359.108 or the inclusion of land in a new 9 10 district may not: (1) limit the amount of the new district's bonds or tax 11 12 rate; or (2) restrict the purposes authorized by this chapter 13 14 for which the new district may issue bonds. Sec. 8359.106. ANNEXATION. (a) Before the district holds 15 an election under Section 8359.003, the district may annex: 16 17 (1) without the consent of the City of Denison, land previously owned by the United States Army Corps of Engineers; or 18 19 (2) in accordance with Section 54.016, Water Code, land located in the extraterritorial jurisdiction or corporate 20 21 limits of the City of Denison if the City of Denison has consented 22 by ordinance or resolution to the annexation. (b) The district may not annex land located outside the 23 24 corporate limits and extraterritorial jurisdiction of the City of 25 Denison. 26 Sec. 8359.107. EFFECT OF ANNEXATION BY CITY OF DENISON. (a) The City of Denison may annex part of the district into its 27

No. 2533 1 corporate limits without annexing the entire district under the terms of a development agreement executed under Section 8359.004 2 between the City of Denison and the owners of the land in the 3 district that is covered by the development agreement. If a 4 5 development agreement is not executed under Section 8359.004 or the agreement has expired, nothing in this chapter limits the right of 6 7 the City of Denison to annex the district. (b) If the City of Denison annexes all or part of the 8 district into its corporate limits: 9 10 (1) the district is not dissolved; 11 (2) the ability of the district to issue bonds is not 12 impaired or precluded; and (3) unless otherwise approved by the board and the 13 14 governing body of the City of Denison, the city: 15 (A) may not take over the property or other 16 assets of the district; 17 (B) may not assume any debts, liabilities, or other obligations of the district; 18 19 (C) is not obligated to perform any functions of 20 the district; and 21 (D) is not obligated to pay a landowner or developer for expenses incurred by the landowner or developer in 22 connection with the district that would otherwise be eligible for 23 24 reimbursement from the proceeds of bonds issued by the district. (c) Notwithstanding Section 54.016(f)(2), Water Code, an 25 26 allocation agreement between the City of Denison and the district that provides for the allocation of the taxes or revenues of the 27

No. 2533 district and the city following the date of inclusion of all the 1 2 district's territory in the corporate limits of the city may 3 provide that the total annual ad valorem taxes collected by the city and the district from taxable property in the district may exceed 4 5 the city's ad valorem tax on that property. 6 Sec. 8359.108. DIVISION OF DISTRICT. (a) The district may 7 be divided into two or more new districts only if the district: 8 (1) has no outstanding bonded debt; and 9 is not imposing ad valorem taxes. (2) 10 (b) This chapter applies to any new district created by the division of the district, and a new district has all the powers and 11 12 duties of the district. 13 (c) Any new district created by the division of the district 14 may, at the time the new district is created, contain only: 15 (1) land within the area described by Section 2 of the Act creating this chapter; 16 17 (2) any land previously owned by the United States Army Corps of Engineers; and 18 19 (3) any land adjacent to the area described by Section 2 of the Act creating this chapter if that adjacent land is within 20 the extraterritorial jurisdiction of the City of Denison and if 21 22 that adjacent land has been approved for inclusion in the district under the consent ordinance or resolution adopted by the City of 23 24 Denison under Section 8359.105. (d) The board, on its own motion or on receipt of a petition 25 26 signed by the owner or owners of a majority of the assessed value of 27 the real property in the district, may adopt an order dividing the

No. 2533 1 district. 2 (e) The board may adopt an order dividing the district only after the date the board holds an election under Section 8359.003 to 3 confirm the district's creation. 4 5 (f) An order dividing the district must: 6 (1) name each new district; 7 (2) include the metes and bounds description of the territory of each new district; 8 9 (3) appoint temporary directors for each new district; 10 and (4) provide for the division of assets and liabilities 11 12 between or among the new districts. (g) On or before the 30th day after the date of adoption of 13 an order dividing the district, the district shall file the order 14 15 with the Texas Commission on Environmental Quality and record the order in the real property records of each county in which the 16 17 district is located. 18 (h) Any new district created by the division of the district 19 shall hold a confirmation and directors' election as required by 20 Section 8359.003. 21 (i) Municipal consent by the City of Denison is not required 22 for the creation of any new district created under this section. 23 (j) Any new district created by the division of the district 24 must hold an election as required by this chapter to obtain voter approval before the district may impose a maintenance tax or issue 25 26 bonds payable wholly or partly from ad valorem taxes. (k) If the voters of a new district do not confirm the 27

1 creation of the new district, the assets, obligations, territory, 2 and governance of the new district revert to that of the original 3 district. 4 Sec. 8359.109. DISSOLUTION OF DISTRICT. The district may 5 be dissolved by ordinance or resolution of the governing body of the City of Denison after the date on which at least 95 percent of the 6 7 infrastructure authorized by this chapter and the Water Code to 8 serve full development in the district has been completed. On dissolution, the City of Denison shall: 9 10 (1) take over the property and other assets of the district; 11 12 (2) assume all debts, liabilities, or other obligations of the district; 13 14 (3) perform the functions of the district; and 15 (4) pay any landowner or developer for costs and expenses incurred by the landowner or developer in connection with 16 17 the district that would otherwise be eligible for reimbursement from the proceeds of bonds issued by the district. 18 19 Sec. 8359.110. LIMITATION ON USE OF EMINENT DOMAIN. The district may not exercise the power of eminent domain outside the 20 district to acquire a site or easement for: 21 (1) a road project authorized by Section 8359.103; or 22 (2) a recreational facility as defined by Section 23 24 49.462, Water Code. [Sections 8359.111-8359.150 reserved for expansion] 25 26 SUBCHAPTER D. GENERAL FINANCIAL PROVISIONS 27 Sec. 8359.151. ELECTIONS REGARDING TAXES OR BONDS. (a) The

5	(b) The district must hold an election in the manner

9	(c) The district may not issue bonds payable from ad valorem
10	taxes to finance a road project unless the issuance is approved by a
11	vote of a two-thirds majority of the district voters voting at an
12	election held for that purpose.
13	Sec. 8359.152. OPERATION AND MAINTENANCE TAX. (a) If
14	authorized at an election held under Section 8359.151, the district
15	may impose an operation and maintenance tax on taxable property in
16	the district in accordance with Section 49.107, Water Code.
17	(b) The board shall determine the tax rate. The rate may not
18	exceed the rate approved at the election.
19	Sec. 8359.153. CONTRACT TAXES. (a) In accordance with
20	Section 49.108, Water Code, the district may impose a tax other than
21	an operation and maintenance tax and use the revenue derived from
22	the tax to make payments under a contract after the provisions of
23	the contract have been approved by a majority of the district voters
24	voting at an election held for that purpose.
25	(b) A contract approved by the district voters may contain a
26	provision stating that the contract may be modified or amended by
27	the board without further voter approval.

## 1 [Sections 8359.154-8359.200 reserved for expansion] SUBCHAPTER E. BONDS AND OTHER OBLIGATIONS 2 Sec. 8359.201. AUTHORITY TO ISSUE BONDS AND OTHER 3 OBLIGATIONS. The district may issue bonds or other obligations 4 payable wholly or partly from ad valorem taxes, impact fees, 5 revenue, contract payments, grants, or other district money, 6 revenue from a tax increment reinvestment zone created under 7 8 Chapter 311, Tax Code, revenue from economic development agreements under Chapter 380, Local Government Code, or any combination of 9 10 those sources, to pay for any authorized district purpose. Sec. 8359.202. TAXES FOR BONDS. At the time the district 11 12 issues bonds payable wholly or partly from ad valorem taxes, the board shall provide for the annual imposition of a continuing 13 direct ad valorem tax, without limit as to rate or amount, while all 14 or part of the bonds are outstanding as required and in the manner 15 provided by Sections 54.601 and 54.602, Water Code. 16

17 <u>Sec. 8359.203. BONDS FOR ROAD PROJECTS. At the time of</u> 18 <u>issuance, the total principal amount of bonds or other obligations</u> 19 <u>issued or incurred to finance road projects and payable from ad</u> 20 <u>valorem taxes may not exceed one-fourth of the assessed value of the</u> 21 <u>real property in the district.</u>

1 Act, has been published as provided by law, and the notice and a 2 copy of this Act have been furnished to all persons, agencies, 3 officials, or entities to which they are required to be furnished 4 under Section 59, Article XVI, Texas Constitution, and Chapter 313, 5 Government Code.

6 (b) The governor, one of the required recipients, has 7 submitted the notice and Act to the Texas Commission on 8 Environmental Quality.
