## **Fiscal Analysis**

ARTICLE 1 of the bill would amend the Occupations Code to prohibit a licensing authority to issue an occupational license, certificate, registration, permit, or other authorization unless an applicant establishes employment eligibility. The applicant would establish employment eligibility by providing an original or a copy of one or two documents specific documents, or a document verifying that the applicant provided to their current or most recent employer a true and correct Form I-9 along with authentic supporting documents.

Each licensing agency would need to adopt the necessary rules not later than January 1, 2010 and the article would apply only to an application for the issuance or renewal of a license filed with a licensing authority on or after March 1, 2010.

ARTICLE 2 of the bill would amend the Transportation Code to direct the Department of Public Safety (DPS) to require each applicant for an original, renewal, or duplicate driver's license, commercial driver's license, or identification certificate to furnish proof of U.S. citizenship, or documents issued by the U.S. agency responsible for authorizing the person to be in the U.S. A license or identification certificate could not be issued to a person who failed or refused to comply with the requirements, or whose lawful admission period in the U.S. expired before the 180th day after the application date.

DPS would set by rule the fee for a driver's license, including a commercial driver's license or commercial driver learner's permit, or a personal identification certificate, issued to a person not a citizen of the U.S. in an amount not to exceed the fee amount otherwise imposed in Subchapter R of Chapter 521, or that exceed actual costs to DPS of issuing the license or certificate.

A drivers license would have to include a statement as to whether the person was a citizen of the U.S., and DPS would maintain an index of the citizenship status for each holder of a license or personal identification certificate. These changes would apply only to licenses issued on or after the effective date of the bill.

## Methodology

It is assumed that the licensing agencies in Article 8 of the General Appropriations Act would adjust license fees to cover any additional costs associated with the implementation of this bill.

Based on information provided by the Article 8 agencies listed below, it is assumed staff costs would include: \$1,547,000 for 46.0 full-time-equivalent positions (FTEs) in fiscal year 2010; \$1,560,000 for 43.3 FTEs in fiscal year 2011; \$1,367,000 for 38.0 FTEs in fiscal year 2012, and \$1,267,000 for 34.0 FTEs in each fiscal year from 2013 to 2014.

By administrative rule DPS currently requires proof of lawful presence before issuing a drivers license to non-citizens.

It is assumed that the Private Security Board (PSB) within DPS would need to have the employment eligibility verified for all original and renewal licensing applicants. It is also assumed that DPS would incur costs to update drivers licenses with a citizenship field and to update licensing applications. It is estimated that these costs would be absorbed by DPS.

It is assumed there would be costs associated with this bill for other state agencies that are not listed below, but that these costs could be absorbed within existing agency resources.

## Technology

Technology costs, including programming costs and the purchase of necessary hardware and software for several agencies, are estimated to be: \$164,000 in fiscal year 2010; \$22,000 in fiscal year 2011; and \$16,000 in each fiscal year from 2012 to 2014.

# Local Government Impact

No significant fiscal implication to units of local government is anticipated.
