5	Code, is amended by amending Subdivisions (3), (7), and (8) and
6	adding Subdivisions $(5-a)$, $(7-a)$, and $(8-a)$ to read as follows:
7	(3) "Customer" means a wholesale or direct retail user
8	of water, wastewater, or other services provided by the district.
9	(5-a) "Enterprise fund" means a fund used to account

11	(A) that are financed and operated in a manner
12	similar to a private business enterprise and for which the intent of
13	the board is that the costs, including depreciation, of providing
14	goods or services to the public on a continuing basis be financed or
15	recovered primarily through user charges; or

17	determination of revenues earned, expenses incurred, or net income
18	earned is appropriate for capital maintenance, public policy,
19	management control, accountability, or other purposes.

- 2 (7-a) "Operating unit" means a separately run unit
- 3 established by action of the board that runs as an enterprise fund

- 8 (A) provides utility service inside the

- 5 Code, is amended to read as follows:
- 6 Sec. 7208.005. DISTRICT TERRITORY. [(a)] The boundaries
- 7 of the district are coextensive with the boundaries of Parker
- 8 County [is composed of the territory described by Section 1.04,
- 9 Chapter 1273, Acts of the 75th Legislature, Regular Session, 1997,
- 10 as that territory may have been modified under:
- [(1) Subchapter B or its predecessor statutes,
- 12 Sections 2.17 and 6.01, Chapter 1273, Acts of the 75th Legislature,
- 13 Regular Session, 1997;
- 14 [(2) Subchapter J, Chapter 49, Water Code;

- 18 [(b) The boundaries and field notes of the district form a

- 25 SECTION 4. Section 7208.116, Special District Local Laws
- 26 Code, is amended to read as follows:
- Sec. 7208.116. CUSTOMER ADVISORY COUNCILS [COUNCILS]. (a)

- 1 For each operating unit, the [The] board may establish a customer
- 2 advisory council that consists of one representative of each
- 3 wholesale customer or retail unit of the district.
- 4 (b) For each retail unit, the board may establish a customer
- 5 advisory council that consists of five members appointed by the
- 6 retail customers of the unit in accordance with the laws applicable
- 7 to and rules of the district. An advisory council member must
- 8 reside in the service area of the retail unit.
- 9 (c) (b) A representative serving on \underline{a} [the] customer
- 10 advisory council:
- 11 (1) has the powers and duties provided in the bylaws
- 12 and rules of the district; and
- 13 (2) may not vote on any matter considered by the board.
- 14 (d) (c) The board may abolish \underline{a} (the) customer advisory

- SECTION 5. Section 7208.154, Special District Local Laws
- 17 Code, is amended to read as follows:
- 18 Sec. 7208.154. GENERAL WASTE AND WATER POWERS. The
- 19 district may:
- 20 (1) provide for:
- 21 (A) the collection, construction, improvement,
- 22 maintenance, and operation of wholesale or retail wastewater and
- 23 water systems and treatment works necessary to provide wholesale or
- 24 <u>retail</u> service to customers; and
- 25 (B) the acquisition, construction, improvement,
- 26 and maintenance of a water supply or reservoir, or an interest in a
- 27 water supply or reservoir, necessary to exercise and fulfill the

- 1 powers and duties of the district;
- 2 (2) supply water for municipal, domestic, and
- 3 industrial or other beneficial uses or controls;
- 4 (3) collect, treat, process, dispose of, and control
- 5 all domestic or industrial wastes, whether in fluid, solid, or
- 6 composite state;
- 7 (4) gather, conduct, divert, control, and treat local
- 8 storm water or local harmful excesses of water in the district; and
- 9 (5) irrigate and alter land elevations in the district
- 10 as needed.
- 11 SECTION 6. The heading to Section 7208.157, Special
- 12 District Local Laws Code, is amended to read as follows:
- 13 Sec. 7208.157. CONTRACTS WITH DISTRICT FOR WATER,
- 14 WASTEWATER, AND OTHER UTILITY SERVICES.
- 15 SECTION 7. Sections 7208.157(a), (b), and (c), Special
- 16 District Local Laws Code, are amended to read as follows:
- 17 (a) Except as provided by Subsection (b), this chapter does
- 18 not require a customer or prospective customer of the district to
- 19 secure water, wastewater, or other utility service from the
- 20 district unless the customer or prospective customer contracts with
- 21 the district for that purpose.
- (b) A customer or prospective customer is required to secure
- 23 water, wastewater, or other utility service from the district if:
- 24 (1) the customer or prospective customer is not
- 25 receiving the service from another source; and
- 26 (2) the district provides the service or determines
- 27 that the district will make the service available to the customer or

- 1 prospective customer.
- 2 (c) If a customer contracts with the district to secure
- 3 water, wastewater, or other utility service from the district, a
- 4 user of the service under the contract must connect to the
- 5 district's service system if:
- 6 (1) the user is located inside the boundaries of the
- 7 customer; and
- 8 (2) the district's system is available for connection
- 9 at or near the property line of the user.
- 10 SECTION 8. Section 7208.201, Special District Local Laws
- 11 Code, is amended to read as follows:
- 12 Sec. 7208.201. AUDITS. All funds and accounts of the
- 13 district shall be audited annually by an independent auditor. The
- 14 district shall maintain a copy of the audit in the district's
- 15 official records.
- SECTION 9. (a) The legal notice of the intention to
- 17 introduce this Act, setting forth the general substance of this
- 18 Act, has been published as provided by law, and the notice and a
- 19 copy of this Act have been furnished to all persons, agencies,
- 20 officials, or entities to which they are required to be furnished
- 21 under Section 59, Article XVI, Texas Constitution, and Chapter 313,
- 22 Government Code.
- 23 (b) The governor has submitted the notice and Act to the
- 24 Texas Commission on Environmental Quality.
- 25 (c) The Texas Commission on Environmental Quality has filed
- 26 its recommendations relating to this Act with the governor,
- 27 lieutenant governor, and speaker of the house of representatives

- 1 within the required time.
- 2 (d) All requirements of the constitution and laws of this
- 3 state and the rules and procedures of the legislature with respect
- 4 to the notice, introduction, and passage of this Act are fulfilled
- 5 and accomplished.
- 6 SECTION 10. This Act takes effect immediately if it
- 7 receives a vote of two-thirds of all the members elected to each
- 8 house, as provided by Section 39, Article III, Texas Constitution.
- 9 If this Act does not receive the vote necessary for immediate
- 10 effect, this Act takes effect September 1, 2009.
