- 2 relating to the offense of coercing a person to have or seek an
- 3 abortion and informed and voluntary consent for an abortion;
- 4 providing penalties.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. The heading to Subchapter B, Chapter 171, Health
- 7 and Safety Code, is amended to read as follows:
- 8 SUBCHAPTER B. VOLUNTARY AND INFORMED CONSENT
- 9 SECTION 2. Section 171.018, Health and Safety Code, is
- 10 amended to read as follows:
- 11 Sec. 171.018. OFFENSE. A physician who intentionally
- 12 performs an abortion on a woman in violation of <u>Section 171.011</u>
- 13 [this subchapter] commits an offense. An offense under this
- 14 section is a misdemeanor punishable by a fine not to exceed \$10,000.
- 15 In this section, "intentionally" has the meaning assigned by
- 16 Section 6.03(a), Penal Code.
- SECTION 3. Subchapter B, Chapter 171, Health and Safety
- 18 Code, is amended by adding Sections 171.019, 171.020, 171.021,
- 19 171.022, and 171.023 to read as follows:
- 20 Sec. 171.019. PREVENTION OF COERCED ABORTIONS. (a) Before
- 21 any anaesthesia or sedative is given to a woman prior to the
- 22 performance of an abortion, a physician shall:
- 23 (1) verbally inform the woman on whom the abortion is
- 24 to be performed that a person cannot coerce or force her to have or

1	seek an abortion and that the physician cannot perform the abortion
2	unless the woman provides her voluntary and informed consent; and
3	(2) provide the woman on whom the abortion is to be
4	performed with the coerced abortion form described by Section
5	<u>171.021:</u>
6	(A) in both English and Spanish; and
7	(B) in a language other than English or Spanish,
8	if applicable, under Section 171.021(c).
9	(b) A physician may not perform an abortion on a woman
10	unless, before the abortion, the woman certifies on the coerced
11	abortion form described by Section 171.021 that she received from
12	the physician the information and materials required by Subsection
13	<u>(a).</u>
14	(c) If the woman indicates on the coerced abortion form or
15	communicates to the physician that she is being coerced or forced to
16	have or seek an abortion or the physician is otherwise made aware
17	that the woman has indicated that she is being coerced or forced to
18	have or seek an abortion, the physician:
19	(1) shall report an offense under Section 25.12, Penal
20	<pre>Code, to local law enforcement;</pre>
21	(2) shall provide the referral required by Section
22	<u>171.020(2);</u>
23	(3) shall provide the woman with access to a telephone
24	in a private room; and
25	(4) may not perform the abortion until:
26	(A) 48 hours have elapsed:
27	(i) since the woman last communicated to

1 the physician, through the form or otherwise, that the woman was being coerced or forced to have or seek an abortion; or 2 (ii) to the best of the physician's 3 knowledge, since the woman last communicated to an agent of the 4 5 physician that the woman was being coerced or forced to have or seek an abortion; and 6 7 (B) the woman provides her voluntary and informed 8 consent that the woman states is not a result of coercion. 9 (d) A person who is a volunteer for or an employee of a 10 physician or an office or facility at which abortions are performed shall immediately notify the physician who is to perform an 11 12 abortion on a woman if the woman communicates to the person that the 13 woman is being coerced or forced to have or seek an abortion. Sec. 171.020. REFERRAL TO DOMESTIC VIOLENCE ASSISTANCE. 14 15 The department shall require each physician who performs an 16 abortion to: 17 (1) maintain a list of domestic violence shelters and assistance programs that do not: 18 19 (A) provide abortions or abortion-related 20 services; 21 (B) make referrals to abortion providers; or 22 (C) affiliate or contract with entities that: (i) provide abortions or abortion-related 23 24 services; or 25 (ii) make referrals to abortion providers; 26 and

(2) provide a refer<u>ral to a domestic violence shelter</u>

- 1 or assistance program that does not provide or refer for abortions
- 2 if the woman seeking an abortion communicates to the facility, the
- 3 physician, or an agent of the physician who is performing the
- 4 abortion that the woman is being abused or is being coerced or
- 5 forced to have or seek the abortion.
- 6 Sec. 171.021. CONTENTS OF FORM. (a) The department shall
- 7 develop a coerced abortion form to be completed by each woman on
- 8 whom an abortion is performed in this state. The form must include:
- 9 (1) the following title centered on the page in
- 10 boldfaced capital letters in 26-point font or larger: "NOTICE";
- 11 (2) the following statement printed in 16-point font
- 12 or larger: "It is against the law for a person, regardless of that
- 13 person's relationship to you, to coerce or force you to have or seek
- 14 an abortion. By law, a physician cannot perform an abortion,
- 15 including inducing, prescribing for, or otherwise providing the
- 16 means for an abortion, unless you give your voluntary and informed
- 17 consent without coercion or force. It is against the law for a
- 18 physician to perform an abortion against your will. You have the
- 19 right to a telephone in a private room to contact any local or state
- 20 law enforcement agency to receive protection from any actual or
- 21 threatened physical abuse or violence.";
- 22 (3) the following statements printed in 14-point font
- 23 or larger followed by spaces for the woman to initial:
- 24 (A) "I understand that I have the right to access
- 25 a telephone in a private room to contact a local or state law
- 26 enforcement agency to receive protection from any actual or
- 27 threatened physical abuse or violence.";

- 1 (B) "I have been informed in person that no one
- 2 can coerce or force me to have or seek an abortion and that an
- 3 abortion cannot be provided to me unless I provide my freely given,
- 4 voluntary, and informed consent."; and
- 5 (C) "I have read the above notice and understand
- 6 that I have legal protection against being coerced or forced to have
- 7 or seek an abortion.";
- 8 (4) spaces for the signature of the woman on whom an
- 9 abortion is to be performed and the date the form was completed; and
- 10 (5) spaces for the license number, area of specialty,
- 11 and signature of the physician who performed the abortion.
- 12 (b) The department shall provide the form required by
- 13 Subsection (a) in both English and Spanish.
- 14 (c) If the department determines that a substantial number
- 15 of residents in this state speak a primary language other than
- 16 English or Spanish, the department shall provide the form required
- 17 by Subsection (a) in that language. The department shall instruct a
- 18 facility that provides abortions to provide the coerced abortion
- 19 form in a language other than English or Spanish if the department
- 20 determines that a substantial number of residents in the area speak
- 21 <u>a primary language other than English or Spanish.</u>
- 22 <u>Sec. 171.022. PROVISION AND RETENTION OF COERCED ABORTION</u>
- 23 FORM. (a) The department shall provide a copy of this section and
- 24 Sections 171.019-171.021 and the coerced abortion form required by
- 25 Section 171.019 to:
- 26 (1) a physician who becomes newly licensed to practice
- 27 in this state, not later than the 30th day after the date the

- 1 physician receives the license; and
- 2 (2) all physicians licensed to practice in this state,
- 3 not later than December 1 of each year.
- 4 (b) A copy of the coerced abortion form certified by the
- 5 woman shall be placed in the woman's medical file and kept until at
- 6 least the seventh anniversary of the date on which the form was
- 7 signed or, if the woman is a minor, at least until the date the woman
- 8 reaches 20 years of age, whichever is later.
- 9 (c) The woman on whom an abortion is performed shall be
- 10 given a copy of the completed coerced abortion form in person before
- 11 the woman leaves the facility where the abortion is performed.
- 12 Sec. 171.023. SIGN POSTING. (a) An office or facility at
- 13 which abortions are performed shall post the following sign:
- 14 "NOTICE: It is against the law for a person, regardless of that
- 15 person's relationship to you, to coerce or force you to have or seek
- 16 an abortion. By law, a physician cannot perform an abortion,
- 17 including inducing, prescribing for, or otherwise providing the
- 18 means for an abortion, unless you give your voluntary and informed
- 19 consent without coercion or force. It is against the law for a
- 20 physician to perform an abortion against your will. You have the
- 21 right to a telephone in a private room to contact any local or state
- 22 law enforcement agency to receive protection from any actual or
- 23 threatened physical abuse or violence.".
- 24 (b) The sign described by Subsection (a) must be:
- 25 (1) printed with lettering that is legible and in at
- 26 least two-inch boldfaced type; and
- 27 (2) printed and posted in both English and Spanish, as

- 1 well as any language other than English or Spanish if it is likely
- 2 that a substantial number of the residents in the area speak a
- 3 language other than English or Spanish as their familiar language.
- 4 (c) An office or facility at which abortions are performed
- 5 shall conspicuously post the sign described by Subsection (a) in
- 6 each patient waiting room and each patient consultation room
- 7 regularly used by patients seeking abortions.
- 8 (d) If requested by a patient, the office or facility shall
- 9 provide the patient:
- 10 (1) a paper copy of the sign described by Subsection
- 11 (a) in the language preferred by the patient; and
- 12 (2) access to a telephone in a private room.
- 13 SECTION 4. Chapter 6, Code of Criminal Procedure, is
- 14 amended by adding Article 6.10 to read as follows:
- Art. 6.10. REPORTS OF COERCION OF ABORTION. A peace officer
- 16 who receives a report of or other information indicating the
- 17 commission or attempted commission of an alleged offense under
- 18 Section 25.12, Penal Code, shall file a police report as necessary
- 19 to ensure that law enforcement may investigate the alleged offense.
- 20 SECTION 5. Chapter 25, Penal Code, is amended by adding
- 21 Section 25.12 to read as follows:
- Sec. 25.12. COERCION OF ABORTION. (a) A person commits an
- 23 offense if the person uses coercion to induce a pregnant woman to
- 24 have or seek an abortion.
- 25 (b) An offense under this section is a Class B misdemeanor.
- 26 (c) A person who in good faith reports to law enforcement
- 27 authorities a suspected offense under Subsection (a) is immune from

- 1 civil liability in an action brought against the person for
- 2 reporting the suspected offense.
- 3 SECTION 6. (a) Not later than December 1, 2011, the
- 4 Department of State Health Services shall develop and make
- 5 available the form required by Subchapter B, Chapter 171, Health
- 6 and Safety Code, as amended by this Act, along with instructions for
- 7 completing the form.
- 8 (b) Not later than December 1, 2011, the Department of State
- 9 Health Services shall develop and make available the sign required
- 10 by Section 171.023, Health and Safety Code, as added by this Act.
- 11 (c) Not later than January 1, 2012, the Department of State
- 12 Health Services shall distribute forms as required by Section
- 13 171.022(a), Health and Safety Code, as added by this Act.
- 14 SECTION 7. This Act takes effect on the 91st day after the
- 15 last day of the legislative session.
