

HOUSE CONCURRENT RESOLUTION

1 WHEREAS, The baseball team of Brazoswood High School in Clute
2 won the University Interscholastic League 5A state championship on
3 June 11, 2011, at the Dell Diamond in Round Rock, capping a
4 spectacular season and giving its school its third state baseball
5 title; and

6 WHEREAS, The Buccaneers came to epitomize teamwork,
7 dedication, and skill as they finished their year with a 34-8
8 record; although they were considered the underdog in games against
9 powerhouse teams from Houston Lamar, Houston Memorial, and Klein
10 High Schools in postseason competition, they bested both Lamar and
11 Memorial without losing a single game and pulled off a dramatic
12 come-from-behind win in the state tournament semifinals against
13 Klein; they went on to dominate every inning in their 10-3
14 championship game against Lubbock Coronado to complete the playoffs
15 with 12 straight victories; and

16 WHEREAS, Many on the Brazoswood team had played together for
17 11 years, always with the dream of making it to the state
18 tournament; in a gesture reflecting their determined focus, they
19 had written "State 2011" on the inside of their caps to remind them
20 daily of their goal; and

21 WHEREAS, A group that emphasized solid baseball fundamentals
22 and hard work, the Buccaneers benefited from the contributions of
23 each individual player, with someone different stepping up to
24 deliver a game-changing performance in every contest; and

1 WHEREAS, The Brazoswood team was encouraged all season long
2 by a tremendous outpouring of community support, with everyone from
3 87-year-old grandmothers to excited classmates chanting "We are
4 B'Wood" throughout every inning; and

5 WHEREAS, Buccaneers who were honored for their fine play in
6 the state tournament are William Renner, who earned the Most
7 Valuable Player award, and Brandon Bergen, William Easter, Dalton
8 Perry, and James Cantu, who were also named to the All-Tournament
9 team; and

10 WHEREAS, Throughout the season, the Buccaneers received an
11 outstanding effort from each member of the roster, which also
12 included Eddie Esquivel, Jacob Reed, Jorge Gonzalez, Scott Lapier,
13 Colby Alexander, Justin Dellinger, A. J. Angelone, Ethan Stremmel,
14 Josh Ward, Blake Jones, Zak Trevino, Bobby Franklin, Evan Hundl,
15 John Ermis, Michael Pyeatt, Dominikk Mottu-Branch, Ryan Rios, and
16 Trevor Valigura; the players were guided by head coach Bobby
17 Williams, who claimed his first state title, assistant coaches Mike
18 Cressman and Josh Cathcart, junior varsity coach Chris Nabors,
19 sophomore coach David Cowley, and freshman coach Javier Solis;
20 vital support was further provided by trainers Lauren DeLaTorre,
21 Blake Lapier, Willie Caines, and Bobby Jack Caines, athletic
22 director Jesse Crow, and principal Steve Snell; and

23 WHEREAS, Achieving such a challenging goal required each of
24 the team's talented athletes to perform at the top of his game, and
25 this triumph is both a fitting culmination to the Buccaneers' many
26 years of hard work and a powerful testament to their unwavering
27 resolve and indomitable spirit; in winning the coveted state crown,

1 these young champions have distinguished themselves as formidable
2 competitors and brought recognition and an enormous sense of pride
3 to their school, as well as to the Brazosport community and all of
4 Brazoria County; now, therefore, be it

5 RESOLVED, That the 82nd Legislature of the State of Texas,
6 1st Called Session, hereby congratulate the Brazoswood High School
7 Buccaneers on winning the 2011 UIL 5A state baseball championship
8 and extend sincere best wishes to the players, coaches, and staff
9 for continued success; and, be it further

10 RESOLVED, That an official copy of this resolution be
11 prepared for the Brazoswood Buccaneers as an expression of high
12 regard by the Texas House of Representatives and Senate.
