- 18 to the sustainable use and conservation of the Gulf of Mexico; in
- 19 his role as director, he guided the institute from the planning
- 20 stages through the construction of its facility, contributed to the
- 21 development of the institute's mission and scope, and helped select
- 22 and hire its faculty and staff; he led the institute until his
- 23 retirement in 2008; and
- 24 WHEREAS, Dr. Furgason earned a bachelor's and a master's

- 1 degree in chemical engineering from the University of Idaho; he
- 2 went on to complete his Ph.D. at Northwestern University, and in
- 3 2006, the University of Idaho conferred on him an honorary
- 4 doctorate of administrative science; before becoming president of
- 5 Texas A&M--Corpus Christi, he served as vice chancellor for
- 6 academic affairs and professor of chemical engineering at the
- 7 University of Nebraska--Lincoln; and
- 8 WHEREAS, The impact of Dr. Furgason's contributions will
- 9 continue to resonate in the Coastal Bend and the Lone Star State for
- 10 years to come, and he is indeed worthy of this prestigious accolade;
