- 1 WHEREAS, Rio Grande City native Lauro L. Lopez has
- 2 distinguished himself through a lifetime of meaningful
- 3 accomplishments that have made a positive difference in the local
- 4 community and beyond; and
- 5 WHEREAS, Born on May 20, 1924, Mr. Lopez graduated from high
- 6 school in 1943 and served his country in the United States Army
- 7 during World War II; he was initially stationed at the headquarters
- 8 of General Eisenhower in England and then helped evacuate wounded
- 9 soldiers from France; after his honorable discharge from the
- 10 military, he attended The University of Texas at Austin, studying
- 11 geology, and subsequently worked in the garment industry in New
- 12 York City while pursuing a career in photography; and
- WHEREAS, Mr. Lopez returned to Rio Grande City in the early
- 14 1950s, where he held jobs selling cars and working on the Falcon Dam
- 15 project; he was employed for more than 17 years with LFD
- 16 Homefurnishings, and then decided to open his own store, Triple L
- 17 Furniture and Appliance, in 1970; he continued to oversee the
- 18 business for the next 35 years; and
- 19 WHEREAS, This esteemed Texan shared his time and talents as
- 20 the vice president of the Rio Grande Valley Partnership and as the
- 21 president of the Rio Grande City Chamber of Commerce; he was a
- 22 leader in the successful effort to reincorporate Rio Grande City in
- 23 1993, and he served two terms as a city alderman; appointed by
- 24 Governor Bush to the South Texas Workforce Development Board, he

- 1 also held a seat on the Starr County Industrial Foundation board;
- 2 moreover, he is active in the Catholic Church, as a grand knight in
- 3 the Knights of Columbus, and as a knight commander in the Order of
- 4 the Alhambra; and
- 5 WHEREAS, In all of his endeavors, Mr. Lopez enjoys the love
- 6 and support of his wife, Maria Celia S. Lopez, with whom he has
- 7 shared more than six decades of rewarding partnership; the couple
- 8 are the parents of five children, David, Daniel, Diana, Dalinda,
- 9 and Delia; and
- 10 WHEREAS, Through service to his country, state, and hometown,
- 11 Lauro Lopez has garnered the lasting respect and admiration of his
- 12 fellow citizens, and he may indeed reflect with great pride on his
- 13 many notable achievements; now, therefore, be it
