## RESOLUTION

- 1 WHEREAS, The community of Rio Grande City lost one of its most
- 2 admired residents with the passing of Lino Perez, Jr., on October
- 3 23, 2008, at the age of 94; and
- 4 WHEREAS, Descended from several Starr County pioneer
- 5 families, Mr. Perez was born to Lino Perez, Sr., and Cristina Margo
- 6 in Rio Grande City on September 19, 1914; his grandfather Ruperto
- 7 Margo and his uncle Idelfonso Hinojosa were prominent Starr County
- 8 ranchers, while his father served as both mayor and postmaster of
- 9 Rio Grande City; and
- 10 WHEREAS, Lino Perez, Jr., attended Rio Grande City High
- 11 School, where he helped to organize the school's first football
- 12 team; he served as captain and quarterback of the 1931 team, which
- 13 went undefeated and unscored upon; after graduating in 1931, he
- 14 continued his studies at Brownsville High School and then at Austin
- 15 High School in Austin, graduating as valedictorian of the AHS Class
- 16 of 1933; and
- WHEREAS, Mr. Perez had hoped to enroll at The University of
- 18 Texas, but his help was needed at home, and he returned to Rio
- 19 Grande City to assist his father with the running of the post
- 20 office; his work there was interrupted during World War II, when he
- 21 answered his country's call to duty and joined the United States
- 22 Army; and
- WHEREAS, Lino Perez succeeded his father as postmaster in
- 24 1957, and he continued to hold that position until stepping down in

- 1 1975, after 41 years' total service; during his tenure as
- 2 postmaster, he oversaw the upgrading of the Rio Grande City post
- 3 office, the initiation of city mail delivery and of rural delivery
- 4 to the whole of the county, and the expansion of the post office
- 5 staff from 4 to 15 employees; and
- 6 WHEREAS, After his retirement from the postal service,
- 7 Mr. Perez owned and operated El Bremo Ranch in La Gloria until 1989;
- 8 he also continued to serve the public, winning election to several
- 9 terms as a member of the Starr County Memorial Hospital Board of
- 10 Directors; and
- WHEREAS, A man of deep faith, Mr. Perez gave generously of his
- 12 time and talents to the Knights of Columbus, which he joined in
- 13 1935; in addition to his extensive involvement in his local
- 14 council, he held a number of statewide offices and led the Texas
- 15 organization as state deputy from 1971 to 1973; he was also a
- 16 charter member of El Cid Caravan No. 106 of the International Order
- 17 of Alhambra and the caravan's first Grand Commander; moreover, he
- 18 belonged to the Dine and Dance Club, Rotary Club, Disabled American
- 19 Veterans, and American Legion; and
- WHEREAS, Lino Perez married the love of his life, Dora Garza,
- 21 on March 1, 1937, and the couple enjoyed a rewarding union until his
- 22 passing; over the years, they became the proud parents of a
- 23 daughter, Rebecca, and three sons, Lino, Ricardo, and Carlos, and
- 24 they rejoiced as their family grew to include grandchildren and
- 25 great-grandchildren; and
- WHEREAS, Held in high esteem throughout his community, Lino
- 27 Perez could take pride in a long record of constructive endeavor,

- 1 and those who were privileged to share in the warmth of his love and
- 2 affection will forever hold him close in their hearts; now,
- 3 therefore, be it

- 6 Perez, Jr., in paying tribute to the life of this esteemed Texan;
