1           WHEREAS, A full and productive life drew to a close with the  
2 passing of George Vernon Wright, Jr., of San Antonio, on June 1,  
3 2011, at the age of 85; and

4           WHEREAS, The son of George and Clara Wright, Mr. Wright was  
5 born in St. Louis, Missouri, on October 11, 1925; he grew up in  
6 Wheatland, Missouri, and completed high school in Raleigh, North  
7 Carolina; he attended Kings Business College in Raleigh before  
8 serving his country in the United States Army in Japan during World  
9 War II; later, he attended John Brown University in Arkansas and  
10 became a territorial manager for Owens-Illinois in Texas until his  
11 retirement in 1987; he and his wife, Freida, owned the Diet Center  
12 on Bandera Road until 1993; and

13           WHEREAS, Mr. Wright served as a precinct election judge for  
14 many years, and he was a valued congregant of First Baptist Church  
15 of San Antonio; a fan of big band music and ballroom dancing, he was  
16 a member of the K Supper Club; he enjoyed dancing at its events with  
17 Mrs. Wright and always cut a fine figure in his stylish suits and  
18 wingtip shoes; blessed with a lovely voice, he often delighted  
19 those around him by singing along with ballads and hymns on the  
20 radio; his other great pleasures included gardening and watching  
21 the Fox news channel, Lawrence Welk, and British comedies, a taste  
22 he acquired from his English-born bride; and

23           WHEREAS, Charming and empathetic, George Wright brought joy  
24 to innumerable people through his warm, engaging manner; although

1 his death has deeply saddened his loved ones, he has left behind  
2 many fond memories that they will forever treasure; now, therefore,  
3 be it
