- 15 working his way through Edinburg Junior College by driving a bus;
- 16 while attending college, he met his future wife, Socorro Vera, and
- 17 the couple went on to share a loving marriage until her death;
- 18 together they were blessed with three children, Blas, Irasema, and
- 19 Ileana; and
- WHEREAS, During the course of a career in education, Judge
- 21 Chapa worked as a teacher and a principal while continuing his
- 22 studies, eventually earning a bachelor's degree from Pan American
- 23 University; he then entered politics, serving as the district clerk
- 24 of Starr County and for two terms as Starr County judge; along the
