- 1 WHEREAS, Citizens across North Texas and beyond have lost an 2 esteemed public servant with the passing of the Honorable Graham Boynton Purcell, Jr., of Wichita Falls on June 11, 2011, at the age 3 of 92; and 4 5 WHEREAS, The son of Graham and Della Key Purcell, Graham Purcell, Jr., was born and raised in Archer City; after graduating 6 from the local high school, he attended Texas A&M University and 7 served his country as a member of the U.S. Army's Horse Cavalry in 8
- 9 World War II; during his notable military tenure, he earned the rank 10 of commander of the Headquarters Company of the IV Army Corps, and 11 he was awarded the Army Silver Star for gallantry in action; and
- WHEREAS, Following his honorable discharge in 1946,

 Mr. Purcell continued his service as a member of the U.S. Army
- 14 Reserve; he resumed his studies at A&M and completed his bachelor's
- 15 degree before graduating from Baylor Law School and beginning his
- 16 legal career at firms in West Texas and Wichita Falls; and
- WHEREAS, Mr. Purcell was appointed to the 89th District Court
- 18 by Governor Allan Shivers in 1955; six years later, he was elected
- 19 to represent the 13th Congressional District in the U.S. House of
- 20 Representatives, where he served for more than a decade; a member of
- 21 the agriculture and post office committees, he also helped to
- 22 reinstate the Congressional Prayer Breakfast and was instrumental
- 23 in bringing the NATO Pilot Training Program to Sheppard Air Force
- 24 Base; and

- WHEREAS, Mr. Purcell concluded his exceptional tenure in 1 Congress in 1972 and went on to practice law as a founding partner 2 3 at Bishop, Cook, Purcell & Reynolds in Washington, D.C.; in 1988, he returned home to Texas and played an active role in the Wichita 4 5 Falls community; he and his wife, Nancy, received the Patsy Baggett Award for their efforts in behalf of children in crisis, and in 6 1993, he was recognized for his public service when the Graham 7 8 B. Purcell, Jr., Post Office and Federal Building was named in his
- WHEREAS, In all of his endeavors, Mr. Purcell was blessed with the support of his family, which eventually grew to include 8 children, 25 grandchildren, and 5 great-grandchildren; preceded in death by his first wife, Betty, he went on to share 40 years with his second wife, Nancy; and
