- 5 Church in Roma as well as the Knights of Columbus and the
- 6 International Order of the Alhambra; he continues to be involved in
- 7 bank meetings and in his ranching business; and

- 9 and support of his wife of more than 40 years, Sylvia, and he takes
- 10 pride in a fine family that includes three children, Martin
