WHEREAS, Born in Lafayette, Louisiana, on May 1, 1940,

5 Mr. Leger began working at the age of 10, delivering both the

6 morning and evening newspapers; he embarked on a 50-year career

7 with Don's Seafood and Steakhouse as a 12-year-old busboy at the

8 Lafayette restaurant; graduating from Lafayette High School, he

9 served his country in the United States Marine Corps for six years

10 before returning to Don's Seafood as kitchen manager; and

11 WHEREAS, Mr. Leger moved to the restaurant's Baton Rouge

12 location as a kitchen manager and then opened a Don's in Shreveport

in 1965; three years later, he built a new Don's Seafood in Beaumont

14 and was both a working partner and manager; the restaurant became

15 one of the city's most successful establishments and Mr. Leger

16 received numerous accolades; in 1974, he was named Outstanding

17 Restaurateur Sabine Area Chapter by the Texas Restaurant

18 Association, and in 1997, the Texas Restaurant Association inducted

19 him into its Hall of Honor; he retired from the business in 2002 and

20 then worked for six years at Kymoco Signs and Graphics; and

21 WHEREAS, For more than four decades, Mr. Leger was an active

22 member of the Sabine Area Restaurant Association, and he served as

its president in 1979; he was a founding member of the Taste of the

24 Triangle and served as chair and honorary chair, and SARA dedicated

- 2 community events, including fund-raisers for the Young Men's
- 3 Business League, the Greater Beaumont Chamber of Commerce, the City
- 4 of Beaumont, the Fire Museum of Texas, and Boys' Haven; famous for
- 5 his gumbo, he estimated, with characteristic humor, that he had
- 6 cooked enough of it to float a battleship; he also served on the
- 7 boards of Boys' Haven, the Fire Museum, and Cooks 2 Dozen Plus,
- 8 among other organizations; and
- 9 WHEREAS, This dynamic Texan enjoyed a long and happy marriage
- 10 to his high school sweetheart, the former Patricia Guidry, and he
- 11 was devoted to his daughters, Rhonda, Angie, and Jodie, his
- 12 grandchildren, Ashley, Kyleigh, Morgan, Cody, Drew, and Mason, and
- 13 his many friends; in his leisure, he enjoyed golfing, hunting, and
- 14 gardening; and
- WHEREAS, A. J. Leger made a positive difference in his
- 16 community and enriched the lives of innumerable people through his
- 17 kindness and joie de vivre; although he is deeply missed, treasured
- 18 memories of time spent in his company remain to comfort those he
