1 WHEREAS, Family and friends are mourning the loss of Robert
2 Ochoa Moon of Irving, who passed away on May 28, 2011, at the age of
3 66; and

4 WHEREAS, Born in Dallas on September 14, 1944, Bob Moon was
5 the son of John Moon and Herminia Ochoa Moon; he graduated from
6 N. R. Crozier Technical High School and served in the United States
7 Navy, aboard the USS *Cimarron* and USS *Valley Forge*, from 1964 to
8 1970, earning the National Defense Service Medal and Vietnam
9 Service Medal; and

10 WHEREAS, After completing his tours of duty, Mr. Moon worked
11 for nearly two decades as a sales representative for apparel
12 companies, traveling around Texas, Oklahoma, Arkansas, and
13 Louisiana in his motor home and making numerous friends among his
14 clients; when the clothing manufacturing business began moving
15 abroad, he opened a popular restaurant called the Burrito House in
16 Seven Points with his sister, Hortensia; later, he became a top
17 salesman for Toyota of Irving, and in 1999, he was licensed as a
18 mortgage broker and banker and established Affirmative Mortgage
19 Company, which grew to include three offices; and

20 WHEREAS, Mr. Moon helped revive the Irving Hispanic Chamber
21 of Commerce and served a term as president during his several years
22 on its board; moreover, he benefited his community in a number of
23 leadership roles, serving on the boards of Housing and Human
24 Services and the Irving YMCA and volunteering for other

1 organizations as well; he had a large network of friends and strove
2 to connect people who could help each other; and

3 WHEREAS, Devoted to his loved ones, Mr. Moon was married to
4 his wife, Rachel, for 33 years, and he was the proud father of
5 daughters Rita, Rachelle, and Alexia; as the years went by, he
6 welcomed six grandchildren into the family; he endeared himself to
7 innumerable people with his wonderful sense of humor and funny
8 stories, and he especially enjoyed sitting on the deck of his lake
9 house in the morning with a cup of coffee, entertaining the
10 neighbors who came to join him; ever attentive, he often advised
11 "God gave us two ears and one mouth to listen more than talk"; he was
12 an ardent fan of the Dallas Cowboys and Texas Rangers and liked
13 golfing, fishing, hosting cookouts, and listening to Mexican music
14 and golden oldies; and

15 WHEREAS, Bob Moon possessed a generosity of spirit that
16 expressed itself in myriad ways, and countless lives were forever
17 enriched by his warmth and kindness; now, therefore, be it

19 Legislature, 1st Called Session, hereby pay tribute to the memory
20 of Robert Ochoa Moon and extend sincere sympathy to the members of
