- 1 WHEREAS, Dr. Robert M. Gates is retiring as the United States
- 2 secretary of defense on June 30, 2011, drawing to a close an
- 3 extraordinary 45-year career in which he has served eight U.S.
- 4 presidents; and
- 5 WHEREAS, A native of Kansas, Robert Gates earned a bachelor's
- 6 degree from the College of William and Mary, a master's degree in
- 7 history from Indiana University, and a doctorate in Russian and
- 8 Soviet history from Georgetown University; and
- 9 WHEREAS, Secretary Gates joined the Central Intelligence
- 10 Agency in 1966, and during the course of his outstanding 27-year
- 11 tenure with the organization, he spent nearly a decade in the White
- 12 House as a member of the National Security Council, serving four
- 13 presidents; and
- 14 WHEREAS, Named deputy director of the CIA in 1986, Secretary
- 15 Gates served in that role until early 1989, when he was appointed
- 16 assistant to the president and deputy national security adviser in
- 17 the administration of President George ${\tt H.~W.~Bush;}$ when he returned
- 18 to the CIA in 1991 as its director, he became the only career
- 19 officer in its history to rise from entry-level employee to agency
- 20 head; and
- 21 WHEREAS, Beginning a new chapter in his career, Secretary
- 22 Gates was appointed interim dean of the George Bush School of
- 23 Government and Public Service at Texas A&M University in 1999, and
- 24 in 2002, he accepted the position of university president; he

- 1 further contributed his expertise as a board member of the American
- 2 Council on Education and the National Association of State
- 3 Universities and Land-Grant Colleges; and
- 4 WHEREAS, Among the other organizations with which Secretary
- 5 Gates has been deeply involved are the National Eagle Scout
- 6 Association and the National Executive Board of the Boy Scouts of
- 7 America, both of which he served as president; in addition, he has
- 8 been chair of the Independent Trustees of the Fidelity Funds and a
- 9 board member of NACCO Industries, Brinker International, and Parker
- 10 Drilling Company; and
- WHEREAS, In 2006, Dr. Gates was selected to be the 22nd U.S.
- 12 secretary of defense by President George W. Bush, and he was sworn
- 13 in on December 18 of that year; after the 2008 election of President
- 14 Barack Obama, Secretary Gates became the only secretary of defense
- 15 in history to be asked to remain in that office by an incoming
- 16 president; and
- 17 WHEREAS, Recognized on many occasions, Dr. Gates is the
- 18 recipient of the National Security Medal, the Presidential Citizens
- 19 Medal, and two National Intelligence Distinguished Service Medals;
- 20 moreover, he has earned the Distinguished Intelligence Medal, the
- 21 CIA's highest award, three times; and
- WHEREAS, Throughout his years of service to the nation,
- 23 Secretary Gates has distinguished himself with his intelligence,
- 24 integrity, and patriotism, winning the lasting trust and respect of
- 25 men and women in uniform, politicians of both parties, and the
- 26 general public, and he may indeed take pride in his tremendous
- 27 contributions to the safety and security of his fellow Americans;
