A BILL TO BE ENTITLED

1 AN ACT 2 relating to the eligibility of certain citizens residing outside 3 the United States to vote a full ballot. Δ BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: SECTION 1. Section 101.001, Election Code, is amended to 5 6 read as follows: 7 Sec. 101.001. ELIGIBILITY. (a) A person is eligible for 8 early voting by mail as provided by this chapter if: (1) the person is qualified to vote in this state or, 9 if not registered to vote in this state, would be qualified if 10 registered; and 11 12 (2) the person is: 13 (A) a member of the armed forces of the United 14 States, or the spouse or a dependent of a member; 15 (B) a member of the merchant marine of the United States, or the spouse or a dependent of a member; or 16 domiciled in this state but temporarily 17 (C) living outside the territorial limits of the United States and the 18 District of Columbia. 19 (b) Notwithstanding Subsection (a) and Chapter 114, a 20 person who indicates on a federal postcard application that the 21 22 person is a United States citizen residing outside the United States indefinitely is entitled to vote a full ballot as provided by 23 24 this chapter if the person is otherwise eligible to vote under this

1 <u>chapter and is a registered voter at the address contained on the</u> 2 <u>application.</u>

3 SECTION 2. Section 101.004, Election Code, is amended by 4 adding Subsection (n) to read as follows:

5 (n) The early voting clerk shall provide notice to a person who indicates on a federal postcard application that the person is a 6 7 United States citizen residing outside the United States indefinitely, other than a person described by Section 101.001(b), 8 9 that as a result of the person's indication, the person is only eligible to vote a federal ballot as provided by Chapter 114. The 10 11 secretary of state shall prescribe the form and manner of the notice provided under this subsection. 12

SECTION 3. Chapter 101, Election Code, is amended by adding Section 101.014 to read as follows:

FOR CITIZENS 15 Sec. 101.014. NOTICE ON COUNTY WEBSITE 16 RESIDING OUTSIDE OF UNITED STATES INDEFINITELY. <u>If a county</u> maintains an Internet website to provide information on voting, the 17 website must include information that describes the effects on the 18 ballot a person will receive under state law if the person indicates 19 20 on a federal postcard application that the person is a United States citizen residing outside the United States indefinitely. 21

22 SECTION 4. Section 114.002, Election Code, is amended to 23 read as follows:

24 Sec. 114.002. ELIGIBILITY. A United States citizen 25 <u>residing</u> [dwelling] outside the United States is eligible to vote a 26 federal ballot by mail if:

(1) the citizen's most recent domicile in the United

States was in this state and the <u>citizen is residing outside the</u> <u>United States indefinitely</u> [<del>citizen's intent to return to this</del> <del>state is uncertain</del>];

4 (2) the citizen would be eligible for registration as 5 a voter in this state if a resident; and

6 (3) the citizen is not eligible to vote on federal 7 offices in any other state.

8 SECTION 5. The change in law made by this Act applies to a 9 federal postcard application that requests a ballot for an election 10 that is held on or after the effective date of this Act.

SECTION 6. This Act takes effect on the 91st day after the last day of the legislative session.
