RESOLUTION

- BE IT RESOLVED by the Senate of the State of Texas, 82nd
- 2 Legislature, 1st Called Session, 2011, That Senate Rule 12.03 be
- 3 suspended in part as provided by Senate Rule 12.08 to enable the
- 4 conference committee appointed to resolve the differences on Senate
- 5 Bill 8 (the flexibility of the board of trustees of a school
- 6 district in the management and operation of public schools in the
- 7 district) to consider and take action on the following matters:
- 8 (1) Senate Rules 12.03(3) and (4) are suspended to permit
- 9 the committee to add text on a matter not in disagreement and not
- 10 included in either the house or senate version of the bill by adding
- 11 the following new SECTIONS to the bill:
- 12 SECTION 2. Section 21.051, Education Code, is amended to
- 13 read as follows:
- 14 Sec. 21.051. RULES REGARDING FIELD-BASED EXPERIENCE AND
- 15 OPTIONS FOR FIELD EXPERIENCE AND INTERNSHIPS. (a) In this section,
- 16 "teacher of record" means a person employed by a school district who
- 17 teaches the majority of the instructional day in an academic
- 18 instructional setting and is responsible for evaluating student
- 19 achievement and assigning grades.
- 20 (b) Before a school district may employ a candidate for
- 21 certification as a teacher of record, the candidate must complete
- 22 at least 15 hours of field-based experience in which the candidate
- 23 is actively engaged in instructional or educational activities
- 24 under supervision at:

- 1 (1) a public school campus accredited or approved for
- 2 the purpose by the agency; or
- 3 (2) a private school recognized or approved for the
- 4 purpose by the agency.
- 5 (c) Subsection (b) applies only to an initial certification
- 6 <u>issued on or after September 1, 2012.</u> Subsection (b) does not
- 7 affect:
- 8 <u>(1) the validity of a certification issued before</u>
- 9 September 1, 2012; or
- 10 (2) the eligibility of a person who holds a
- 11 certification issued before September 1, 2012, to obtain a
- 12 subsequent renewal of the certification in accordance with board
- 13 rule.
- 14 (d) Subsection (b) does not affect the period within which
- 15 an individual must complete field-based experience hours as
- 16 determined by board rule if the individual is not accepted into an
- 17 educator preparation program before the deadline prescribed by
- 18 board rule and is hired for a teaching assignment by a school
- 19 district after the deadline prescribed by board rule.
- 20 (e) The board shall propose rules relating to the
- 21 <u>field-based experience required by Subsection (b). The</u>
- 22 commissioner by rule shall adopt procedures and standards for
- 23 recognizing a private school under Subsection (b)(2).

- 25 options for persons for any field-based [field] experience or

- 4 Explanation: The addition is necessary to establish
- 5 requirements for field-based experience that a candidate for
- 6 certification must meet before a school district may employ the
- 7 candidate as a teacher of record.
- 8 (2) Senate Rules 12.03(3) and (4) are suspended to permit

- 12 Code, in SECTION 16 of the bill:
- 13 A furlough day does not constitute a day of service for purposes of

- 16 school district furlough day does not constitute a day of service
- 17 for purposes of the Teacher Retirement System of Texas.
