A BILL TO BE ENTITLED

1 AN ACT 2 relating to reports filed with the comptroller regarding certain alcoholic beverage sales; providing a penalty. 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 4 5 SECTION 1. Section 111.006, Tax Code, is amended by adding Subsections (h) and (i) to read as follows: 6 (h) The comptroller shall disclose information to a person 7 regarding net sales by quantity, brand, and size that is submitted 8 9 in a report required under Section 151.462 if: (1) the person requesting the information holds a 10 permit or license under Chapter 19, 20, 21, 37, 64, 65, or 66, 11 12 Alcoholic Beverage Code; and 13 (2) the request relates only to information regarding 14 the sale of a product distributed by the person making the request. (i) A disclosure made under Subsection (h) is not considered 15 disclosure of competitively sensitive, proprietary, or 16 confidential information. 17 SECTION 2. Chapter 151, Tax Code, is amended by adding 18 Subchapter I-1, and a heading is added to that subchapter to read as 19 20 follows: 21 SUBCHAPTER I-1. REPORTS BY PERSONS INVOLVED IN THE MANUFACTURE AND DISTRIBUTION OF ALCOHOLIC BEVERAGES 22 23 SECTION 3. Subchapter I-1, Chapter 151, Tax Code, as added by this Act, is amended by adding Sections 151.462, 151.463, 24

DEFINITIONS. 6 WHOLESALERS AND DISTRIBUTORS OF BEER, WINE, AND MALT LIQUOR. (a)] In this subchapter [section]: 7 8 (1)"Brewer" means a person required to hold a brewer's permit under Chapter 12, Alcoholic Beverage Code. 9 10 (2) "Distributor" means a person required to hold: (A) a general distributor's license under 11 12 Chapter 64, Alcoholic Beverage Code; (B) a local distributor's license under Chapter 13 14 65, Alcoholic Beverage Code; or 15 (C) a branch distributor's license under Chapter 66, Alcoholic Beverage Code. 16 17 (3) "Manufacturer" means a person required to hold a manufacturer's license under Chapter 62, Alcoholic Beverage Code. 18 19 (4) "Package store local distributor" means a person required to hold: 20 21 (A) a package store permit under Chapter 22, 22 Alcoholic Beverage Code; and (B) a local distributor's permit under Chapter 23 23, [a general, local, or branch distributor's license under the] 24 Alcoholic Beverage Code. 25 26 (5) [(2)] "Retailer" means a person required to hold [the following]: 27

(6) [(3)] "Wholesaler" means a person required to hold 2 3 [the following under the Alcoholic Beverage Code]: 4 (A) a winery permit under Chapter 16, Alcoholic 5 Beverage Code; 6 (B) a wholesaler's permit under Chapter 19, 7 Alcoholic Beverage Code; 8 (C) [(B)] a general Class B wholesaler's permit under Chapter 20, Alcoholic Beverage Code; or 9 10 (D) [(C)] a local Class B wholesaler's permit under Chapter 21, Alcoholic Beverage Code. 11 12 Sec. 151.462. REPORTS BY BREWERS, MANUFACTURERS, WHOLESALERS, AND DISTRIBUTORS. (a) [<del>(b)</del>] The comptroller <u>shall</u> 13 14 [may, when considered necessary by the comptroller for the 15 administration of a tax under this chapter, require each brewer, manufacturer, wholesaler, [or] distributor, or package store local 16 17 distributor [of beer, wine, or malt liquor] to file with the comptroller a report each month of alcoholic beverage sales to 18 retailers in this state. 19 (b) Each brewer, manufacturer, [(c) The] wholesaler, [or] 20 distributor, or package store local distributor shall file a 21 separate [the] report for each permit or license held on or before 22 23 the 25th day of each month. The report must contain the following 24 information for the preceding calendar month's sales in relation to each retailer: 25 26 (1)the brewer's, manufacturer's, wholesaler's, distributor's, or package store local distributor's name, address, 27

No. 11 1 taxpayer number and outlet number assigned by the comptroller, and alphanumeric permit or license number issued by the Texas Alcoholic 2 3 Beverage Commission; 4 (2) the retailer's: 5 (A) name and address, including street name and 6 number, city, and zip code; 7 (B) taxpayer number assigned by the comptroller; 8 and (C) alphanumeric permit or license number issued 9 10 by the Texas Alcoholic Beverage Commission for each separate retail location or outlet to which the brewer, manufacturer, wholesaler, 11 12 distributor, or package store local distributor sold the alcoholic beverages that are listed on the report [the name of the retailer 13 and the address of the retailer's outlet location to which the 14 15 wholesaler or distributor delivered beer, wine, or malt liquor, 16 including the city and zip code; 17 [(2) the taxpayer number assigned by the comptroller to the retailer, if the wholesaler or distributor is in possession 18 19 of the number; [(3) the permit or license number assigned to the 20 retailer by the Texas Alcoholic Beverage Commission]; and 21 22 (3) [(4)] the monthly net sales made by the brewer, manufacturer, wholesaler, distributor, or package store local 23 24 distributor to the retailer for each [by] outlet or location covered by a separate retail permit or license issued by the Texas 25 26 Alcoholic Beverage Commission, including separate line items for: 27 (A) the number of units of alcoholic beverages;

8	(F) the net selling price of the alcoholic
9	beverage [by the wholesaler or distributor, including the quantity
10	and units of beer, wine, and malt liquor sold to the retailer].
11	<u>(c)</u> [ <del>(d)</del> ] Except as provided by this subsection, the
12	brewer, manufacturer, wholesaler, [ <del>or</del> ] distributor, or package
13	store local distributor shall file the report with the comptroller
14	electronically. The comptroller may establish procedures to
15	temporarily postpone the electronic reporting requirement [for
16	allowing an alternative method of filing] for a brewer,
17	<u>manufacturer,</u> wholesaler <u>,</u> [ <del>or</del> ] distributor <u>, or package store local</u>
18	distributor who demonstrates to the comptroller an inability to
19	comply because undue hardship would result if it were required to
20	file the return electronically [with the electronic reporting
21	requirement]. If the comptroller determines that another
22	technological method of filing the report is more efficient than
23	electronic filing, the comptroller may establish procedures
24	requiring its use by <u>brewers, manufacturers,</u> wholesalers, [and]
25	distributors, and package store local distributors.
26	Sec. 151.463. RULES. The comptroller may adopt rules to
27	implement this subchapter.

<u>Sec. 151.464. CONFIDENTIALITY.</u> [<del>(e)</del>] Except as provided by
 Section 111.006, information contained in a report required to be
 filed by this <u>subchapter</u> [<del>section</del>] is confidential and not subject
 to disclosure under Chapter 552, Government Code.

5 <u>Sec. 151.465. APPLICABILITY TO CERTAIN BREWERS. This</u> 6 <u>subchapter applies only to a brewer whose annual production of malt</u> 7 <u>liquor in this state, together with the annual production of beer at</u> 8 <u>the same premises by the holder of a manufacturer's license under</u> 9 <u>Section 62.12, Alcoholic Beverage Code, does not exceed 75,000</u> 10 <u>barrels.</u>

Sec. 151.466. APPLICABILITY TO CERTAIN MANUFACTURERS. This
 subchapter applies only to a manufacturer whose annual production
 of beer in this state does not exceed 75,000 barrels.

14 <u>Sec. 151.467.</u> SUSPENSION OR CANCELLATION OF PERMIT. [(f)] 15 If a person fails to file a report required by this <u>subchapter</u> 16 [section] or fails to file a complete report, the comptroller may 17 suspend or cancel one or more permits issued to the person under 18 Section 151.203.

19 <u>Sec. 151.468. CIVIL PENALTY; CRIMINAL PENALTY. (a) If a</u> 20 person fails to file a report required by this subchapter or fails 21 <u>to file a complete report, the comptroller</u> [and] may impose a civil 22 or criminal penalty, or both, under Section 151.7031 or 151.709.

(b) In addition to the penalties imposed under Subsection (a), a brewer, manufacturer, wholesaler, distributor, or package store local distributor shall pay the state a civil penalty of not less than \$25 or more than \$2,000 for each day a violation continues if the brewer, manufacturer, wholesaler, distributor, or package

1 store local distributor:

(1) violates this subchapter; or

3 (2) violates a rule adopted to administer or enforce
4 this subchapter.

5 <u>Sec. 151.469. ACTION BY TEXAS ALCOHOLIC BEVERAGE</u> 6 <u>COMMISSION.</u> [<del>(g)</del>] If a person fails to file a report required by 7 this <u>subchapter</u> [<del>section</del>] or fails to file a complete report, the 8 comptroller may notify the Texas Alcoholic Beverage Commission of 9 the failure and the commission may take administrative action 10 against the person for the failure under the Alcoholic Beverage 11 Code.

Sec. 151.470. AUDIT; INSPECTION. The comptroller may audit, inspect, or otherwise verify a brewer's, manufacturer's, wholesaler's, distributor's, or package store local distributor's compliance with this subchapter.

16 <u>Sec. 151.471. ACTION BY ATTORNEY GENERAL; VENUE; ATTORNEY'S</u> 17 <u>FEES. (a) The comptroller may bring an action to enforce this</u> 18 <u>subchapter and obtain any civil remedy authorized by this</u> 19 <u>subchapter or any other law for the violation of this subchapter.</u> 20 <u>The attorney general shall prosecute the action on the</u> 21 <u>comptroller's behalf.</u>

22 (b) Venue for and jurisdiction of an action under this 23 section is exclusively conferred on the district courts in Travis 24 <u>County.</u>

25 (c) If the comptroller prevails in an action under this
26 section, the comptroller and attorney general are entitled to
27 recover court costs and reasonable attorney's fees incurred in

## 1 bringing the action.

SECTION 4. Subchapter I-1, Chapter 151, Tax Code, as added by this Act, applies only to a report due on or after the effective date of this Act. A report due before the effective date of this Act is governed by the law as it existed on the date the report was due, and the former law is continued in effect for that purpose.

7 SECTION 5. This Act takes effect September 1, 2011.
