H.B. No. 80

A BILL TO BE ENTITLED

1 AN ACT  
2 relating to registration with the Selective Service System of  
3 certain applicants for a driver's license or personal  
4 identification certificate.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

6 SECTION 1. Section 521.147, Transportation Code, is amended  
7 to read as follows:

8 Sec. 521.147. [~~OPTIONAL~~] REGISTRATION WITH SELECTIVE  
9 SERVICE SYSTEM. (a) After an application for an original, renewal,  
10 or duplicate driver's license or personal identification  
11 certificate is submitted by a male applicant who on the date of the  
12 application is at least 18 years of age but younger than 26 years of  
13 age, the department shall send in an electronic format to the United  
14 States Selective Service System the information from the  
15 application necessary to register the applicant under the Military  
16 Selective Service Act (50 U.S.C. App. Section 451 et seq.).

17 (b) An application under this section must give written  
18 notice to an applicant that the application also constitutes  
19 registration with the United States Selective Service System for  
20 persons who are subject to registration and have not previously  
21 registered. The notice must be conspicuous on the application and  
22 state: "By submitting this application, I am consenting to  
23 registration with the United States Selective Service System if my  
24 registration is required by federal law."

1        (c) The applicant's submission of the application following  
2 this notification constitutes the applicant's consent to the  
3 sending of the information and the [~~The department shall develop by~~  
4 ~~rule a selective service consent statement as a part of the~~  
5 ~~application for an original, renewal, or duplicate driver's license~~  
6 ~~or personal identification certificate. The consent statement must~~  
7 ~~include a place to indicate consent or declination to register with~~  
8 ~~the United States Selective Service System and must state the~~  
9 ~~benefits and penalties associated with consent or declination to~~  
10 ~~register. The department shall present the statement to each~~  
11 ~~applicant who is subject to registration with the Selective Service~~  
12 ~~System and record the applicant's response. A response is required~~  
13 ~~to complete the application for a license or certificate for such an~~  
14 ~~applicant. The department shall forward to the Selective Service~~  
15 ~~System, in an electronic format, only the information necessary for~~  
16 ~~registration of an applicant consenting to]~~ registration.

17        (d) [~~(b)~~] In addition to the notification [~~statement~~]  
18 required by Subsection (b) [~~(a)~~], the department may conspicuously  
19 post at each location where applications for driver's licenses and  
20 personal identification certificates are accepted one or more  
21 signs, in English and Spanish, providing the information contained  
22 in the notification [~~statement~~].

23        (e) Subsections (a) and (c) do not apply to an applicant  
24 concerning whom the department has previously sent information to  
25 the Selective Service System.

26        SECTION 2. This Act applies only to an application for the  
27 issuance of a driver's license or personal identification
