11	Sec. 1671.001. DEFINITIONS. In this chapter:
12	(1) "Direct payment" means payment for health care
13	services provided to an individual or a dependent of the individual
14	that is made by the individual or by the individual's employer,
15	without a public or private third party, other than the employer,
16	paying for any portion of the service.
17	(2) "Health care system" means any public or private
18	entity, including a health insurer or health benefit plan, that for
19	the benefit of its participants:
20	(A) manages, enrolls individuals in, or makes
21	full or partial payment for health care services; or
22	(B) manages or processes health care data or
23	<u>information.</u>
24	Sec. 1671.002. DIRECT PAYMENT; HEALTH CARE SYSTEM

- 1 PARTICIPATION. (a) This state, an agency of this state, or a health
- 2 care system may not:
- 3 (1) impose a fine or penalty on an individual or the
- 4 individual's employer for direct payment for a health care service;
- 5 (2) impose a fine or penalty on a health care provider
- 6 for accepting direct payment for a health care service; or
- 7 (3) directly or indirectly require an individual,
- 8 employer, or health care provider to participate in a health care
- 9 system, including imposing a fine or penalty for failure to
- 10 participate.
- 11 (b) This section does not:
- 12 (1) affect which health care services a health care
- 13 provider or hospital is required to provide;
- 14 (2) affect which health care services are permitted by
- 15 <u>law;</u>
- 16 (3) prohibit care provided pursuant to a workers'
- 17 compensation claim;
- 18 (4) affect a law or rule in effect January 1, 2010; or
- 19 (5) affect the terms or conditions of a health care
- 20 system that do not:
- 21 (A) impose a fine or penalty on an individual or
- 22 the individual's employer for direct payment for a health care
- 23 service; or
- 24 (B) impose a fine or penalty on a health care
- 25 provider for accepting direct payment for a health care service.
