A BILL TO BE ENTITLED

- 2 relating to the enforcement of tax laws; providing a criminal
- 3 penalty.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Article 13.13, Code of Criminal Procedure, is
- 6 amended to read as follows:
- 7 Art. 13.13. CONSPIRACY. Criminal conspiracy may be
- 8 prosecuted in the county where the conspiracy was entered into, in
- 9 the county where the conspiracy was agreed to be executed, or in any
- 10 county in which one or more of the conspirators does any act to
- 11 effect an object of the conspiracy. If the object of the conspiracy
- 12 is an offense classified as a felony under the Tax Code, regardless
- 13 of whether the offense was committed, the conspiracy may be
- 14 prosecuted in any county in which venue is proper under the Tax Code
- 15 for the offense. If a conspiracy was entered into outside this
- 16 State under circumstances that give this State jurisdiction to
- 17 prosecute the offender, the offender may be prosecuted in the
- 18 county where the conspiracy was agreed to be executed, [ex] in the
- 19 county where any one of the conspirators was found, or in Travis
- 20 County.
- 21 SECTION 2. Article 13.21, Code of Criminal Procedure, is
- 22 amended to read as follows:
- 23 Art. 13.21. ORGANIZED CRIMINAL ACTIVITY. The offense of
- 24 engaging in organized criminal activity may be prosecuted in any

- 1 county in which any act is committed to effect an objective of the
- 2 combination, or, if the prosecution is based on a criminal offense
- 3 classified as a felony under the Tax Code, in any county in which
- 4 venue is proper under the Tax Code for the offense.
- 5 SECTION 3. Chapter 13, Code of Criminal Procedure, is
- 6 amended by adding Article 13.35 to read as follows:
- 7 Art. 13.35. MONEY LAUNDERING. Money laundering may be
- 8 prosecuted in the county in which the offense was committed as
- 9 provided by Article 13.18 or, if the prosecution is based on a
- 10 criminal offense classified as a felony under the Tax Code, in any
- 11 county in which venue is proper under the Tax Code for the offense.
- 12 SECTION 4. Chapter 42, Code of Criminal Procedure, is
- 13 amended by adding Article 42.0182 to read as follows:
- 14 Art. 42.0182. FINDINGS REGARDING TAX FRAUD. (a) In the
- 15 trial of an offense under the Tax Code or an offense under the Penal
- 16 Code related to the administration of taxes, the state may file a
- 17 written request with the court in which the indictment or
- 18 information is pending for the court to make affirmative findings
- 19 regarding the commission of tax fraud as described by Subsection
- 20 (b). The state must provide a copy of the written request to the
- 21 <u>defendant before the date the trial begins.</u>
- 22 (b) If the state requests affirmative findings in the manner
- 23 required by Subsection (a), the court shall make the requested
- 24 affirmative findings and enter the findings in the papers in the
- 25 case if the court finds by clear and convincing evidence that:
- 26 (1) the defendant's failure to pay a tax or file a
- 27 report when due, as required by Title 2 or 3, Tax Code, was a result

- 1 of fraud or an intent to evade the tax;
- 2 (2) the defendant altered, destroyed, or concealed any
- 3 record, document, or thing, or presented to the comptroller any
- 4 altered or fraudulent record, document, or thing, or otherwise
- 5 engaged in fraudulent conduct for the apparent purpose of affecting
- 6 the course or outcome of an audit, investigation, redetermination,
- 7 <u>or other proceeding before the comptroller; or</u>
- 8 <u>(3) the defendant's failure to file a report under</u>
- 9 Chapter 162, Tax Code, or to pay a tax under that chapter when the
- 10 tax became due is attributable to fraud or an intent to evade the
- 11 application of Chapter 162, Tax Code, or a rule adopted under
- 12 Chapter 111 or 162, Tax Code.
- SECTION 5. Section 403.012, Government Code, is amended to
- 14 read as follows:
- 15 Sec. 403.012. ACCEPTANCE OF FEDERAL MONEY OR PROPERTY. (a)
- 16 The comptroller may accept federal money for a state agency not
- 17 otherwise restricted by statute or by rider or special provision in
- 18 the General Appropriations Act, if the state agency has certified
- 19 to the comptroller that the agency will be responsible for
- 20 compliance with applicable federal and state law.
- 21 (b) The comptroller may accept money or property under a
- 22 <u>federal equitable sharing program. In accepting the money or</u>
- 23 property, the comptroller shall comply with federal program
- 24 requirements, including those governing accounting and the
- 25 permissible use of an award.
- SECTION 6. Section 411.109(a), Government Code, is amended
- 27 to read as follows:

- 1 (a) The comptroller is entitled to obtain from the
- 2 department criminal history record information maintained by the
- 3 department that the comptroller believes is necessary for the
- 4 enforcement or administration of Chapter 151, 152, [153,] 154, [or]
- 5 155, or 162, Tax Code, including criminal history record
- 6 information that relates to a person who is:
- 7 (1) an applicant for a permit under any of those
- 8 chapters;
- 9 (2) a permit holder under any of those chapters;
- 10 (3) an officer, director, stockholder owning 10
- 11 percent or more of the outstanding stock, partner, owner, or
- 12 managing employee of an applicant or permit holder under any of
- 13 those chapters that is a corporation, association, joint venture,
- 14 syndicate, partnership, or proprietorship;
- 15 (4) believed to have violated any of those chapters;
- 16 or
- 17 (5) being considered by the comptroller for employment
- 18 as a peace officer.
- 19 SECTION 7. Section 34.01(4), Penal Code, is amended to read
- 20 as follows:
- 21 (4) "Proceeds" means funds acquired or derived
- 22 directly or indirectly from, produced through, or realized through:
- 23 <u>(A)</u> an act; or
- 24 (B) conduct that constitutes an offense under
- 25 <u>Section 151.7032, Tax Code</u>.
- SECTION 8. Section 71.02(a), Penal Code, as amended by
- 27 Chapters 153 (S.B. 2225), 1130 (H.B. 2086), and 1357 (S.B. 554),

- 1 Acts of the 81st Legislature, Regular Session, 2009, is reenacted
- 2 and amended to read as follows:
- 3 (a) A person commits an offense if, with the intent to

- 16 comptroller records that document a taxpayer's taxable sale of
- 17 items that the taxpayer obtained using a resale certificate.
- 18 (b) The records to which Subsection (a) applies are records:
- 19 (1) required to be kept under Section 151.025; and
- 20 (2) requested by the comptroller under Section 151.023
- 21 that are not produced in the period required by that section.
- (c) The items to which Subsection (a) applies are items the

- 14 <u>seized under Section 154.403 before their sale under this</u>

- 16 (b) In a proceeding arising out of this chapter, including a
- 17 criminal proceeding, the state is not required to produce the
- 18 actual cigarettes.
- 19 (c) The photographs are admissible in evidence under rules
- 20 of law governing the admissibility of photographs. The photographs
- 21 are as admissible in evidence as are the cigarettes themselves.
- 22 (d) A person's rights of discovery and inspection of
- 23 tangible physical evidence are satisfied if the photographs taken
- 24 under this section are made available to the person by the state on
- 25 order of any court or other entity having jurisdiction over the
- 26 proceeding.
- 27 SECTION 22. Section 155.145, Tax Code, is amended by adding

- 1 Subsection (e) to read as follows:
- 2 (e) A forfeiture proceeding under this section is an in rem
- 3 proceeding.
- 4 SECTION 23. Section 155.1451, Tax Code, is amended by
- 5 amending Subsection (a) and adding Subsection (d) to read as
- 6 follows:
- 7 (a) The comptroller may sell property forfeited to the state
- 8 at public or private sale in any commercially reasonable manner or
- 9 retain the property for official use by the comptroller's criminal
- 10 investigation division. Property retained for use under this
- 11 subsection may later be sold by the comptroller under this section.
- 12 (d) If an automobile or other vehicle seized under Section
- 13 155.143 is forfeited and retained by the comptroller under
- 14 Subsection (a), the comptroller is considered the owner under
- 15 <u>Subtitle A, Title 7, Transportation Code. The Texas Department of</u>
- 16 Motor Vehicles shall issue a certificate of title for the vehicle to
- 17 the comptroller. The comptroller may maintain, repair, use, and

- 19 SECTION 24. Subchapter E, Chapter 155, Tax Code, is amended
- 20 by adding Section 155.146 to read as follows:
- 21 <u>Sec. 155.146. PHOTOGRAPHIC EVIDENCE IN CASES INVOLVING</u>
- 22 SEIZED TOBACCO PRODUCTS. (a) The comptroller may photograph
- 23 tobacco products seized under Section 155.143 before their sale
- 24 under this subchapter.
- 25 (b) In a proceeding arising out of this chapter, including a
- 26 criminal proceeding, the state is not required to produce the
- 27 actual tobacco products.

- 1 (c) The photographs are admissible in evidence under rules
- 2 of law governing the admissibility of photographs. The photographs
- 3 are as admissible in evidence as are the tobacco products
- 4 themselves.
- 5 (d) A person's rights of discovery and inspection of
- 6 tangible physical evidence are satisfied if the photographs taken
- 7 under this section are made available to the person by the state on
- 8 order of any court or other entity having jurisdiction over the
- 9 proceeding.
- SECTION 25. Section 162.401, Tax Code, is amended by adding
- 11 Subsection (c) to read as follows:
- 12 (c) The penalties provided by this section are intended to
- 13 be remedial in nature and are provided for the protection of state
- 14 revenue and to reimburse the state for expenses incurred as a result
- 15 of fraud, including expenses incurred in conducting an
- 16 <u>investigation</u>.
- 17 SECTION 26. Except as provided by Section 27 of this Act,
- 18 the changes in law made by this Act apply only to an offense
- 19 committed on or after the effective date of this Act. An offense
- 20 committed before the effective date of this Act is covered by the
- 21 law in effect when the offense was committed, and the former law is
- 22 continued in effect for that purpose. For purposes of this section,
- 23 an offense was committed before the effective date of this Act if
- 24 any element of the offense occurred before that date.
- 25 SECTION 27. The change in law made by this Act in amending
- 26 Article 13.13, Code of Criminal Procedure, applies only to a
- 27 criminal case in which the indictment or information is presented

- 1 to the court on or after the effective date of this Act. A criminal
- 2 case in which the indictment or information was presented to the
- 3 court before the effective date of this Act is governed by the law
- 4 in effect when the indictment or information was presented, and the
- 5 former law is continued in effect for that purpose.
- 6 SECTION 28. This Act applies only to a seizure of property
- 7 that occurs on or after the effective date of this Act. A seizure of
- 8 property that occurs before the effective date of this Act is
- 9 covered by the law in effect as it existed on the date the seizure
- 10 occurred, and the former law is continued in effect for that
- 11 purpose.
- 12 SECTION 29. This Act takes effect September 1, 2011.
