5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:					
6	SECTION 1. Title 2, Tax Code, is amended by adding Subtitle					
7	L to read as follows:					
8	SUBTITLE L. PERSONAL INCOME TAX					
9	CHAPTER 261. PERSONAL INCOME TAX					
10	SUBCHAPTER A. IMPOSITION OF TAX					
11	Sec. 261.001. TAX IMPOSED. (a) A tax is imposed for each					
12	<pre>tax year:</pre>					
13	(1) on the taxable income that exceeds \$150,000 of					
14	every resident of this state; and					
15	(2) on the taxable income that exceeds \$150,000					
16	derived from sources in this state of every nonresident.					
17	(b) The tax rates for an individual are:					
18	(1) for taxable income that exceeds \$150,000 but does					
19	not exceed \$250,000, three percent of the taxable income that					
20	exceeds \$150,000 but does not exceed \$250,000;					
21	(2) for taxable income that exceeds \$250,000 but does					
22	not exceed \$500,000, \$3,000 plus four percent of the taxable income					
23	that exceeds \$250,000 but does not exceed \$500,000;					
24	(3) for taxable income that exceeds \$500,000 but does					

- 1 not exceed \$1 million, \$13,000 plus five percent of the taxable
- 2 income that exceeds \$500,000 but does not exceed \$1 million; or
- 3 (4) for taxable income that exceeds \$1 million,
- 4 \$38,000 plus six percent of the taxable income that exceeds \$1
- 5 million.
- 6 Sec. 261.002. JOINT RETURN. If persons subject to the tax
- 7 under this chapter file a joint federal income tax return with a
- 8 spouse, they may file a joint return under this chapter but they may
- 9 not combine their incomes for the purpose of determining the amount
- 10 of tax owed. The separate incomes of each spouse are taxed as
- 11 individual incomes under Section 261.001.
- 12 Sec. 261.003. MEANING OF TERMS. (a) In this chapter:
- 13 (1) an individual is a resident of this state if the
- 14 individual:
- 15 (A) is domiciled in this state, unless the
- 16 individual does not maintain a permanent abode in this state and
- 17 does maintain a permanent abode elsewhere and spends, in the
- 18 aggregate, not more than 30 days of the tax year in this state; or
- 19 (B) is not domiciled in this state but maintains
- 20 a permanent abode in this state and spends, in the aggregate, more
- 21 than 183 days of the tax year in this state; and
- 22 (2) an individual is a nonresident if the individual
- 23 <u>is not a resident of this state.</u>
- (b) Any term used in this chapter and not defined by or for
- 25 purposes of this chapter has the same meaning as when used in a
- 26 comparable context in the laws of the United States relating to
- 27 federal income taxes, unless a different meaning is clearly

- 1 required. Any reference in this chapter to federal law means the
- 2 provisions of the Internal Revenue Code of 1986 in effect on
- 3 December 31, 2011, and other provisions of federal laws relating to
- 4 federal income taxes in effect on December 31, 2011.

- 6 SUBCHAPTER B. COMPUTATION OF TAXABLE INCOME
- 7 Sec. 261.051. TAXABLE INCOME. The taxable income of a
- 8 resident of this state is the resident's federal adjusted gross
- 9 income as defined by federal law.
- 10 Sec. 261.052. CREDIT FOR INCOME TAX PAID TO ANOTHER STATE.
- 11 (a) A resident individual is allowed a credit against the tax
- 12 otherwise due under this chapter for the amount of any income tax
- 13 imposed on the individual for the tax year by another state of the
- 14 United States on income that is derived from sources in that state
- 15 and that is subject to tax under this chapter.
- 16 (b) The credit provided by this section may not exceed the
- 17 proportion of the tax otherwise due under this chapter that the
- 18 amount of the taxpayer's adjusted gross income derived from sources
- 19 in the other taxing jurisdiction bears to the taxpayer's entire
- 20 adjusted gross income as modified by this subchapter.
- 21 Sec. 261.053. DUAL RESIDENCE; REDUCTION OF TAX. If a
- 22 taxpayer is a resident of this state and is regarded as a resident
- 23 of another jurisdiction for purposes of personal income taxation,
- 24 the comptroller shall reduce the tax on that portion of the
- 25 taxpayer's income that is subject to tax in both jurisdictions
- 26 solely by virtue of dual residence. The reduction is an amount
- 27 equal to that portion of the lower of the two taxes applicable to

- 1 the income taxed twice that the tax imposed by this state bears to
- 2 the combined taxes of the two jurisdictions on the income taxed
- 3 twice.
- 4 Sec. 261.054. NONRESIDENT INDIVIDUALS--TAXABLE INCOME.
- 5 The taxable income of a nonresident individual is that part of the
- 6 <u>individual's federal adjusted gross income derived from sources in</u>
- 7 this state determined under Section 261.055.
- 8 Sec. 261.055. ADJUSTED GROSS INCOME FROM SOURCES IN THIS
- 9 STATE--NONRESIDENT. (a) The adjusted gross income of a
- 10 nonresident derived from sources in this state is the net amount of
- 11 items of income, gain, loss, and deduction entering into the
- 12 nonresident's federal adjusted gross income that are derived from
- 13 or connected with sources in this state, including:
- 14 (1) the nonresident's distributive share of
- 15 partnership income and deductions determined under Section
- 16 <u>261.403</u>; and
- 17 (2) the nonresident's share of estate or trust income
- 18 and deductions derived from sources in this state.
- 19 (b) Items of income, gain, loss, and deduction derived from
- 20 or connected with sources in this state are those items
- 21 <u>attributable to:</u>
- (1) the ownership or disposition of an interest in
- 23 real or tangible personal property in this state; and
- 24 (2) a business, trade, profession, or occupation
- 25 conducted in this state.
- 26 (c) Income from intangible personal property, including
- 27 annuities, dividends, interest, and gains from the disposition of

- 1 intangible personal property, constitutes income derived from
- 2 sources in this state only to the extent that the income is from
- 3 property used in a business, trade, profession, or occupation
- 4 carried on in this state.
- 5 (d) Deductions for capital losses, net long-term capital
- 6 gains, and net operating losses derived from or connected with
- 7 sources in this state, are determined in the same manner as the
- 8 corresponding federal deductions. However, the extent to which the
- 9 deductions are derived from or connected with sources in this state
- 10 is determined under the comptroller's rules.
- 11 <u>(e) For a nonresident individual who is a sharehol</u>der of a
- 12 corporation that is an electing small business corporation for
- 13 federal income tax purposes, the undistributed taxable income of
- 14 the corporation does not constitute income derived from sources in
- 15 this state and a net operating loss of the corporation does not
- 16 constitute a loss or deduction connected with sources in this
- 17 state.
- 18 (f) If a business, trade, profession, or occupation is
- 19 carried on partly in and partly outside this state, the items of
- 20 income and deduction derived from or connected with sources in this
- 21 state are determined by apportionment and allocation consistent
- 22 with Chapter 141 under the comptroller's rules.
- 23 (g) Compensation paid by the United States for service in
- 24 the armed forces of the United States performed by a nonresident is
- 25 not income derived from sources in this state.

3	SUBCHAPTER D. ACCOUNTING PERIODS AND METHODS
4	Sec. 261.201. PERIOD FOR COMPUTATION OF TAXABLE INCOME.
5	(a) For purposes of the tax imposed by this chapter, a taxpayer's
6	tax year is the same as the taxpayer's tax year for federal income
7	tax purposes.
8	(b) If a taxpayer's tax year is changed for federal income
9	tax purposes, the taxpayer's tax year for purposes of the tax
10	imposed by this chapter is similarly changed.
11	Sec. 261.202. METHODS OF ACCOUNTING. (a) A taxpayer's
12	method of accounting is the same as the taxpayer's method of
13	accounting for federal income tax purposes. If a single method of
14	accounting has not been regularly used by the taxpayer, taxable
15	income for purposes of this chapter shall be computed under any
16	method that in the opinion of the comptroller fairly reflects
17	income.
18	(b) If a taxpayer's method of accounting is changed for
19	federal income tax purposes, the taxpayer's method of accounting
20	for purposes of this chapter is changed in the same manner.
21	Sec. 261.203. ADJUSTMENTS. In computing a taxpayer's
22	taxable income for any tax year under a method of accounting
23	different from the method under which the taxpayer's taxable income
24	for the previous year was computed, there shall be taken into
25	account those adjustments that are determined, under rules
26	prescribed by the comptroller, to be necessary solely by reason of
27	the change in order to prevent amounts from being duplicated or

- 2 Sec. 261.204. LIMITATION ON ADDITIONAL TAX. (a) If a
- 3 taxpayer's method of accounting is changed, other than from an
- 4 accrual to an installment method, an additional tax that results
- 5 from adjustments determined to be necessary solely because of the
- 6 change may not be greater than if those adjustments were ratably
- 7 allocated and included for the tax year of the change and not more
- 8 than two preceding tax years during which the taxpayer used the
- 9 method of accounting from which the change is made.
- 10 (b) If a taxpayer's method of accounting is changed from an
- 11 accrual to an installment method, an additional tax for the year of
- 12 the change of method and for a subsequent year that is attributable
- 13 to the receipt of installment payments properly accrued in a prior
- 14 year is reduced by the portion of tax for any prior tax year
- 15 attributable to the accrual of the installment payments, under
- 16 <u>rules adopted by the comptroller.</u>
- [Sections 261.205-261.400 reserved for expansion]
- SUBCHAPTER E. PARTNERS AND PARTNERSHIPS
- 19 Sec. 261.401. ENTITY NOT TAXABLE. A partnership as an
- 20 entity is not subject to the tax imposed by this chapter. Persons
- 21 carrying on business as partners are liable for the tax imposed by
- 22 this chapter only in their separate or individual capacities.
- Sec. 261.402. RESIDENT PARTNER--ADJUSTED GROSS INCOME. (a)
- 24 Partnership income, gain, loss, or deduction is allocated in
- 25 accordance with each partner's distributive share for federal
- 26 income tax purposes.
- 27 (b) Each item of partnership income, gain, loss, or

- 1 deduction has the same character for a partner under this chapter as
- 2 it has for federal income tax purposes. If an item is not
- 3 characterized <u>for federal income tax purposes</u>, it has the same
- 4 character for a partner as if realized directly from the source from
- 5 which realized by the partnership or incurred in the same manner as
- 6 incurred by the partnership.
- 7 (c) If a partner's distributive share of an item of
- 8 partnership income, gain, loss, or deduction is determined for
- 9 federal income tax purposes by a special provision in the
- 10 partnership agreement with respect to the item, and the principal
- 11 purpose of the provision is the avoidance or evasion of tax under
- 12 this chapter, the partner's distributive share of the item and a
- 13 modification required with respect to it is determined in
- 14 accordance with the partner's distributive share of the taxable
- 15 <u>income or loss of the partnership generally, excluding those items</u>
- 16 requiring separate computation under Section 702, Internal Revenue
- 17 Code of 1986.
- 18 Sec. 261.403. NONRESIDENT PARTNER--ADJUSTED GROSS INCOME
- 19 FROM SOURCES IN THIS STATE. (a) In determining the adjusted gross
- 20 income of a nonresident partner of any partnership, there shall be
- 21 included only that part derived from or connected with sources in
- 22 this state of the partner's distributive share of items of
- 23 partnership income, gain, loss, and deduction entering into the
- 24 partner's federal adjusted gross income, as that part is determined
- 25 under rules adopted by the comptroller and consistent with the
- 26 rules adopted under Section 261.055.
- 27 (b) Except as authorized by Subsection (c), in determining

- 1 the sources of a nonresident partner's income, no effect is given to
- 2 a provision in the partnership agreement that:
- 3 (1) characterizes payments to the partner as being for
- 4 services or for the use of capital, or allocates to the partner, as
- 5 income or gain from sources outside this state, a greater
- 6 proportion of the partner's distributive share of partnership
- 7 income or gain than the ratio of partnership income or gain from
- 8 sources outside this state to partnership income or gain from all
- 9 sources; or
- 10 (2) allocates to the partner a greater proportion of a
- 11 partnership item of loss or deduction connected with sources in
- 12 this state than the partner's proportionate share, for federal
- 13 income tax purposes, of partnership loss or deduction generally.
- 14 (c) The comptroller may, on application, authorize the use
- 15 of other methods of determining a nonresident partner's portion of
- 16 partnership items derived from or connected with sources in this
- 17 state, and the modifications related to it, that are appropriate
- 18 and equitable, on terms the comptroller may require.
- 19 (d) A nonresident partner's distributive share of items of
- 20 income, gain, loss, or deduction is determined under Section
- 21 <u>261.402(a)</u>. The character of partnership items for a nonresident
- 22 partner is determined under Section 261.402(b). The effect of a
- 23 special provision in a partnership agreement, other than a
- 24 provision described by Subsection (b), having as a principal
- 25 purpose the avoidance or evasion of tax under this chapter is
- 26 determined under Section 261.402(c).

1 SUBCHAPTER F. TAX RETURNS AND PAYMENTS

- 2 Sec. 261.501. PERSONS REQUIRED TO MAKE RETURNS OF INCOME. A
- 3 state income tax return shall be made by every individual who has
- 4 adjusted gross income from sources in this state in excess of
- 5 \$150,000.
- 6 Sec. 261.502. RETURNS BY FIDUCIARIES. (a) An income tax
- 7 return for a deceased individual shall be made and filed by the
- 8 executor, administrator, or other person charged with the care of
- 9 the property of the decedent. A final return of a decedent is due
- 10 when it would have been due if the decedent had not died.
- 11 (b) An income tax return for an individual who is unable to
- 12 make a return because of minority or other disability shall be made
- 13 and filed by the individual's authorized agent, guardian,
- 14 conservator, fiduciary, or other person charged with the care of
- 15 the individual or the individual's property other than a receiver
- 16 <u>in possession of only a part of the individual's property.</u>
- (c) If two or more fiduciaries are acting jointly, the
- 18 return may be made by any one of them.
- 19 Sec. 261.503. NOTICE OF QUALIFICATION AS RECEIVER. A
- 20 receiver, trustee in bankruptcy, assignee for benefit of creditors,
- 21 or other similar fiduciary shall give notice of the person's
- 22 qualification to the comptroller, as may be required by rule.
- Sec. 261.504. CHANGE OF STATUS AS RESIDENT OR NONRESIDENT
- 24 DURING YEAR. (a) If the status of an individual changes during the
- 25 individual's tax year from resident to nonresident or from
- 26 <u>nonresident to resident, the comptroller by rule may require the</u>
- 27 individual to file one return for the portion of the year during

- 1 which the individual is a resident and one for the portion of the
- 2 year during which the individual is a nonresident.
- 3 (b) Except as provided by Subsection (c), the taxable income
- 4 of an individual is determined as provided by Section 261.051 for
- 5 residents and Section 261.054 for nonresidents as if the
- 6 individual's tax year for federal income tax purposes were limited
- 7 to the period of the individual's resident and nonresident status
- 8 respectively.
- 9 (c) There is included in determining taxable income from
- 10 sources in or outside this state, as the case may be, income, gain,
- 11 loss, or deduction accrued prior to the change of status even though
- 12 not otherwise includable or allowable in respect to the period
- 13 before the change, but the taxation or deduction of items accrued
- 14 before the change of status is not affected by the change.
- 15 (d) If two returns are required to be filed under this
- 16 section, the total of the taxes due may not be less than would be due
- 17 if the total of the taxable incomes reported on the two returns were
- 18 includable in one return.
- 19 Sec. 261.505. TIME AND PLACE FOR FILING RETURNS AND PAYING
- 20 TAX. (a) A person required to make and file an income tax return
- 21 required by this chapter shall:
- (1) file the return not later than the 15th day of the
- 23 fourth month following the end of the taxpayer's tax year; and
- 24 (2) pay a tax due to the comptroller not later than the
- 25 last day the filing of the return is allowed without penalty,
- 26 excluding an extension of time for filing the return.
- 27 (b) The comptroller by rule shall prescribe the place for

- 1 filing a return, statement, or other document required by this
- 2 chapter and for the payment of a tax.
- 3 Sec. 261.506. ESTIMATED TAX. (a) An individual subject to
- 4 the income tax imposed by this chapter shall make estimated
- 5 payments of the tax. Section 6654, Internal Revenue Code of 1986,
- 6 other than Subsections (a), (b), (d)(2), and (e) of that section,
- 7 governing the payment of estimated federal income taxes on
- 8 individuals applies to the payments required by this section,
- 9 including exemptions from the estimated tax payment requirement. A
- 10 reference in that section to the federal income tax imposed on
- 11 individuals is construed as a reference to the tax imposed by this
- 12 chapter as required to administer this section. A power or duty
- 13 given by Section 6654, Internal Revenue Code of 1986, to the United
- 14 States secretary of the treasury is assigned to the comptroller for
- 15 purposes of the estimated payments required by this section.
- 16 (b) The comptroller shall adopt rules to administer this
- 17 section.
- 18 (c) Payment of the estimated tax or an installment is
- 19 considered payment on account of the tax imposed by this chapter.
- Sec. 261.507. EXTENSION OF TIME FOR FILING AND PAYMENT. (a)
- 21 The comptroller, on terms the comptroller may require, may grant a
- 22 reasonable extension of time for payment of tax or an installment,
- 23 or for filing a return, statement, or other document required under
- 24 this chapter. Except for an extension for a taxpayer who is outside
- 25 the United States, an extension for filing a return, statement, or
- 26 document may not exceed six months.
- 27 (b) If the time for the payment of an amount of tax is

- 1 extended, the comptroller may require the taxpayer to furnish a
- 2 bond or other security in an amount not exceeding twice the amount
- 3 of tax for which the extension of time for payment is granted, on
- 4 terms the comptroller may require.
- 5 Sec. 261.508. CHANGE OF ELECTION. An election expressly
- 6 authorized by this chapter may be changed as authorized by the
- 7 comptroller or by the comptroller's rule.
- 8 Sec. 261.509. SIGNING OF RETURNS AND OTHER DOCUMENTS. (a)
- 9 A return, statement, or other document required to be made or filed
- 10 under this chapter shall be signed as provided by the comptroller.
- 11 An individual's name signed to a return, statement, or other
- 12 document is prima facie evidence that the individual signed the
- 13 return, statement, or other document.
- 14 (b) A return, statement, or other document required of a
- 15 partnership must be signed by at least one partner. A partner's
- 16 name signed to a return, statement, or other document is prima facie
- 17 evidence that the partner is authorized to sign on behalf of the
- 18 partnership.
- 19 (c) The making or filing of a return, statement, or other
- 20 document or copy required to be made or filed under this chapter,
- 21 <u>including a copy of a federal return, constitutes a certification</u>
- 22 by the person making or filing the return, statement, or other
- 23 document or copy that the statements contained in it are true and
- 24 that a copy filed is a true copy.
- 25 [Sections 261.510-261.520 reserved for expansion]
- 26 <u>SUBCHAPTER G. INFORMATION RETURNS</u>
- Sec. 261.521. GENERAL REQUIREMENTS. The comptroller by

- 1 rule may require the keeping of records, the content and form of
- 2 returns and statements, and the filing of copies of federal income
- 3 returns and determinations. The comptroller may require a person,
- 4 by rule or by notice served on the person, to make returns, render
- 5 statements, or keep records, as the comptroller considers
- 6 sufficient to show whether the person is liable under this chapter
- 7 for tax or for the collection of tax.
- 8 Sec. 261.522. REPORT OF CHANGE IN FEDERAL TAXABLE INCOME.
- 9 (a) If the amount of a taxpayer's federal taxable income reported
- 10 on the taxpayer's federal income tax return for a tax year is
- 11 changed or corrected by the United States Internal Revenue Service
- 12 or other competent authority, or as the result of a renegotiation of
- 13 <u>a contract or subcontract with the United States, the taxpayer</u>
- 14 shall:
- 15 (1) report the change or correction in federal taxable
- 16 income not later than the 90th day after the final determination of
- 17 the change, correction, or renegotiation, or as required by the
- 18 comptroller; and
- 19 (2) concede the accuracy of the determination or state
- 20 in what way it is erroneous.
- 21 (b) A taxpayer filing an amended federal income tax return
- 22 shall also file, not later than the 90th day after filing, an
- 23 amended return under this chapter, and shall give any information
- 24 required by the comptroller.
- 25 <u>(c) The comptroller by rule may prescribe exceptions to the</u>
- 26 requirements of this section.

1	SUBCHAPTER H.	ADDITIONS T	TO TAX;	PENALTIES

- 2 Sec. 261.601. FAILURE TO FILE TAX RETURN. (a) A person who
- 3 does not file a return required under this chapter on or before the
- 4 prescribed date is subject to the following penalty based on a
- 5 percentage of the full amount of tax owed on the prescribed day:
- 6 (1) if the return is filed not later than the 30th day
- 7 <u>after the prescribed date, five percent;</u>
- 8 (2) if the return is filed later than the 30th day
- 9 after the prescribed date, but not later than the 60th day after the
- 10 prescribed date, 10 percent;
- 11 (3) if the return is filed later than the 60th day
- 12 after the prescribed date, but not later than the 90th day after the
- 13 prescribed date, 15 percent;
- 14 (4) if the return is filed later than the 90th day
- 15 after the prescribed date, but not later than the 120th day after
- 16 the prescribed date, 20 percent; or
- 17 (5) if the return is filed later than the 120th day
- 18 after the prescribed date, 25 percent.
- 19 (b) The prescribed date is determined with regard to an
- 20 extension of time for filing.
- 21 (c) In determining the amount owed on the prescribed date,
- 22 the taxpayer is entitled to credit for a portion of the tax paid on
- 23 or before the prescribed date and other credit that may be claimed
- 24 on the return.
- 25 (d) The penalty required by this section does not apply if
- 26 the taxpayer shows that the failure to file a return was not the
- 27 result of wilful neglect before the prescribed date or at any time

- 1 during the delinquency and that good cause for the failure existed
- 2 at all times before filing.
- 3 Sec. 261.602. FAILURE TO PAY TAX. (a) A person who does not
- 4 pay any amount of tax owed by the person on the prescribed date
- 5 shall pay, in addition to all other penalties and interest, a
- 6 penalty of 10 percent of the amount of the tax due and owing on the
- 7 prescribed date.
- 8 (b) The prescribed date is determined with regard to
- 9 extensions of time allowed by the comptroller.
- 10 (c) A failure to pay all or part of an estimated tax is
- 11 considered to be an underpayment of estimated tax. The comptroller
- 12 by rule shall prescribe the method of determining the amount and
- 13 period of underpayment.
- 14 Sec. 261.603. PENALTIES AND INTEREST TREATED AS TAX. The
- 15 penalties and interest provided by this subchapter shall be paid on
- 16 <u>notice</u> and demand and shall be assessed, collected, and paid in the
- 17 same manner as other taxes. The comptroller may issue a deficiency
- 18 notice for all or part of a penalty or interest along with or
- 19 separate from the amount of tax owed in absence of penalties or
- 20 interest.

- 22 <u>SUBCHAPTER I. CREDITS AND REFUNDS</u>
- Sec. 261.631. CREDITS AND REFUNDS. (a) Within the
- 24 applicable period of limitations the comptroller may credit an
- 25 overpayment of income tax and interest on the overpayment against a
- 26 liability of a tax imposed by the tax laws of this state on the
- 27 person who made the overpayment, and the comptroller shall refund

- 1 the balance out of the proceeds of the tax retained by the
- 2 comptroller.
- 3 (b) The comptroller may prescribe rules providing for
- 4 crediting against the estimated tax for a tax year the amount
- 5 determined to be an overpayment of the income tax for a preceding
- 6 tax year.
- 7 (c) If an amount of income tax is assessed and collected
- 8 after the expiration of the period of limitations properly
- 9 applicable, the amount is an overpayment.
- Sec. 261.632. ABATEMENTS. (a) The comptroller may abate
- 11 any unpaid portion of a tax or a tax liability that is excessive in
- 12 amount, assessed after the expiration of the applicable period of
- 13 limitations, or erroneously or illegally assessed.
- 14 (b) The comptroller may abate the unpaid portion of a tax or

- 20 (c) If a claim for credit or refund relates to an 21 overpayment attributable to a net operating loss carryback, the 22 claim may be made, under rules adopted by the comptroller, not later 23 than the 15th day of the 40th month following the end of the tax year 24 of the net operating loss that resulted in the carryback or the 25 period prescribed by Section 111.104, whichever expires later.

Sec. 261.651. TAXPAYER NOT RESIDENT. If notice and demand 2 3 for the payment of a tax is given to a nonresident and it appears to the comptroller that it is not practicable to locate property of the 4 5 taxpayer sufficient in amount to cover the amount of tax due, the comptroller may authorize the institution of any available action 6 7 or proceeding to collect or enforce the claim in any place by any 8 procedure by which a civil judgment of a court of record of this state could be collected or enforced. The comptroller may 9 10 designate agents or retain counsel outside this state for the purpose of collecting taxes due under this chapter and require of 11 12 them bonds or other security for the faithful performance of their duties. The comptroller may enter into agreements with the tax 13 department of another state for the collection of taxes from 14 persons found in this state who are delinquent in the payment of 15 income taxes imposed by that state on condition that the agreeing 16 17 state afford similar assistance in the collection of taxes from persons found in that state who are delinquent in the payment of 18 19 taxes imposed by this chapter. 20 Sec. 261.652. INCOME TAX CLAIMS OF OTHER STATES. The courts of this state shall recognize and enforce liabilities for personal 21 22 income taxes lawfully imposed by another state that extends a like comity to this state, and the authorized officer of the other state 23 24 may sue for the collection of personal income tax in the courts of this state. A certificate by the secretary of state of the other 25 26 state that an officer suing for the collection of the tax is

authorized to collect the tax is conclusive proof of the officer's
