6	SECTION 1. The heading to Subchapter A, Chapter 103, Civil
7	Practice and Remedies Code, is amended to read as follows:

19	(3) "Wrongfully imprisoned person" has the meaning

23	(b) The department shall provide to each wrongfully
24	imprisoned person information, both orally and in writing, that

No. 417 1 includes: 2 (1) guidance on how to obtain compensation under this 3 chapter; and 4 (2) a list of and contact information for nonprofit advocacy groups, identified by the department, that assist 5 wrongfully imprisoned persons in filing claims for compensation 6 under this chapter. 7 8 (c) The department must provide the information required under Subsection (b): 9 (1) at the time of the release of the wrongfully 10 11 imprisoned person from a penal institution; or (2) if the wrongfully imprisoned person is not 12 confined in a penal institution, as soon as is practicable after the 13 14 date of the full pardon or granting of relief on the basis of 15 innocence or actual innocence, respectively. SECTION 3. Section 501.091, Government Code, as added by 16 17 Chapter 180 (H.B. 1736), Acts of the 81st Legislature, Regular Session, 2009, is amended by adding Subsection (d-1) to read as 18 follows: 19 (d-1) The department shall provide information to 20 wrongfully imprisoned persons as required by Section 103.002, Civil 21 Practice and Remedies Code. 22 SECTION 4. Chapter 103, Civil Practice and Remedies Code, 23 24 is amended by adding Subchapter C to read as follows: 25 SUBCHAPTER C. ATTORNEY'S FEES 26 Sec. 103.101. ATTORNEY'S FEES LIMITED; PREREQUISITES TO FEE AGREEMENT. (a) An attorney may not charge or collect a fee at a rate 27

No. 417 1 that exceeds the maximum rate established under Section 103.102 for 2 preparing, filing, or bringing a claimant's application or mandamus 3 action under this chapter. 4 (b) An attorney may enter into a fee agreement with a 5 claimant for services related to an application or mandamus action under this chapter only after the attorney has disclosed in writing 6 7 to the claimant the maximum rates for fees established under 8 Section 103.102. 9 (c) An attorney may not charge or collect a fee for 10 preparing, filing, or bringing a claimant's application or mandamus action under this chapter before a final determination is made by 11 12 the comptroller or the court, as applicable, that the claimant is eligible or ineligible for compensation under this chapter. 13 Sec. 103.102. MAXIMUM HOURLY RATES. (a) The comptroller by 14 15 rule shall establish a maximum hourly rate for an attorney's services related to: 16 17 (1) preparing or filing an application under this 18 chapter; and 19 (2) bringing a mandamus action under this chapter. (b) In setting the rates under Subsection (a), the 20 comptroller shall consider: 21 22 (1) rates charged for similar attorney's services; and 23 (2) compensation incentives necessary because of the 24 delayed nature of payment of attorney's fees as required by Section 25 103.101(c). 26 Sec. 103.103. SUBMISSION OF FEE REPORT. (a) Together with an application for compensation under this chapter or not later 27

than the 14th day after the date the application is filed, an 1 attorney seeking payment for preparing or filing the application 2 must file a fee report with the comptroller's judiciary section. 3 4 (b) An attorney seeking payment for bringing a mandamus action under this chapter must file a fee report with the 5 comptroller's judiciary section not later than the 14th day after 6 7 the date a final court order is issued. 8 (c) A fee report under this section must include: 9 (1) a sworn copy of the attorney's fee agreement, 10 signed by the attorney and claimant; (2) the total dollar amount sought for attorney's 11 12 fees; 13 (3) the number of hours the attorney worked preparing, 14 filing, or arguing the application or mandamus action; and 15 (4) a brief description of work done during those 16 hours. Sec. 103.104. VIOLATION. An attorney who charges or 17 collects a fee for services described by Section 103.102 in an 18 19 amount that exceeds a fee computed in accordance with the maximum rate established under that section violates Rule 1.04(a), Texas 20 Disciplinary Rules of Professional Conduct. 21 SECTION 5. Before January 1, 2012, the comptroller shall 22

25 SECTION 6. Subchapter C, Chapter 103, Civil Practice and 26 Remedies Code, as added by this Act, applies only to an attorney's 27 fee agreement entered into on or after January 1, 2012. An

1 attorney's fee agreement entered into before January 1, 2012, is 2 governed by the law as it existed immediately before the effective 3 date of this Act, and that law is continued in effect for that 4 purpose.
