A BILL TO BE ENTITLED

1 AN ACT

- 2 relating to a subsidy under an adoption assistance agreement for
- 3 certain adoptive parents of children in foster care.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 162.304, Family Code, is amended by
- 6 adding Subsection (a-1) and amending Subsections (b), (c), and (h)
- 7 to read as follows:
- 8 (a-1) The department shall subsidize under an adoption
- 9 assistance agreement the adoption of a child in foster care by an
- 10 adoptive parent whose family income is less than 300 percent of the
- 11 federal poverty level if, based on factors specified in rules of the
- 12 department, the department determines the child would otherwise
- 13 have been expected to remain in foster care until the child's 18th
- 14 birthday and this state would have made foster care payments for
- 15 that care. The amount of the subsidy to be paid is equal to the
- 16 amount that would have been paid to the child's foster parent based
- 17 on the child's foster care service level on the date the department
- 18 and the adoptive parent enter into the adoption assistance
- 19 <u>agreement.</u>
- 20 (b) The adoption of a child to which Subsection (a-1) does
- 21 not apply may be subsidized by the department. The need for and
- 22 amount of the subsidy available under this subsection shall be
- 23 determined by the department under its rules.
- 24 (c) In addition to a [the] subsidy under Subsection (a-1) or

- 1 (b), the department may subsidize the cost of medical care for a
- 2 child. The department shall determine the amount of and need for
- 3 the subsidy.
- 4 (h) In determining the amount that would have been paid to a
- 5 foster parent for purposes of Subsection (a-1) or (g), the
- 6 department:
- 7 (1) shall use the minimum amount required to be paid to
- 8 a foster parent for a child assigned the same service level as the
- 9 child who is the subject of the adoption assistance agreement; and
- 10 (2) may not include any amount that a child-placing
- 11 agency is entitled to retain under the foster care rate structure in
- 12 effect on the date the department and the adoptive parent enter into
- 13 the agreement.
- 14 SECTION 2. The changes in law made by this Act to Section
- 15 162.304, Family Code, apply only to an adoption assistance
- 16 agreement that is entered into on or after the effective date of
- 17 this Act. An adoption assistance agreement that was entered into
- 18 before the effective date of this Act is governed by the law in
- 19 effect on the date the agreement was entered into, and the former
- 20 law is continued in effect for that purpose.
- 21 SECTION 3. This Act takes effect September 1, 2011.
