## A BILL TO BE ENTITLED

1	AN ACT
2	relating to the creation of the Rowlett Downtown Management
3	District; providing authority to impose a tax, levy an assessment,
4	and issue bonds.
5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Subtitle C, Title 4, Special District Local Laws
7	Code, is amended by adding Chapter 3894 to read as follows:
8	CHAPTER 3894. ROWLETT DOWNTOWN MANAGEMENT DISTRICT
9	SUBCHAPTER A. GENERAL PROVISIONS
10	Sec. 3894.001. DEFINITIONS. In this chapter:
11	(1) "Board" means the district's board of directors.
12	(2) "City" means the City of Rowlett, Texas.
13	(3) "Director" means a member of the board.
14	(4) "District" means the Rowlett Downtown Management
15	District.
16	(5) "Improvement project" means any program or project
17	authorized by Section 3894.102, inside or outside the district.
18	Sec. 3894.002. CREATION AND NATURE OF DISTRICT. The
19	district is a special district created under Sections 52 and 52-a,
20	Article III, and Section 59, Article XVI, Texas Constitution.
21	Sec. 3894.003. PURPOSE; DECLARATION OF INTENT. (a) The
22	creation of the district is essential to accomplish the purposes of
23	Sections 52 and 52-a, Article III, and Section 59, Article XVI,
24	Texas Constitution, and other public purposes stated in this

- 1 chapter. By creating the district and in authorizing the city and
- 2 other political subdivisions to contract with the district, the
- 3 legislature has established a program to accomplish the public
- 4 purposes set out in Section 52-a, Article III, Texas Constitution.
- 5 (b) The creation of the district is necessary to promote,
- 6 develop, encourage, and maintain employment, commerce,
- 7 transportation, housing, tourism, recreation, the arts,
- 8 entertainment, economic development, safety, and the public
- 9 welfare in the district.
- 10 (c) This chapter and the creation of the district may not be
- 11 interpreted to relieve the city or Dallas County from providing the
- 12 level of services provided to the area in the district as of the
- 13 effective date of the Act enacting this chapter. The district is
- 14 created to supplement and not to supplant the city and county
- 15 services provided in the district.
- Sec. 3894.004. FINDINGS OF BENEFIT AND PUBLIC PURPOSE. (a)
- 17 The district is created to serve a public use and benefit.
- (b) All land and other property included in the district
- 19 will benefit from the improvements and services to be provided by
- 20 the district under powers conferred by Sections 52 and 52-a,
- 21 Article III, and Section 59, Article XVI, Texas Constitution, and
- 22 other powers granted under this chapter.
- 23 <u>(c) The creation of the district is in the public interest</u>
- 24 and is essential to further the public purposes of:
- 25 (1) developing and diversifying the economy of the
- 26 state;
- 27 (2) eliminating unemployment and underemployment; and

- 1 (3) developing or expanding transportation and
- 2 commerce.
- 3 (d) The district will:
- 4 (1) promote the health, safety, and general welfare of
- 5 residents, employers, employees, potential employees, visitors,
- 6 and consumers in the district, and of the public;
- 7 (2) provide needed funding for the district to
- 8 preserve, maintain, and enhance the economic health and vitality of
- 9 the district territory as a community and business center; and
- 10 (3) promote the health, safety, welfare, and enjoyment
- of the public by providing pedestrian ways and by landscaping and
- 12 developing certain areas in the district, which are necessary for
- 13 the restoration, preservation, and enhancement of scenic and
- 14 aesthetic beauty.
- (e) Pedestrian ways along or across a street, whether at
- 16 grade or above or below the surface, and street lighting, street
- 17 landscaping, parking, and street art objects are parts of and
- 18 necessary components of a street and are considered to be an
- 19 improvement project that includes a street or road improvement.
- 20 (f) The district will not act as the agent or
- 21 instrumentality of any private interest even though the district
- 22 will benefit many private interests as well as the public.
- Sec. 3894.005. DISTRICT TERRITORY. (a) The district is
- 24 composed of the territory described by Section 2 of the Act creating
- 25 this chapter, as that territory may have been modified under
- 26 Section 3894.108 or other law.
- 27 (b) The boundaries and field notes of the district contained

- 1 in Section 2 of the Act creating this chapter form a closure. A
- 2 mistake in the field notes of the district contained in Section 2 of
- 3 the Act creating this chapter or in copying the field notes in the
- 4 legislative process does not in any way affect the district's:
- 5 (1) organization, existence, or validity;
- 6 (2) right to contract, including the right to issue
- 7 any type of bond or other obligation for a purpose for which the
- 8 district is created;
- 9 (3) right to impose or collect an assessment, tax, or
- 10 any other revenue; or
- 11 (4) legality or operation.
- 12 Sec. 3894.006. ELIGIBILITY FOR REINVESTMENT OR ENTERPRISE
- 13 ZONES. (a) All or any part of the area of the district is eligible,
- 14 regardless of other statutory criteria, to be included in:
- 15 (1) a tax increment reinvestment zone created by the
- 16 city under Chapter 311, Tax Code; or
- 17 (2) a tax abatement reinvestment zone created by the
- 18 city under Chapter 312, Tax Code.
- 19 (b) All or any part of the area of the district is eligible
- 20 to be nominated for inclusion in an enterprise zone by the city
- 21 under Chapter 2303, Government Code.
- Sec. 3894.007. APPLICABILITY OF MUNICIPAL MANAGEMENT
- 23 DISTRICTS LAW. Except as otherwise provided by this chapter,
- 24 Chapter 375, Local Government Code, applies to the district.
- 25 Sec. 3894.008. LIBERAL CONSTRUCTION OF CHAPTER. This
- 26 chapter shall be liberally construed in conformity with the
- 27 <u>findings and purposes stated in this chapter.</u>

2	SUBCHAPTER B. BOARD OF DIRECTORS
3	Sec. 3894.051. BOARD OF DIRECTORS. The district is
4	governed by a board of five directors appointed under Section
5	3894.052 and three directors serving ex officio under Section
6	<u>3894.053.</u>
7	Sec. 3894.052. APPOINTMENT OF DIRECTORS; TERMS. (a) The
8	mayor and governing body of the city shall appoint voting
9	directors. A person is appointed if a majority of the members of
10	the governing body, including the mayor, vote to appoint that
11	person. A member of the governing body of the city may not be
12	appointed to the board.
13	(b) Section 375.063, Local Government Code, does not apply
14	to the district.
15	(c) The appointed directors serve staggered terms of four
16	years, with two or three directors' terms expiring June 1 of each
17	odd-numbered year.
18	(d) A person may not be appointed to the board if the
19	appointment of that person would result in fewer than three of the
20	directors residing in the city.
21	(e) The governing body of the city shall appoint a director
22	to fill a vacancy that occurs on the board.
23	(f) District directors are public officials entitled to

- 3 (b) If an office described by Subsection (a) is renamed,
- 4 changed, or abolished, the governing body of the city may appoint
- 5 <u>another city officer or employee who performs duties comparable to</u>
- 6 those performed by the officer described by Subsection (a).
- 7 Sec. 3894.054. CONFLICTS OF INTEREST. (a) Except as
- 8 provided by Section 3894.053 or this section:
- 9 (1) a director may participate in all board votes and
- 10 decisions; and
- 11 (2) Chapter 171, Local Government Code, governs
- 12 conflicts of interest of board members.
- 13 (b) A director who has a beneficial interest in a business
- 14 entity that will receive a pecuniary benefit from an action of the
- 15 board may participate in discussion and vote on that action if a
- 16 majority of the board has a similar interest in the same action or
- 17 <u>if all other similar business entities in the district will receive</u>
- 18 a similar pecuniary benefit.
- 19 (c) A director who is also an officer or employee of a public
- 20 entity may not participate in a discussion of or vote on a matter
- 21 regarding a contract with that same public entity.
- 22 Sec. 3894.055. DIRECTOR'S OATH OR AFFIRMATION. A
- 23 director's oath or affirmation of office shall be filed with the
- 24 district and the district shall retain the oath or affirmation in
- 25 the district records.
- Sec. 3894.056. OFFICERS. The board shall elect from among
- 27 the directors a chair, vice chair, and secretary.

1	Sec. 3894.057. COMPENSATION OF DIRECTORS; REIMBURSEMENT OF
2	EXPENSES. A director is not entitled to compensation for service on
3	the board but is entitled to be reimbursed for necessary expenses
4	incurred in carrying out the duties and responsibilities of a
5	director.
6	Sec. 3894.058. INITIAL DIRECTORS. (a) The initial board
7	consists of the following directors:
8	<u>(1)</u> ;
9	(2);
10	(3);
11	(4); and
12	(5)
13	(b) Of the initial directors, the terms of directors
14	appointed for positions 1 and 2 expire June 1, 2013, and the terms
15	of directors appointed for positions 3 through 5 expire June 1,
16	<u>2015.</u>
17	(c) This section expires September 1, 2015.
18	Sec. 3894.059. QUORUM. For purposes of determining whether
19	a quorum of the board is present, the following are not counted:
20	(1) a board position vacant for any reason, including
21	death, resignation, or disqualification;
22	(2) a director who is abstaining from participation in
23	a vote because of a conflict of interest; or
24	(3) a nonvoting director.

26	SUBCHAPTER C. POWERS AND DUTIES
27	Sec. 3894.101. GENERAL POWERS AND DUTIES. The district has

1 the powers and duties provided by: 2 (1) the general laws relating to conservation and 3 reclamation districts created under Section 59, Article XVI, Texas Constitution, including Chapters 49 and 54, Water Code; 4 5 (2) the general laws relating to road districts and road utility districts created under Section 52(b), Article III, 6 7 Texas Constitution, including Chapter 441, Transportation Code; 8 (3) Subchapter A, Chapter 372, Local Government Code, in the same manner as a municipality or a county; 9 10 (4) Chapter 375, Local Government Code; and (5) Chapter 505, Local Government Code, as if the 11 12 district were a municipality to which that chapter applies. Sec. 3894.102. IMPROVEMENT PROJECTS. (a) The district may 13 provide, or it may enter into contracts with a governmental or 14 private entity to provide, the following types of improvement 15 projects or activities in support of or incidental to those 16 projects: 17 (1) a supply and distribution facility or system to 18 19 provide potable and city-approved nonpotable water to the residents and businesses of the district, including a wastewater collection 20 facility; 21 22 (2) a paved road or street, inside and outside the district, to the extent authorized by Section 52, Article III, 23 24 Texas Constitution; (3) the planning, design, construction, improvement, 25 and maintenance of: 26

(A) landscaping;

1	(B) highway right-of-way or transit corridor
2	beautification and improvement;
3	(C) lighting, banners, and signs;
4	(D) a street or sidewalk;
5	(E) a hiking and cycling path or trail;
6	(F) a pedestrian walkway, skywalk, crosswalk, or
7	tunnel;
8	(G) a park, lake, garden, recreational facility,
9	sports facility, open space, scenic area, or related exhibit or
10	preserve;
11	(H) a fountain, plaza, or pedestrian mall; or
12	(I) a drainage or storm-water detention
13	<pre>improvement;</pre>
14	(4) protection and improvement of the quality of storm
15	water that flows through the district;
16	(5) the planning, design, construction, improvement,
17	<pre>maintenance, and operation of:</pre>
18	(A) a water or sewer facility;
19	(B) an off-street parking facility or heliport;
20	<u>or</u>
21	(C) alternative power generation facilities,
22	including solar, geothermal, and wind;
23	(6) the planning and acquisition of:
24	(A) public art and sculpture and related exhibits
25	and facilities; or
26	(B) an educational and cultural exhibit or
27	facility;

1	(7) the planning, design, construction, acquisition,
2	lease, rental, improvement, maintenance, installation, and
3	management of and provision of furnishings for a facility for:
4	(A) a conference, convention, or exhibition;
5	(B) a manufacturer, consumer, or trade show;
6	(C) a civic, community, or institutional event;
7	<u>or</u>
8	(D) an exhibit, display, attraction, special
9	event, or seasonal or cultural celebration or holiday;
10	(8) the removal, razing, demolition, or clearing of
11	land or improvements in connection with an improvement project;
12	(9) the acquisition and improvement of land or other
13	property for the mitigation of the environmental effects of an
14	<pre>improvement project;</pre>
15	(10) the acquisition of property or an interest in
16	property in connection with an authorized improvement project;
17	(11) a special or supplemental service for the
18	improvement and promotion of the district or an area adjacent to the
19	district or for the protection of public health and safety in or
20	adjacent to the district, including:
21	(A) advertising;
22	(B) promotion;
23	(C) tourism;
24	(D) health and sanitation;
25	(E) public safety;
26	(F) security;
27	(G) fire protection or emergency medical

1	services;
2	(H) business recruitment;
3	(I) development;
4	(J) elimination of traffic congestion; and
5	(K) recreational, educational, or cultural
6	improvements, enhancements, and services; or
7	(12) any similar public improvement, facility, or
8	service.
9	(b) The district may not undertake an improvement project
10	under this section unless the board determines the project to be
11	necessary to accomplish a public purpose of the district.
12	(c) An improvement project must comply with any applicable
13	city requirements, including codes and ordinances.
14	(d) The district may not provide, conduct, or authorize any
15	improvement project on the city streets, highways, rights-of-way,
16	or easements without the consent of the governing body of the city.
17	(e) The district shall immediately comply with any city
18	ordinance, order, or resolution that:
19	(1) requires the district to transfer to the city the
20	title to all or any portion of an improvement project; or
21	(2) authorizes the district to own, encumber,
22	maintain, and operate an improvement project, subject to the right
23	of the city to order a conveyance of the project to the city on a
24	date determined by the city.
25	(f) For the purposes of this section, planning, design,
26	construction, improvement, and maintenance of a lake include work
27	done for drainage, reclamation, or recreation.

- 1 Sec. 3894.103. GENERAL POWERS REGARDING CONTRACTS. (a)
- 2 The district may:
- 3 (1) contract with any person to accomplish any
- 4 <u>district purpose</u>, including a contract for:
- 5 (A) the payment, repayment, or reimbursement of
- 6 costs incurred by that person on behalf of the district, including
- 7 all or part of the costs of an improvement project and interest on
- 8 the reimbursed cost; or
- 9 <u>(B) the use, occupancy, lease, rental,</u>
- 10 operation, maintenance, or management of all or part of a proposed
- 11 or existing improvement project; and
- 12 (2) apply for and contract with any person to receive,
- 13 administer, and perform a duty or obligation of the district under a
- 14 federal, state, local, or private gift, grant, loan, conveyance,
- 15 transfer, bequest, or other financial assistance arrangement
- 16 relating to the investigation, planning, analysis, study, design,
- 17 acquisition, construction, improvement, completion,
- 18 implementation, or operation by the district or others of a
- 19 proposed or existing improvement project.
- 20 (b) A contract the district enters into to carry out a
- 21 purpose of this chapter may be on any terms and for any period the
- 22 board determines, including a negotiable or nonnegotiable note or
- 23 warrant payable to the city, Dallas County, and any other person.
- 24 (c) Any person may contract with the district to carry out
- 25 the purposes of this chapter without further statutory or other
- 26 authorization.
- 27 (d) A contract payable from ad valorem taxes for a period

- 1 longer than one year must be approved by the governing body of the
- 2 city.
- 3 Sec. 3894.104. COMPETITIVE BIDDING. Section 375.221, Local
- 4 Government Code, applies only to a district contract that has a
- 5 value of more than \$50,000.
- 6 Sec. 3894.105. ECONOMIC DEVELOPMENT. The district may
- 7 create economic development programs and exercise the economic
- 8 development powers that:
- 9 (1) Chapter 380, Local Government Code, provides to a
- 10 municipality with a population of more than 100,000; and
- 11 (2) Chapter 1509, Government Code, provides to a
- 12 municipality.
- Sec. 3894.106. RULES; ENFORCEMENT. (a) The district may
- 14 adopt rules:
- 15 (1) to administer or operate the district;
- 16 (2) for the use, enjoyment, availability, protection,
- 17 security, and maintenance of the district's property and
- 18 facilities; or
- 19 (3) to provide for public safety and security in the
- 20 district.
- 21 (b) The district may enforce its rules by injunctive relief.
- 22 <u>(c) To the extent a district rule conflicts with a city</u>

- Sec. 3894.107. NAME CHANGE. The board by resolution may
- 26 change the district's name. The board shall give written notice of

The board may 2 add or remove territory under Subchapter J, Chapter 49, and Section 3 54.016, Water Code, except that: 4 (1) the addition or removal of the territory must be 5 approved by: 6 (A) the governing body of the city; and 7 (B) the owners of the territory being added or 8 removed; 9 (2) a reference to a tax in Subchapter J, Chapter 49, 10 or Section 54.016, Water Code, means an ad valorem tax; and 11 (3) territory may not be removed from the district if 12 bonds or other obligations of the district payable wholly or partly from ad valorem taxes on the territory are outstanding. 13 14 Sec. 3894.109. The board may employ and establish the terms of 17 employment and compensation of: 18 19 (1) an executive director or general manager; or (2) any other district employee the board considers 20 21 necessary. BORROWING MONEY. The district may borrow 10 money for a district purpose by issuing or executing bonds, notes, 11 12 credit agreements, or other obligations of any kind found by the board to be necessary or appropriate for the district purpose. The 13 14 bond, note, credit agreement, or other obligation must be secured 15 by and payable from ad valorem taxes, assessments, or other 16 district revenue. 17 Sec. 3894.153. IMPACT FEES AND ASSESSMENTS; EXEMPTION. (a) The district may impose an impact fee or assessment on property in 18 19 the district, including an impact fee or assessment on residential or commercial property, only in the manner provided by Subchapter 20 A, Chapter 372, or Subchapter F, Chapter 375, Local Government 21 22 Code, for a municipality, county, or public improvement district, according to the benefit received by the property. 23 24 (b) An impact fee for residential property must be for the limited purpose of providing capital funding for: 25 26 (1) public water and wastewater facilities;

(2) drainage and storm-water facilities; and

- 1 (3) streets and alleys.
- 2 (c) An assessment, a reassessment, or an assessment
- 3 resulting from an addition to or correction of the assessment roll
- 4 by the district, penalties and interest on an assessment or
- 5 reassessment, or an expense of collection of an assessment,
- 6 including reasonable attorney's fees, incurred by the district:
- 7 (1) is a first and prior lien against the property
- 8 assessed; and
- 9 (2) is superior to any other lien or claim other than a
- 10 lien or claim for county, school district, or municipal ad valorem
- 11 taxes.
- 12 (d) The board may make a correction to or deletion from the
- 13 assessment roll that does not increase the amount of assessment of
- 14 any parcel of land without providing notice and holding a hearing in
- 15 the manner required for additional assessments.
- (e) The district may not impose an impact fee on the
- 17 property, including equipment and facilities, of a public utility
- 18 provider in the district.
- 19 Sec. 3894.154. CERTAIN RESIDENTIAL PROPERTY NOT EXEMPT.
- 20 Section 375.161, Local Government Code, does not apply to the
- 21 <u>district.</u>
- Sec. 3894.155. MAINTENANCE AND OPERATION TAX; ELECTION.
- 23 (a) Except as provided by Section 3894.161, the district may impose
- 24 a tax for maintenance and operation purposes, including for:
- 25 (1) planning, constructing, acquiring, maintaining,
- 26 repairing, and operating all improvement projects, including land,
- 27 plants, works, facilities, improvements, appliances, and equipment

- 1 of the district; and
- 2 (2) paying costs of services, engineering and legal
- 3 fees, and organization and administrative expenses.
- 4 (b) The district may not impose a maintenance and operation
- 5 tax unless the maximum tax rate is approved by the governing body of
- 6 the city and a majority of the district voters voting at an election
- 7 held for that purpose. If the maximum tax rate is approved, the
- 8 board may impose the tax at any rate that does not exceed the
- 9 approved rate.
- 10 (c) A maintenance and operation tax election may be held at
- 11 the same time and in conjunction with any other district election.
- 12 The election may be called by a separate election order or as part
- 13 of any other election order.
- 14 (d) The proposition in a maintenance and operation tax
- 15 election may be for a specific maximum rate.
- Sec. 3894.156. USE OF SURPLUS MAINTENANCE AND OPERATION
- 17 MONEY. If the district has surplus maintenance and operation tax
- 18 money that is not needed for the purposes for which it was
- 19 collected, the money may be used for any authorized purpose.
- 20 <u>Sec. 3894.157.</u> <u>BOND ISSUANCE PLAN REQUIRED BEFORE</u> ISSUING
- 21 BONDS. The district may not issue bonds until the governing body of
- 22 the city approves a bond issuance plan authorizing and setting
- 23 forth the limitations on the issuance of the bonds.
- Sec. 3894.158. BONDS AND OTHER OBLIGATIONS; MUNICIPAL
- 25 APPROVAL. (a) Except as provided by Sections 3894.157 and
- 26 3894.161, the district may issue, by competitive bid or negotiated
- 27 sale, bonds, notes, or other obligations payable wholly or partly

- 1 from ad valorem taxes or assessments in the manner provided by
- 2 Subchapter A, Chapter 372, or Subchapter J, Chapter 375, Local
- 3 Government Code.
- 4 (b) In exercising the district's borrowing power, the
- 5 district may issue a bond or other obligation in the form of a bond,
- 6 note, certificate of participation or other instrument evidencing a
- 7 proportionate interest in payments to be made by the district, or
- 8 other type of obligation.
- 9 (c) In addition to the sources of money described by
- 10 Subchapter A, Chapter 372, and Subchapter J, Chapter 375, Local
- 11 Government Code, district bonds may be secured and made payable
- 12 wholly or partly by a pledge of any part of the net proceeds the
- 13 district receives from any other district revenue.
- Sec. 3894.159. BOND MATURITY. Bonds may mature not more
- 15 than 40 years from their date of issue.
- Sec. 3894.160. TAXES FOR BONDS AND OTHER OBLIGATIONS. (a)
