10	unit for which a permit under Section 623.011 has been issued; or
11	[ <del>(2)</del> ] \$15 for a registration year [ <del>, for a semitrailer</del>
12	being propelled by a power unit for which a permit under Section
13	623.011 has not been issued].
14	SECTION 2. Section 623.011(b), Transportation Code, is
15	amended to read as follows:
16	(b) To qualify for a permit under this section:
17	(1) the vehicle must be registered under Chapter 502
18	for the maximum gross weight applicable to the vehicle under
19	Section 621.101, not to exceed 80,000 pounds;
20	(2) the security requirement of Section 623.012 must
21	be satisfied; and
22	(3) a base permit fee of <u>\$90</u> [ <del>\$75</del> ], any additional fee
23	required by Section 623.0111, and any additional fee set by the
24	department under Section 623.0112 must be paid.

H.B. No. 441 SECTION 3. Section 621.353(a), Transportation Code, is amended to read as follows:

The comptroller shall send \$50 of each base 3 (a) fee collected under Section 623.011 for an excess weight permit to the 4 counties of the state, with each county receiving an amount 5 determined according to the ratio of the total number of miles of 6 county roads maintained by the county to the total number of miles 7 8 of county roads maintained by all of the counties of this state. The comptroller shall deposit \$40 [\$25] of each base fee, plus each 9 fee collected under Section 623.0112, to the credit of the state 10 highway fund. Money deposited to the credit of that fund under this 11 subsection may be appropriated only to the department to administer 12 this section and Sections 623.011, 623.0111, and 623.0112. 13

14 SECTION 4. (a) The changes in law made by this Act apply 15 only to fees charged for a vehicle registration or permit issued on 16 or after the effective date of this Act.

(b) A vehicle registration or permit issued before the effective date of this Act is covered by the law in effect when the registration or permit was issued, and the former law is continued in effect for that purpose.
