(2) "Pilot program" means the Serve Your Way to 15 16 College pilot program established under this section. (3) "Qualifying community service activity" includes 17 work performed by a student for a participating organization, other 18 19 than: 20 (A) fund-raising activities; 21 (B) political activities; 22 (C) any activity for which the student may earn 23 course credit; or 24 (D) any activity that reduces the work of or

2	(b) The board by rule shall develop and implement the Serve
3	Your Way to College pilot program, under which students enrolled in
4	grades 7-12 at public schools in participating school districts in
5	this state may accrue prepaid tuition units under this subchapter

8	education, shall select to participate in the pilot program one

(h) Each participating student: 13 (1) is responsible for securing the student's 14 15 placement with a participating organization; and 16 (2) may accrue prepaid tuition units under this 17 section for qualifying community service activities performed by the student for one or more participating organizations, except 18 19 that the student: (A) must perform at least 50 hours of qualifying 20 community service activities before any tuition unit may be 21 22 purchased on behalf of the student under this section; and (B) may not accrue tuition units under this 23 24 section for qualifying community service activities performed by the student for one or more participating organizations in excess 25 26 of 250 hours per year. 27 (i) Notwithstanding any other provision of this subchapter,

25 SECTION 2. The Prepaid Higher Education Tuition Board shall 26 adopt rules to implement the Serve Your Way to College pilot program 27 as required by Section 54.7522, Education Code, as added by this

1 Act, beginning with the 2012-2013 school year.

2 SECTION 3. This Act takes effect immediately if it receives 3 a vote of two-thirds of all the members elected to each house, as 4 provided by Section 39, Article III, Texas Constitution. If this 5 Act does not receive the vote necessary for immediate effect, this 6 Act takes effect September 1, 2011.
