- 12 (2) under Section 504.315(a) or (g) [504.315(g)]; or

- SECTION 2. Section 504.315, Transportation Code, is amended
- 15 by adding Subsection (a) to read as follows:
- 16 (a) The department shall issue specialty license plates for

- 6 collected through a parking meter charged by a governmental
