- 4 SECTION 1. Section 372.053(a), Transportation Code, is
- 5 amended to read as follows:
- 6 (a) A toll project entity may establish a discount program
- 7 for electronic toll collection customers. The program must
- 8 include free or discounted use of the entity's toll project by an
- 9 electronic toll collection customer whose account relates to a
- 10 vehicle registered:

- SECTION 2. Section 504.3015(b), Transportation Code, is

- SECTION 3. Section 504.315, Transportation Code, is amended

- 4 SECTION 4. Section 681.008(b), Transportation Code, as
- 5 amended by Chapters 115 (H.B. 2020) and 319 (H.B. 618), Acts of the
- 6 81st Legislature, Regular Session, 2009, is reenacted and amended
- 7 to read as follows:
- 8 (b) A vehicle on which license plates described by
- 9 Subsection (a)(2) or issued under Section 504.202, Section
- 10 504.315(a), (c) [504.315(c)], (d), (e), (f), or (g), or Section
- 11 504.316 are displayed is exempt from the payment of a parking fee
- 12 collected through a parking meter charged by a governmental
- 13 authority other than a branch of the federal government, when being
- 14 operated by or for the transportation of:
- 15 (1) the person who registered the vehicle under
- 16 Section 504.202(a), Section 504.315(a), (c) [504.315(c)], (d),
- 17 (e), (f), or (g), or Section 504.316;
- 18 (2) a person described in Section 504.202(b) if the
- 19 vehicle is registered under that subsection; or
- 20 (3) the owner or operator of a vehicle displaying
