No. 2154, Acts of the 81st Legislature, Regular Session, 2009, 2 amends Section 155.0211, Tax Code, in a manner that results in an increase in the revenue from the tax under that section during the 4 state fiscal biennium beginning September 1, 2009, that is 5 6 attributable to that change, and that Act is enacted and becomes law. If H.B. No. 2154, Acts of the 81st Legislature, Regular 7 Session, 2009, does not amend Section 155.0211, Tax Code, in that 9 manner or is not enacted or does not become law, this section takes effect January 1, 2010]. 10 SECTION 4. This Act takes effect immediately if it receives 11 a vote of two-thirds of all the members elected to each house, as 12 provided by Section 39, Article III, Texas Constitution. If this 13

Act does not receive the vote necessary for immediate effect, this

Act takes effect September 1, 2011.
