SECTION 2. Article 48.05(b), Code of Criminal Procedure, is 21 22 amended to read as follows: (b) An individual may not apply for restoration of civil 23 24 rights under this article unless:

No. 728 (1) the individual has completed the sentence for the 1 offense; 2 3 (2) the conviction occurred: 4 (A) three or more years before the date of application, if the offense is a federal or state offense; or 5 6 (B) two or more years before the date of 7 application, if the offense is an offense under the laws of another 8 country; and (3) the individual has not been convicted at any other 9 time of an offense under the laws of this state, another state, or 10 the United States. 11 SECTION 3. This Act applies to a defendant who is convicted 12 of an offense before, on, or after the effective date of this Act. 13 SECTION 4. This Act takes effect September 1, 2011. 14
