1-6 A BILL TO BE ENTITLED  
1-7 AN ACT

1-8 relating to the creation of the Harris County Municipal Utility  
1-9 District No. 528; providing authority to impose a tax and issue  
1-10 bonds; granting a limited power of eminent domain.

1-11 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-12 SECTION 1. Subtitle F, Title 6, Special District Local Laws  
1-13 Code, is amended by adding Chapter 8318 to read as follows:

1-14 CHAPTER 8318. HARRIS COUNTY MUNICIPAL UTILITY DISTRICT NO. 528

1-15 SUBCHAPTER A. GENERAL PROVISIONS

1-16 Sec. 8318.001. DEFINITIONS. In this chapter:

1-17 (1) "Board" means the district's board of directors.

1-18 (2) "Commission" means the Texas Commission on  
1-19 Environmental Quality.

1-20 (3) "Director" means a board member.

1-21 (4) "District" means the Harris County Municipal  
1-22 Utility District No. 528.

1-23 Sec. 8318.002. NATURE OF DISTRICT. The district is a  
1-24 municipal utility district created under Section 59, Article XVI,  
1-25 Texas Constitution.

1-26 Sec. 8318.003. CONFIRMATION AND DIRECTORS' ELECTION  
1-27 REQUIRED. The temporary directors shall hold an election to  
1-28 confirm the creation of the district and to elect five permanent  
1-29 directors as provided by Section 49.102, Water Code.

1-30 Sec. 8318.004. CONSENT OF MUNICIPALITY REQUIRED. The  
1-31 temporary directors may not hold an election under Section 8318.003  
1-32 until each municipality in whose corporate limits or  
1-33 extraterritorial jurisdiction the district is located has  
1-34 consented by ordinance or resolution to the creation of the  
1-35 district and to the inclusion of land in the district.

1-36 Sec. 8318.005. FINDINGS OF PUBLIC PURPOSE AND BENEFIT.

1-37 (a) The district is created to serve a public purpose and benefit.

1-38 (b) The district is created to accomplish the purposes of:

1-39 (1) a municipal utility district as provided by  
1-40 general law and Section 59, Article XVI, Texas Constitution; and

1-41 (2) Section 52, Article III, Texas Constitution, that  
1-42 relate to the construction, acquisition, improvement, operation,  
1-43 or maintenance of macadamized, graveled, or paved roads, or  
1-44 improvements, including storm drainage, in aid of those roads.

1-45 Sec. 8318.006. INITIAL DISTRICT TERRITORY. (a) The  
1-46 district is initially composed of the territory described by  
1-47 Section 2 of the Act enacting this chapter.

1-48 (b) The boundaries and field notes contained in Section 2 of  
1-49 the Act enacting this chapter form a closure. A mistake made in the  
1-50 field notes or in copying the field notes in the legislative process  
1-51 does not affect the district's:

1-52 (1) organization, existence, or validity;

1-53 (2) right to issue any type of bond for the purposes  
1-54 for which the district is created or to pay the principal of and  
1-55 interest on a bond;

1-56 (3) right to impose a tax; or

1-57 (4) legality or operation.

1-58 [Sections 8318.007-8318.050 reserved for expansion]

1-59 SUBCHAPTER B. BOARD OF DIRECTORS

1-60 Sec. 8318.051. GOVERNING BODY; TERMS. (a) The district is  
1-61 governed by a board of five elected directors.

1-62 (b) Except as provided by Section 8318.052, directors serve  
1-63 staggered four-year terms.

1-64 Sec. 8318.052. TEMPORARY DIRECTORS. (a) On or after

2-1 September 1, 2011, the owner or owners of a majority of the assessed  
 2-2 value of the real property in the district may submit a petition to  
 2-3 the commission requesting that the commission appoint as temporary  
 2-4 directors the five persons named in the petition. The commission  
 2-5 shall appoint as temporary directors the five persons named in the  
 2-6 petition.

2-7 (b) Temporary directors serve until the earlier of:  
 2-8 (1) the date permanent directors are elected under  
 2-9 Section 8318.003; or  
 2-10 (2) September 1, 2015.

2-11 (c) If permanent directors have not been elected under  
 2-12 Section 8318.003 and the terms of the temporary directors have  
 2-13 expired, successor temporary directors shall be appointed or  
 2-14 reappointed as provided by Subsection (d) to serve terms that  
 2-15 expire on the earlier of:

2-16 (1) the date permanent directors are elected under  
 2-17 Section 8318.003; or  
 2-18 (2) the fourth anniversary of the date of the  
 2-19 appointment or reappointment.

2-20 (d) If Subsection (c) applies, the owner or owners of a  
 2-21 majority of the assessed value of the real property in the district  
 2-22 may submit a petition to the commission requesting that the  
 2-23 commission appoint as successor temporary directors the five  
 2-24 persons named in the petition. The commission shall appoint as  
 2-25 successor temporary directors the five persons named in the  
 2-26 petition.

2-27 [Sections 8318.053-8318.100 reserved for expansion]

2-28 SUBCHAPTER C. POWERS AND DUTIES

2-29 Sec. 8318.101. GENERAL POWERS AND DUTIES. The district has  
 2-30 the powers and duties necessary to accomplish the purposes for  
 2-31 which the district is created.

2-32 Sec. 8318.102. MUNICIPAL UTILITY DISTRICT POWERS AND  
 2-33 DUTIES. The district has the powers and duties provided by the  
 2-34 general law of this state, including Chapters 49 and 54, Water Code,  
 2-35 applicable to municipal utility districts created under Section 59,  
 2-36 Article XVI, Texas Constitution.

2-37 Sec. 8318.103. AUTHORITY FOR ROAD PROJECTS. Under Section  
 2-38 52, Article III, Texas Constitution, the district may design,  
 2-39 acquire, construct, finance, issue bonds for, improve, operate,  
 2-40 maintain, and convey to this state, a county, or a municipality for  
 2-41 operation and maintenance macadamized, graveled, or paved roads, or  
 2-42 improvements, including storm drainage, in aid of those roads.

2-43 Sec. 8318.104. ROAD STANDARDS AND REQUIREMENTS. (a) A  
 2-44 road project must meet all applicable construction standards,  
 2-45 zoning and subdivision requirements, and regulations of each  
 2-46 municipality in whose corporate limits or extraterritorial  
 2-47 jurisdiction the road project is located.

2-48 (b) If a road project is not located in the corporate limits  
 2-49 or extraterritorial jurisdiction of a municipality, the road  
 2-50 project must meet all applicable construction standards,  
 2-51 subdivision requirements, and regulations of each county in which  
 2-52 the road project is located.

2-53 (c) If the state will maintain and operate the road, the  
 2-54 Texas Transportation Commission must approve the plans and  
 2-55 specifications of the road project.

2-56 Sec. 8318.105. COMPLIANCE WITH MUNICIPAL CONSENT ORDINANCE  
 2-57 OR RESOLUTION. The district shall comply with all applicable  
 2-58 requirements of any ordinance or resolution adopted by the city  
 2-59 council of the City of Baytown.

2-60 Sec. 8318.106. LIMITATION ON USE OF EMINENT DOMAIN. The  
 2-61 district may not exercise the power of eminent domain outside the  
 2-62 district to acquire a site or easement for:

2-63 (1) a road project authorized by Section 8318.103; or  
 2-64 (2) a recreational facility as defined by Section  
 2-65 49.462, Water Code.

2-66 [Sections 8318.107-8318.150 reserved for expansion]

2-67 SUBCHAPTER D. GENERAL FINANCIAL PROVISIONS

2-68 Sec. 8318.151. ELECTIONS REGARDING TAXES OR BONDS.  
 2-69 (a) The district may issue, without an election, bonds and other

3-1 obligations secured by:

3-2 (1) revenue other than ad valorem taxes; or

3-3 (2) contract payments described by Section 8318.153.

3-4 (b) The district must hold an election in the manner  
 3-5 provided by Chapters 49 and 54, Water Code, to obtain voter approval  
 3-6 before the district may impose an ad valorem tax or issue bonds  
 3-7 payable from ad valorem taxes.

3-8 (c) The district may not issue bonds payable from ad valorem  
 3-9 taxes to finance a road project unless the issuance is approved by a  
 3-10 vote of a two-thirds majority of the district voters voting at an  
 3-11 election held for that purpose.

3-12 Sec. 8318.152. OPERATION AND MAINTENANCE TAX. (a) If  
 3-13 authorized at an election held under Section 8318.151, the district  
 3-14 may impose an operation and maintenance tax on taxable property in  
 3-15 the district in accordance with Section 49.107, Water Code.

3-16 (b) The board shall determine the tax rate. The rate may not  
 3-17 exceed the rate approved at the election.

3-18 Sec. 8318.153. CONTRACT TAXES. (a) In accordance with  
 3-19 Section 49.108, Water Code, the district may impose a tax other than  
 3-20 an operation and maintenance tax and use the revenue derived from  
 3-21 the tax to make payments under a contract after the provisions of  
 3-22 the contract have been approved by a majority of the district voters  
 3-23 voting at an election held for that purpose.

3-24 (b) A contract approved by the district voters may contain a  
 3-25 provision stating that the contract may be modified or amended by  
 3-26 the board without further voter approval.

3-27 [Sections 8318.154-8318.200 reserved for expansion]

3-28 SUBCHAPTER E. BONDS AND OTHER OBLIGATIONS

3-29 Sec. 8318.201. AUTHORITY TO ISSUE BONDS AND OTHER  
 3-30 OBLIGATIONS. The district may issue bonds or other obligations  
 3-31 payable wholly or partly from ad valorem taxes, impact fees,  
 3-32 revenue, contract payments, grants, or other district money, or any  
 3-33 combination of those sources, to pay for any authorized district  
 3-34 purpose.

3-35 Sec. 8318.202. TAXES FOR BONDS. At the time the district  
 3-36 issues bonds payable wholly or partly from ad valorem taxes, the  
 3-37 board shall provide for the annual imposition of a continuing  
 3-38 direct ad valorem tax, without limit as to rate or amount, while all  
 3-39 or part of the bonds are outstanding as required and in the manner  
 3-40 provided by Sections 54.601 and 54.602, Water Code.

3-41 Sec. 8318.203. BONDS FOR ROAD PROJECTS. At the time of  
 3-42 issuance, the total principal amount of bonds or other obligations  
 3-43 issued or incurred to finance road projects and payable from ad  
 3-44 valorem taxes may not exceed one-fourth of the assessed value of the  
 3-45 real property in the district.

3-46 SECTION 2. The Harris County Municipal Utility District No.  
 3-47 528 initially includes all the territory contained in the following  
 3-48 area:

3-49 TRACT 1

3-50 FIELD NOTES of a 27.8347 acre tract of land situated in the William  
 3-51 Scott Lower league, Abstract No. 65, Harris County, Texas, and  
 3-52 being out of and a part of a 1541 acre tract of land conveyed to  
 3-53 Ashbel Smith Land Company by B. W. Armstrong, et al, by Deed dated  
 3-54 November 29, 1935, and recorded in Volume 996 at Page 379 of the  
 3-55 Deed Records of Harris County, Texas. This 27.8347 acre tract of

4-20 line of Tri-Cities Beach Road (80 feet wide right-of-way) for the  
4-21 Southeast corner of said 33.00 acres and the Northeast corner of

4-23 THENCE: South 08°04'39" East along the Northernmost East line of  
4-24 this tract and the West right-of-way line of said Tri-Cities Beach

6-42 BEGINNING POINT of a curve to the right, concave Northeast.  
6-43 THENCE: Along and around said curve, in a Northwesterly direction,  
6-44 with the Easternmost South line of this tract of land and the  
6-45 Northeast right-of-way line of Evergreen Road, said curve having a  
6-46 central angle of 15°59'48", a radius of 789.20 feet, and a chord  
6-47 bearing and distance of North 50°50'40" West 219.63 feet, for an arc  
6-48 length of 220.34 feet to a 1/2 inch iron rod for the TERMINATION  
6-49 POINT of said curve.  
6-50 THENCE: North 42°52'16" West along the Easternmost South line of  
6-51 this tract of land and the Northeast right-of-way line of Evergreen  
6-52 Road for a distance of 685.33 feet to a 1/2 inch iron rod for the  
6-53 BEGINNING POINT of a curve to the left, concave Southwest.  
6-54 THENCE: Along and around said curve to the left, in a Northerly  
6-55 direction, with the Easternmost South line of this tract of land and  
6-56 the Northeast right-of-way line of Evergreen Road, said curve  
6-57 having a central angle of 03°08'33", a radius of 6814.28 feet, and a  
6-58 chord bearing and distance of North 44°27'42" West 373.68 feet, for  
6-59 an arc length of 373.73 feet, to a 1/2 inch iron rod for the  
6-60 TERMINATION POINT of said curve.  
6-61 THENCE: North 46°00'58" West along the Easternmost South line of  
6-62 this tract of land and the Northeast right-of-way line of Evergreen  
6-63 Road for a distance of 531.26 feet to a 1/2 inch iron rod, with cap,  
6-64 for the Southernmost Southwest corner of this tract of land and the  
6-65 Southeast corner of an 80 acre tract of land conveyed to Bill W.  
6-66 Nance by Alvie Wright Nance, by Deed dated October 22, 1996, and  
6-67 recorded under County Clerk's File No. S210455 of the Official  
6-68 Public Records of Real Property of Harris County, Texas.  
6-69 THENCE: North 50°36'12" East along the Southernmost West line of

7-1 this tract of land and the East line of said 80 acre tract of land,  
7-2 and at 2.37 feet pass a 4 inch pipe fence corner post, continuing  
7-3 along said line and a barb wire fence a total distance of 536.04  
7-4 feet to a 2 inch iron pipe for an interior corner of this tract of  
7-5 land and an angle corner of said 80 acre tract of land.

7-6 THENCE: North 54°45'13" West along the Westernmost South line of  
7-7 this tract and an exterior line of said 80 acre tract, and along a  
7-8 barb wire fence, for a distance of 293.16 feet to a 1/2 inch iron  
7-9 rod, with cap, for the Westernmost Southwest corner of this tract.

7-10 THENCE: In a Northerly direction along the Northernmost West line  
7-11 of this tract of land and the East line of said 80 acre tract of  
7-12 land, and a barb wire fence line the following courses and  
7-13 distances:

7-14 North 16°15'01" East for a distance of 1171.99 feet to a 2 inch  
7-15 iron pipe;

7-16 North 43°11'17" East for a distance of 341.17 feet to a 2 inch  
7-17 iron pipe;

7-18 North 18°00'45" East for a distance of 481.29 feet to a 1/2  
7-19 inch iron rod, with cap;

7-20 North 15°59'25" East for a distance of 927.59 feet to the  
7-21 PLACE OF BEGINNING and containing within these boundaries 180.9042  
7-22 acres of land.

7-23 SECTION 3. (a) The legal notice of the intention to  
7-24 introduce this Act, setting forth the general substance of this  
7-25 Act, has been published as provided by law, and the notice and a  
7-26 copy of this Act have been furnished to all persons, agencies,  
7-27 officials, or entities to which they are required to be furnished  
7-28 under Section 59, Article XVI, Texas Constitution, and Chapter 313,  
7-29 Government Code.

7-30 (b) The governor, one of the required recipients, has  
7-31 submitted the notice and Act to the Texas Commission on  
7-32 Environmental Quality.

7-33 (c) The Texas Commission on Environmental Quality has filed  
7-34 its recommendations relating to this Act with the governor, the  
7-35 lieutenant governor, and the speaker of the house of  
7-36 representatives within the required time.

7-37 (d) All requirements of the constitution and laws of this  
7-38 state and the rules and procedures of the legislature with respect  
7-39 to the notice, introduction, and passage of this Act are fulfilled  
7-40 and accomplished.

7-41 SECTION 4. (a) Section 8318.106, Special District Local  
7-42 Laws Code, as added by Section 1 of this Act, takes effect only if  
7-43 this Act receives a two-thirds vote of all the members elected to  
7-44 each house.

7-45 (b) If this Act does not receive a two-thirds vote of all the  
7-46 members elected to each house, Subchapter C, Chapter 8318, Special  
7-47 District Local Laws Code, as added by Section 1 of this Act, is  
7-48 amended by adding Section 8318.106 to read as follows:

7-49 Sec. 8318.106. NO EMINENT DOMAIN POWER. The district may  
7-50 not exercise the power of eminent domain.

7-51 (c) This section is not intended to be an expression of a  
7-52 legislative interpretation of the requirements of Section 17(c),  
7-53 Article I, Texas Constitution.

7-54 SECTION 5. Except as provided by Section 4 of this Act, this  
7-55 Act takes effect September 1, 2011.
