- 7 (2) "Historically underutilized business" means an
- 8 entity with its principal place of business in this state that is:
- 9 (A) a corporation formed for the purpose of
- 10 making a profit in which 51 percent or more of all classes of the
- 11 shares of stock or other equitable securities are owned by one or
- 12 more persons who:
- (i) are either:
- 14 (a) economically disadvantaged
- 15 persons; or
- (b) veterans as defined by 38 U.S.C.
- 17 Section 101(2) who have a service-connected disability as defined
- 18 by 38 U.S.C. Section 101(16); and
- 19 (ii) [who] have a proportionate interest and
- 20 actively participate in the corporation's control, operation, and
- 21 management;
- 22 (B) a sole proprietorship created for the purpose
- 23 of making a profit that is completely owned, operated, and
- 24 controlled by an economically disadvantaged person or a veteran as

- 1 defined by 38 U.S.C. Section 101(2) who has a service-connected
- 2 disability as defined by 38 U.S.C. Section 101(16);
- 3 (C) a partnership formed for the purpose of
- 4 making a profit in which 51 percent or more of the assets and
- 5 interest in the partnership are owned by one or more persons who:
- 6 <u>(i)</u> are either:
- 7 <u>(a)</u> economically disadvantaged
- 8 persons; or
- 9 (b) veterans as defined by 38 U.S.C.
- 10 Section 101(2) who have a service-connected disability as defined
- 11 by 38 U.S.C. Section 101(16); and
- 12 (ii) [who] have a proportionate interest
- 13 and actively participate in the partnership's control, operation,
- 14 and management;
- 15 (D) a joint venture in which each entity in the
- 16 venture is a historically underutilized business, as determined
- 17 under another paragraph of this subdivision; or
- 18 (E) a supplier contract between a historically
- 19 underutilized business as determined under another paragraph of
- 20 this subdivision and a prime contractor under which the
- 21 historically underutilized business is directly involved in the
- 22 manufacture or distribution of the goods or otherwise warehouses
- 23 and ships the goods.
- SECTION 2. This Act takes effect September 1, 2011.
