2	relating to the registration and compulsory inspection of certain
3	street rods and custom vehicles.
4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Subchapter B, Chapter 501, Transportation Code,
6	is amended by adding Section 501.038 to read as follows:
7	Sec. 501.038. CERTIFICATE OF TITLE FOR CUSTOM VEHICLE OR
8	STREET ROD. (a) In this section, "custom vehicle" and "street rod"
9	have the meanings assigned by Section 504.502.
10	(b) Notwithstanding any other provision of this chapter, if
11	the department issues a certificate of title for a custom vehicle or
12	street rod, the model year of the vehicle must be listed on the
13	certificate of title and must be the model year that the body of the
14	vehicle resembles. The certificate of title must also include the
15	word "replica."
16	(c) The owner of the custom vehicle or street rod shall
17	provide the department with documentation identifying the model
18	year that the body of the vehicle resembles.
19	SECTION 2. Section 504.502, Transportation Code, is amended
20	by amending Subsections (a), (b), and (i) and adding Subsections
21	(f-1) and (f-2) to read as follows:
22	(a) The department shall issue specialty license plates for
23	a passenger car, truck, motorcycle, or former military vehicle

No. 890  $[\frac{\text{is at least 25 years old}}{\text{if the vehicle is a}}]$  if the vehicle is a 1 (1)passenger car, truck, or motorcycle: 2 3 (A) is at least 25 years old; or 4 (B) is a custom vehicle or street rod; 5 (2) is a collector's item; 6 is used exclusively for exhibitions, club (3) 7 activities, parades, and other functions of public interest and is 8 not used for regular transportation; and (4) does not carry advertising. 9 (b) The license plates must include the words "Antique 10 Auto," "Antique Truck," "Antique Motorcycle," <u>"Street Rod,"</u> 11 "Custom Vehicle," or "Military Vehicle," as appropriate. 12 (f-1) Notwithstanding Chapter 547, a custom vehicle or 13 14 street rod eligible to receive license plates under this section is 15 not required to be equipped with a specific piece of equipment unless the specific piece of equipment was required by statute as a 16 17 condition of sale during the year listed as the model year on the certificate of title. 18 19 (f-2) On initial registration of a custom vehicle or street rod, the owner must provide proof, acceptable to the department, 20 that the custom vehicle or street rod passed a safety inspection 21 that has been approved by the department. The department shall 22 create a safety inspection process for inspecting custom vehicles 23 24 and street rods. In this section: 25 (i) (1) "Custom vehicle" means a vehicle: 26 (A) that is: 27

10	(2) "Former[ <del>, "former</del> ] military vehicle" means a
11	vehicle, including a trailer, regardless of the vehicle's size,

13	(A) [ <del>(1)</del> ] was manufactured for use in any
14	country's military forces; and
15	(B) [ <del>(2)</del> ] is maintained to represent its
16	military design and markings accurately.
17	(3) "Street rod" means a vehicle:
18	(A) that was manufactured:
19	(i) before 1949; or
20	(ii) after 1948 to resemble a vehicle
21	manufactured before 1949; and
22	(B) that:
23	(i) has been altered from the
24	<pre>manufacturer's original design; or</pre>
25	(ii) has a body constructed from materials
26	not original to the vehicle.
27	SECTION 3. Section 548.052, Transportation Code, is amended

Sec. 548.052. VEHICLES NOT SUBJECT TO INSPECTION. Thischapter does not apply to:

4 (1) a trailer, semitrailer, pole trailer, or mobile
5 home moving under or bearing a current factory-delivery license
6 plate or current in-transit license plate;

7 (2) a vehicle moving under or bearing a paper dealer 8 in-transit tag, machinery license, disaster license, parade 9 license, prorate tab, one-trip permit, antique license, <u>custom</u> 10 <u>vehicle license, street rod license,</u> temporary 24-hour permit, or 11 permit license;

12 (3) a trailer, semitrailer, pole trailer, or mobile 13 home having an actual gross weight or registered gross weight of 14 4,500 pounds or less;

15 (4) farm machinery, road-building equipment, a farm 16 trailer, or a vehicle required to display a slow-moving-vehicle 17 emblem under Section 547.703;

18 (5) a former military vehicle, as defined by Section 19 504.502(i) [502.275];

20 (6) a vehicle qualified for a tax exemption under21 Section 152.092, Tax Code; or

(7) a vehicle for which a certificate of title has beenissued but that is not required to be registered.

SECTION 4. Section 504.502, Transportation Code, as amended by this Act, applies only to a registration period beginning on or after the effective date of this Act.

27 SECTION 5. This Act takes effect September 1, 2011.
